## **SERVICE OFFICER**

The FEMA Funeral Reimbursement Program is reimbursing up to \$7,000.00 for COVID-19 funerals **WHO IS ELIGIBLE?** – To be eligible for funeral assistance, you must meet these conditions:

• The death must have occurred in the United States, including the U.S. territories and the District of Columbia.

- The death certificate must indicate the death was attributed to COVID-19.
- The applicant must be a U.S. citizen, non-citizen national, or a qualified alien who incurred funeral expenses after January 20, 2020.
- There is no requirement for the deceased person to have been a U.S. citizen, non-citizen national, or qualified alien.

**HOW TO APPLY** - In April, FEMA will begin accepting applications. If you had COVID-19 funeral expenses, we encourage you to keep and gather documentation. Types of information should include:

- An official death certificate that attributes the death directly or indirectly to COVID-19 shows that the death occurred in the United States, including the U.S. territories and the District of Columbia.
- Funeral expenses documents (receipts, funeral home contract, etc.) include the applicant's name, the deceased person's name, the amount of funeral expenses, and the dates the funeral expenses happened.
- Proof of funds received from other sources specifically for use toward funeral costs. We cannot duplicate benefits received from burial or funeral insurance, financial assistance received from voluntary agencies, government agencies, or other sources.

# **LEGISLATIVE NEWS**

NATIONAL LEGISLATION – On March 11, President Biden signed into law a \$1.9 trillion coronavirus relief package finally approved by House Democrats on March 10, following party-line Senate passage. The House voted 220-211 on final passage, with one Democrat, Rep. Jared Golden (D-Maine) joining all Republicans in opposition to the bill. Although Republicans and Democrats were divided along party lines, both parties agreed that this round of COVID-19 relief is one of the most progressive packages ever written into law. (HuffPost)

The bill includes \$1,400 stimulus checks for most Americans, extends \$300 weekly unemployment benefits into September, establishes about \$10,000 in tax forgiveness for the jobless, increases the child tax credit to roughly \$3,000, includes \$350 billion in state and local government aid, another \$128 billion in funding for schools, \$46 billion for contact tracing and testing, \$25 billion for rental assistance, \$25 billion to help struggling bars and restaurants, and billions more for vaccines, pandemic supplies and other public health measures. **(CNBC)** 

The bill includes \$39 billion for child care providers, \$40 billion for higher education and boosts subsidies for customers who buy insurance through the Affordable Care Act. The bill also includes a provision that could make it easier for President Biden to eliminate student debt by not requiring beneficiaries to pay taxes on canceled loans. Biden said he might cancel up to \$10,000 in student debt using executive action. (NBC NEWS)

The final package looks remarkably similar to what Biden proposed in January before he was even inaugurated. Despite razor-thin majorities in both the House and Senate, Democrats got on board with the president's proposal. There were, however, some changes made to appease moderate Senate Democrats who were concerned benefits would go to some higher income families. The stimulus payments are cut off entirely for individuals who make more than \$80,000 (or \$160,000 for joint filers), though the full payments will go to all individuals making up to \$75,000 a year (or up to \$150,000 for joint filers), as Biden initially proposed. Democrats also kept federal unemployment insurance aid at its current \$300 per week level, instead of expanding it to a \$400 weekly benefit as Biden had initially called for. (HuffPost)

The Internal Revenue Service has extended the 2020 federal income tax due date to May 17, 2021. (My Federal Retirement)

<u>VIRGINIA LEGISLATION</u> – The Democrat-controlled General Assembly passed more than 500 bills during a sixweek session ending February 27, including historic votes to make Virginia the first Southern State to abolish the death penalty and make marijuana legal to possess and buy on January 1, 2024. Governor Ralph Northam has so far signed more than 100 of them into law, including bills shifting any municipal elections previously held in May to November, allowing restaurants to sell alcoholic drinks for takeout and delivery until July 1, 2022, allowing people on Medicaid to get up to a 12-month prescription of birth control, requiring carmakers to sell a certain percentage of electric or hybrid cars, allowing localities to hold early voting on Sundays and the bill abolishing the death penalty. The General Assembly adopted a \$141 billion two-year budget that would restore and surpass raises that teachers, state employees and public employees lost during the health emergency, giving 5% raises to teachers,

State employees and state supported local employees, plus additional money to police, correctional officers, social workers and local registrars.

The General Assembly will reconvene April 7 for its "veto session," when lawmakers will take up the governor's suggested changes or vetoes to legislation. Gov. Northam is expected to make changes to legislation setting up the regulatory framework for marijuana sales. (Richmond Times-Dispatch)
