President's Comments:

 - Gaston Gianni felt that in response to the national emergency, we should postpone the annual meeting and revisit the topic later on
 - Donna Shackelford agrees with Gaston
 - Luther Santiful asked to set a date to revisit the annual meeting discussion
 - Ted Pasek suggested a tentative date in July
 - Bill Martin indicated that we need to have an electronic meeting before
 June 30th as that is the end of our Fiscal Year and term for current officers.
 Additionally, bylaws changes need to be considered. We also need to plan
 for a 2021 budget
 - Bill was given permission to work with Jim Little and Alex Adkins on budget and financial for the VFN.
 - Connie stated that we can hold the election no matter what else happens.
 - Wynn Hasty recommended that we pick dates for late summer or early fall and set it up with the hotel. He also suggested extending the terms of the existing officers until we have an annual meeting.
 - Luther asked if Connie is open to an electronic meeting in April. We need to follow One Member, One Vote (OMOV). Everyone can use GoTo Meeting.
 - Linda Smallwood indicated that we need a motion to with the annual meeting.
- o Bill Martin made a motion to do a 1-day electronic meeting in April 2nd by Karen
- o Linda had us restate the motion to be more specific.
 - Bill Martin clarified his motion to have an electronic meeting in April to handle some of the business. 2nd by Luther Santiful

 - 2nd vote taken was 13 No and 6 Yes

- Discussion:
 - Donna Shackelford suggested waiting to discuss this and call the meeting whenever we are know ore about the national emergency.

 - Also, July 1, whoever is the winning candidate for federation office take over.
