- Repeal of "Cadillac" Tax on Health Plans
- Fighting threats in 2020 Budget
- Fighting the Schedule F Executive Order
- Extending the Rehired Federal Retirees Waiver Auth.



NARFE POLITICAL ACTION FUND PAC 2019–2020

- Purpose: Help build strong congressional relationships
- How Funded? NARFE Member voluntary contributions (Non Tax Deductable)
- ▶ Total Collected 2019–2020 for 116th Congress (End of Cycle)
 - \$2,173,897
 - 31,966 Members participated
 - 749 Sustainers (have monthly contributions)
- Congressional Campaign Committees must request NARFE PAC
- Total Paid Out: \$1,436,000
