REPORT ON SEPTEMBER 14th CHAPTER MEETING - Kay Dellinger

President Kathy Arpa called the meeting to order at 1:35 pm. This is the first formal chapter meeting since May although there was a chapter picnic held in June. Kathy welcomed new member Darnell Wilson. Marc Owens led the Pledge of Allegiance. There was one guest. Members who celebrated birthdays in June, July, August, and September were recognized. Harriet Epstein spoke in recognition of the 20th anniversary of 9/11 and asked us to reflect in a moment of silence.

Ralph Dantinne introduced our guest speaker and chapter member, William (Bill) Inch, (pictured here) who retired in 2020 from the position of Deputy Director, Customs and Border Protection, Cargo Systems Program Directorate, Department of Homeland Security (DHS). Bill began by giving an overview of the Department of Homeland Security, the third largest department with approximately 240,000 federal employees. DHS includes large agencies such as Customs and Border Patrol (CBP), the Transportation Security Administration (TSA), and the Coast Guard. Other smaller but very well-known agencies within DHS are U.S. Immigration and Customs Enforcement (ICE), Federal Emergency Management Agency (FEMA) and the Secret Service, to name a few. He then spoke about the four units within the Customs and Border Patrol. These are the Customs Officers at Ports of Entry, the U.S. Border Patrol, Air and Marine Operations, and Trade. Trade focuses on importing and exporting. Our speaker fielded several questions from the attendees before concluding his presentation. Bill Inch is a chapter member!

Mark Arpa and Kay Dellinger are this year's Nominating Committee for our upcoming chapter election of officers.

Officer and committee reports were presented.

MEMBERSHIP REPORT – JAYNE SEIDMAN

As of October 1, there are 183 chapter members and 162 National members for a total of 345 NARFE members in the area. One member passed away. Three members were dropped for non-renewal, and we have five new prospective members. Letters were mailed to nine prospective members on September 27th.

TREASURER'S REPORT – DAVID GRAF

Since the last newsletter, the Chapter received \$215.20 for membership dues collected by National for the month of August. A \$2.00 refund was received from the Oakton Post Office when the rental of the Post Office Box was discontinued, and the keys were turned in on August 26th. There have not been any expenses.

LEGISLATION REPORT- CHRIS GIESELER

State Legislation

Special Session II of 2021 of the General Assembly is still in recess. We will monitor for any reconvening. Meanwhile, various committee hearings and meetings are scheduled for the rest of 2021.

The Virginia Federation's Legislation Chair is in the process of distributing the 2022 VFN Legislative Plan in trifold form to various members of the Federation. Members who attend the VFN Conference will receive copies for the chapter. Moreover, further communications from the Chair are expected later in October regarding future actions to implement that Plan.

National Legislation

Congress "reconvened" in late September to consider some important legislation of interest to the Federal workforce and retirees. Notably, on September 30, 2021, Congress passed a "continuing resolution" that authorizes spending for the federal government through December 3, 2021. The bill does not suspend the federal debt, so separately legislation will need to be enacted by October 18, 2021, so that the Federal Government does not default on its debts. (Even now, as of August 2, 2021, the Treasury Department has suspended investments into the Civil Service and Postal Service retirement funds and reinvestment into the "G Fund"; these will be reimbursed once the debt ceiling issue is resolved.) There is much debate on whether or how to suspend or raise the debt limit. The \$3.5 trillion human infrastructure bill is a major sticking point in the process. Meanwhile, the bipartisan infrastructure bill (which covers traditional infrastructure such as roads and communications), passed by the Senate, is waiting for House action.

Bill Tracker information in the October 2021 NARFE Magazine is up to date, based on information on October 1 data on <u>congress.gov</u> Also, on September 30, 2021, the House passed a bill, HR 3533, requiring OPM to establish one or more occupation series regarding software development and/or engineering, data science and data management. The bill now goes to the Senate.

On the regulatory front, the Cost-of-Living Adjustments (COLAs) for federal retirees are expected to be about 6% for 2022 for civil service retirees; 5% for FERS retirees. The COLA calculation will be made once the Consumer Price Index for September 2021 is calculated later this month. (Bills pending in Congress would change the index that is currently being used for COLAs and/or would make the COLAs for both CSRS and FERS retirees the same [thus, no more "diet COLAs" for FERS types].)

OPM reform: OPM has submitted its report to Congress regarding its response to an earlier report (that contains about 20 recommendations) from a statutorily required study of OPM's structure and operations. The study was conducted by the National Academy of Public Administration (NAPA), and its written results were provided to OPM in March 2021. The study was a middle ground that NARFE had sought as a way around President Trump's proposal to disband OPM and transfer its functions to other agencies. The report contains recommendations for both Congress and OPM. OPM agreed with many of the recommendations but disagreed with other recommendations in whole or in part, e.g., to create a strategic planning and policy office. We'll wait and see whether Congress takes further actions related to OPM. Hopefully, OPM's operations regarding federal employees and retirees will improve in any case.

Covid vaccinations and testing: Recent Executive Orders, and implementing guidance subsequently issued on September 16, 2021, require most federal employees and contractor/subcontractor employees to finish receiving their (second) Covid vaccinations by November 8, 2021, so that full vaccination occurs by November 22, 2021. Postal Employees are exempt but must take weekly Covid tests. Agencies can make additional exceptions from the vaccine mandates. Technically, Executive Orders (EOs) Nos. 14043 and 14042 require agencies to implement a program requiring employee vaccinations and to include in most contracts, clauses requiring contractor and subcontractor employees to be vaccinated. The EOs do not contain penalties for noncompliance, but the implementing guidance notes that agency programs should provide for disciplinary actions, to include termination, for employees who fail to comply. Different processes apply if an employee is seeking an exception from the vaccination requirements.

The guidance also addresses visitors to federal facilities. In general, agencies can request vaccination status from visitors, but there is more to the story. If you wish to visit an agency at its official locations, it would be advisable to contact the agency first to determine what information they want or what to do if you don't have the requisite information.
