NATIONAL LEGISLATION

Follow-up: H.R.3076 - Postal Service Reform Act of 2021

The Postal Service Reform Act of 2021 (<u>H.R. 3076</u>), is a bipartisan bill that aims to provide financial and operational stability to the Postal Service.

Key Provisions: If passed the legislation would:

- repeal the mandate that the Postal Service prefund decades' worth of health benefits for its future retirees, which was enacted through the Postal Accountability and Enhancement Act (PAEA) of 2006
- maximize participation in Medicare once active postal employees (as of January 1, 2023) retire and reach age 65. Annuitants as of January 1, 2023, will be given the choice of whether to

remain in the existing FEHBP system or participate in the postal version of the program that requires enrollment in Medicare Parts A and B – and retirees over the age of 65 who have chosen not to enroll in Medicare Part B will be given a one-time opportunity to do so with no lateenrollment penalty.

- require the Postal Service to maintain an "integrated" network of both mail and packages six days a week.
- require the Postal Service to provide semi-annual reports to Congress on the implementation of its 10-year strategic plan; provide for a public dashboard using nationwide delivery metrics to track delivery performance; directs the Postal Service to use the most efficient means to transport mail, likely moving from air to ground;
- mandate a Postal Regulatory Commission (PRC) review of competitive and non-competitive products and a study of nationwide processing efficiency of flats (magazines and catalogs)

DeJoy Announces 10-Year Reorganization of U.S. Postal Service

Postmaster General Louis DeJoy is calling for longer delivery times for some first-class mail, shorter hours for some post offices and more expensive postal rates — all part of a 10-year reorganization plan for the U.S. Postal Service he unveiled Tuesday March 23.

Kristin Seaver, the Postal Service's executive vice president, said the change in delivery times would affect only "the fringes of our network." She said 70% of first-class mail will still be delivered in two or three days under the proposal. Twenty percent of what she identified as coast-to-coast mail "might not arrive for five days."

DeJoy told lawmakers the postal system is "in a death spiral" and needs legislation to help restore it to financial stability.

On Oct. 3, the Postal Service temporarily began increasing prices on all commercial and retail domestic packages extending through the holiday season.

Other provisions:

The reorganization plan would have first-class mail ferried cross-country on trucks instead of airplanes and introduces new products to help commercial shippers move packages more efficiently.

The plan codifies slowdowns for nonlocal first-class mail, adding as many as two days to delivery timetables for items sent further than 930 miles.

CONGRESSIONAL UPDATES

CDL VA 7th Congressional District

On June 21-23 ten of the thirteen members of the NARFE Virginia Federation's legislative team attended the 2021 NARFE National Legislative Conference. The conference took place via ZOOM. After two days of preparation, on the next day we attended NARFE's virtual Advocacy Day in which Representative Abigail Spanberger of Virginia's 7th Congressional District attended with her legislative team member. Other Virginia Federation members also virtually attended. We also had an opportunity to attend meetings with other congressmen to witness their points of view.

The meeting worked out very well even though we did not meet face to face. In most cases the members of congress have previously received NARFE's Advocacy Positions for the 117th Congress (2021-2022), so they understood what we are proposing for our members – their constituents. One example of discussion was the Cost of Living (COLA's), the current Social Security cost index – CPI-W for Urban Wage Earners and Clerical Workers, suggesting a change to an index CPI-E more reflective of how seniors and the elderly experience the market. Seniors typically pay more than the general public for medical services, prescriptions and care services.

Please note the above proposal is not to be confused with the current 5.9% federal retirement and Social Security forthcoming pay increase for 2022. The 5.9% is bases for the CPI-W which is not adequate for the elderly. Other bills regarding Rep. Spanberger's sponsorship are HR 82 Social Security Fairness Act (repeal of WEP/GPO) and HR 2337 Public Servants Protection and Fairness Act, advocates an alternative formula to calculate Social Security retirement benefits for those who receive pensions for certain non-covered employment. The existing formula is known as the windfall elimination provision (WEP). To my knowledge - Rep. McEachin has not yet sponsored HR 2337. His constituents need to contact his office for verification. More sponsors are needed to qualify for a vote in the House.

Consider writing or visiting your member of congress to advise him or her of your current situation and needs for which they may be able to help. You are also encouraged to use NARFE.org / advocacy website to write your representatives and senator.
