#### TREASURER'S REPORT - DAVID GRAF

Since the last newsletter, the Chapter received \$186.22 for membership dues collected by National for the month of November. The only expense was \$125.00 for our annual donation to the Town of Vienna, Parks & Recreation for use of the Community Center meeting rooms.

"Be Prepared for Life's Events" - What Your Survivors Should Know - F-100 (09/21) I will be bringing a few "Be Prepared for Life" booklets to the meeting on January 11. The purpose of this guide is to help you organize your personal and financial information in one location so your survivors will have the information they will need to handle your affairs upon your death. While one's death is a difficult topic to discuss, reviewing this information with your family will help them understand the steps they will need to take. Any questions that come up can also be addressed ahead of time. You should ensure that your family members review this guide with you and know where it is located. Additionally, you should review this guide periodically to ensure that the information is up-to-date.

### **LEGISLATION REPORTS- CHRIS GIESELER**

## **State Legislation**

Regarding the results of Virginia's November 2021 elections, the two recounts that occurred for contested House of Delegates seats affirmed the unofficial results of the elections that had indicated that Republicans would have a 52-48 majority in the Virginia House for the 2022 General Assembly. However, due to a recent resignation by a Democratic Delegate that became effective December 31, 2021, a special election will be held on January 11, 2022, in his district, according to the current district boundaries. Thus, there will be a vacancy in the House of Delegates until the results of that special election are determined. The Virginia Senate was not up for re-election, and the Democrats hold a 21-19 majority in that body. The General Assembly's regular session begins on Wednesday, January 12, 2022.

A troubling development affecting the General Assembly was a ransomware attack on certain of its systems. Included in those hacked systems is the one which legislators use to draft their respective bills. The attack is still under investigation, and users of the Legislative Information System still get warning messages regarding technical difficulties in using that system. Governor-elect Younkin indicated he may investigate the matter deeper and may invest more to protect against the risk posed by this type of attack.

Please contact me if you would like further information on which member(s) of the General Assembly to contact. Governor Northam's budget for the Commonwealth's fiscal year beginning July 1, 2022, has been proposed. The proposal is subject to amendment by the General Assembly. Time will tell whether any of the proposals therein will affect the topics contained in the 2022 Legislative Plan.

# **National Legislation**

Congress has passed an increase in the national debt of \$2.5 trillion; see Senate Joint Resolution 33, which was approved on December 16, 2021, by the President. Also, the National Defense Authorization Act, 2022 has been enacted. NARFE noted the Act's provisions regarding (1) two weeks of paid bereavement leave for federal employees due to the death of a child and (2) a 2.7% pay increase for military service members. Meanwhile, the Build Back Better Act is still under consideration by the Senate. Moreover, appropriation acts for many federal agencies and programs still need to be passed; the current "continuing resolution" expires COB February 18, 2022. (Note: this is the correct date; my report in the December 2021 Chapter Newsletter contained the wrong date.)

The Bill Tracker Information in the January/February 2022 NARFE Magazine is accurate as of December 29, 2021, although the number of cosponsors has increased for many of the bills listed. Of note, HR 3076, the Postal Service Reform Act, had an increase of 10 cosponsors from the Bill Tracker information. NARFE opposes this bill because of its potentially adverse effect on FEHB premiums.

NARFE's continuing focus is on bills that would eliminate or modify current laws regarding the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO), which reduce the number of federal pensions for certain federal retirees. Again, please contact your U.S. congressman or senator to voice your support for NARFE's positions.

A bill that is not on the Bill Tracker that would, among other things, repeal WEP and GPO is HR 5723, Social Security 2100: A Sacred Trust. Hearings were held on this bill on December 7, 2021.

Lastly, on December 10, 2021, the House passed the Protecting Our Democracy Act, which contains a variety of provisions of interest to federal employees, including protections for whistleblowers and Hatch Act reforms. The bill also would require presidential candidates to release their income tax returns and contains protections for federal inspector generals.

Administratively, the President signed an executive order on December 22, 2021, approving federal employee pay scales, including locality pay, throughout the country. See <a href="mailto:opm.gov">opm.gov</a> for the related pay schedules. The Washington-DC-Arlington locality zone will receive a 3.02% increase for 2022.

In January 2022, the increases in Social Security benefits and the cost-of-living adjustments (COLAs) for Civil Service and FERS pensions will be 5.9%, while the FERS COLA will be 4.9%. NARFE supports legislation, HR 304, sponsored by Rep. Gerry Connolly, that would eliminate the unfair disparity between the CSRS and FERS COLAs.

Regarding federal regulations over Covid vaccinations, the U.S. Supreme Court will hear arguments on January 7, 2022, regarding regulations issued by the Occupational Safety and Health Administration and by the Centers for Medicare and Medicaid Services that require certain employers to mandate that their employees be vaccinated or tested for Covid. In general, the arguments center around whether those federal agencies had the statutory authority to issue such regulations.
