The 2020 Census resulted in new House of Representative Congressional Districts here in Virginia along with the rest of the country. We have seen this in the news and mailings received at home from current and proposed candidates for congress that will be selected in primaries and then be on the November 2022 ballot for the House of Representatives mid-term elections.

Chapter 2065 is going to be mostly in Virginia's 5<sup>th</sup> Congressional District which includes Louisa, Goochland and Fluvanna counties and the western portion of Hanover County. The current 5<sup>th</sup> district represented is Bob Good (R), Those members in Spotsylvania are now in the Seventh Congressional District which will cover the counties of Greene, Madison, Orange, Spotsylvania, Caroline, King George, Stafford and Culpeper as well as part of Albemarle and Prince William Counties.

Part of every chapter's job is to contact their elected representatives and senators representing that chapter's state and congressional district requesting they support legislation that is important/beneficial to their members and/or is promoted by NARFE. You see these requests that you contact your legislators in the National Legislative Report.

There is concern among some chapters that NARFE is slowly fading away! The number of members and chapters continues to decrease. I've written that one of the main purposes of NARFE is to advocate for our benefits both as retirees and active employees. A part of this is that senators and representatives count e-mails and letters that they receive from their constituents; this is where the Advocacy part of NARFE is important. We may loose our clout as an advocacy organization where numbers mean everything, particularly in the halls of Congress. If we do not wish to be irrelevant, we need to add members. ## NATIONAL LEGISLATION REPORT

As you probably already know, Congress passed a full year spending bill (Consolidated Appropriations Act, 2022 (<u>H.R. 2471</u>) of \$1.5 trillion. The measure includes funding boosts for nearly every agency in government, it would increase non-defense discretionary spending by 6.7%, and defense spending would jump about 6%. Relevant federal government bills:

The Comprehensive Access to Resources and Education (CARE) for Long COVID

Act legislation was introduced to help people living with long-term COVID-19 symptoms. This bill would improve research on long COVID as well as provide resources for people with long COVID.

• Specifically, the CARE for Long COVID Act would:

- Accelerate research by centralizing data regarding long COVID patient experiences;
- Increase understanding of treatment by expanding research to provide recommendations to improve the health care responses to long COVID;
- Educate long COVID patients and medical providers by working with the CDC to develop and provide the public with information on common symptoms, treatment, and other related illnesses;
- Facilitate interagency coordination to educate employers and schools on the impact of long COVID and employment, disability, and education rights for people with long COVID; and
- Develop partnerships between community-based organizations, social service providers, and legal assistance providers to help people with long COVID access needed services.
- \* Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0 was signed into law last month representing a massive economic policy shift regarding retirement savings and investment.
  - The retirement savings legislation expands the original SECURE Act and includes provisions to boost the required minimum distribution (RMD) age from 72 to 75 over time, broaden automatic enrollment in retirement plans, and enhance 403(b) plans.
  - The original SECURE Act was passed into law by former President Donald Trump in December 2019. This legislation altered the existing retirement savings plan system in terms of RMD, contributions to traditional IRAs, 529 plan uses for student loans, and making annuities easier

for 401(k) plan administrators to offer.

• SECURE Act 2.0 changes policies on catch-up limits concerning retirement plans and indexes IRA catch-up limits to inflation beginning in 2023 among other initiatives.
