### Message from our State Legislative Chair, Deborah Fisk – Update on State Legislation, dated 4 April 2022

Good Morning,

The Special Session to complete work on nearly 50 bills and the budget begins today. The House of Delegates and Senate convene at 12 pm in the Capitol.

Governor Youngkin wants to suspend the entire Virginia state tax on fuel for three months to provide some relief from rising gas prices. The governor has also stated, however, that eliminating the gas tax will not necessarily lower prices. The market controls the price. Business owners that sell fuel could just pocket the extra 26 cents per gallon instead of lowering the prices. The current struggle is over not having language in the procedural resolution that would allow legislators to consider any new bill from the governor.

There is also a long list of bills that are still up for consideration by legislators. Here is that list, if you are interested in all 40; but, please pay particular attention to HB 1128 and SB 528 (let's watch as it could help with our CSRS initiative in the future):

HB 90 Sales tax; exemption for food purchased for human consumption & essential personal hygiene products.

- HB 177 Absentee voting; witness requirement for absentee ballots.
- HB 191 Health Workforce Development; creates position of Special Advisor to the Governor.
- HB 305 Elections; appointment of Commissioner of Elections, membership of Board, effective date.
- HB 346 College partnership laboratory schools; application and establishment.
- HB 349 Foster care; housing support for persons between ages 18 and 21.
- HB 563 School Construction Fund and Program; created and established.
- HB 653 Foster care; DSS to establish and implement a collaborative local board placement program.
- HB 680 Medical assistance services; state plan, case management service, individuals w/severe brain injury.
- HB 736 Search warrants; execution.
- HB 764 Charitable gaming; registration of landlords, Texas Hold'em poker operations.
- HB 833 Group violence intervention; definition, Operation Ceasefire Grant Fund created.
- HB 935 Income tax, state; refunds for individuals or married persons filing a joint return.
- HB 993 Unlawful hazing; amends definition, civil and criminal liability, penalties.
- HB 1046 Over-the-counter medications, etc.; DMAS to study plan for a process to allow direct purchase.
- HB 1053 Correctional facilities, local; fees associated with inmates.

#### HB 1128 Income tax, state; military benefits subtraction.

- HB 1206 Fort Monroe Authority; adds to powers and duties, facilities management.
- HB 1245 Nurse practitioners; practice without a practice agreement, repeals sunset provision.
- HB 1257 Natural gas utilities; retail supply choice.

HB 1261 State environmental boards; appointment of members to various Boards.

HB 1306 Firearms; removing, altering, etc., serial number, selling, etc., or possessing.

HB 1319 Beneficial hardwood management practices; creates a nonrefundable income tax credit.

HB 1339 Facial recognition technology; redefines, local law enforcement and campus police to utilize.

HB 1353 Virginia Football Stadium Authority; established.

SB 38 Capitol Square Preservation Council; powers and duties, review and approval of plans for changes.

- SB 47 Income tax, state; housing opportunity tax credits.
- SB 273 Absentee voting; verification by social security number or unique identifier.
- SB 324 Public agencies; privacy of personal information.

SB 371 Elections, State Board of; expands membership, appointment of Commissioner of Elections.

SB 440 Unlawful hazing; civil and criminal liability.

SB 451 Retail Sales and Use tax; exemption for essential personal hygiene products.

SB 471 Literary Fund; open application process for loans, maximum loan amounts, etc.

SB 473 School Construction Fund and Program; created and established.

SB 487 Firearm Violence Intervention and Prevention, Virginia Center; established.

SB 490 Standards of Quality; specialized student support.

SB 498 Conveyances of property; acceptance by clerk's office for recordation.

#### SB 528 Income tax, state; military benefits subtraction, person 60 years of age or older, etc.

SB 579 Income tax, state; refunds for individuals or married persons filing a joint return.

SB 598 College partnership laboratory schools; application and establishment.

SB 652 Absentee voting; application requirements, last four digits of social security number.

SB 727 Virginia Football Stadium Authority; established, definitions, report.
