<u>A Few Details for Our September 7<sup>th</sup> Meeting</u> -- On September 7<sup>th</sup>, we will have a presentation by Ann Shields discussing WWII German POW camps and activities in the Washington DC area. Three local camps provide examples of the immense wartime program for confinement of 375,000 Germans in the US. Topics will include the labor program, escapes, interrogations, relationships with locals, and Nazi threats in camp. The camp histories of Ft. Meade, Ft. Hunt, and Fairfax Camp will be highlighted with photos, maps, interviews, and a display of POW items. In addition, Debby Mossburg of the Osher Lifelong Learning Institute (George Mason University) will provide a brief introduction to the Institute and its programs. Our meeting will be held both in-person and via Zoom. # Legislation Report – GPO/WEP: H.R. 82, the Social Security Fairness Act would



repeal the unfair Windfall Elimination Provision (WEP) and Government Pension Offset (GPO) penalties, and is getting very close to a House vote! Per a relatively new House rule, any bill with 290 cosponsors (which the bill now has!) can be added to the House

Consensus Calendar. Once on the calendar, it is teed up for a vote; if it maintains those 290 cosponsors or more for 25 legislative days there may be a chance at a floor vote prior to the end of the 117th Congress. Getting closer.

*Equal COLA Act, S.4221 & companion Bill H.R. 304*, would ensure that cost-ofliving adjustments (COLAs) for Federal Employees Retiree System (FERS) annuities match the measured change in consumer prices. This bill fixes a longstanding issue affecting FERS retirees whereby their earned annuities fail to keep pace with inflation due to an inequitable policy that reduces their annual cost-of-living adjustments (COLAs).

*PAY RAISE*: The House Appropriations Subcommittee on Financial Services and General Government (FSGG) released its fiscal year 2023 (FY23) appropriations bill. Since Congress remained silent on the pay raise, it is possible the decision will be left with the president, who proposed a 4.6 percent average pay increase in his FY23 budget.

*H.R. 6398, the Federal Adjustment of Income Rates (FAIR) Act* proposes a 5.1 percent pay raise. This is a standalone bill, introduced by Rep. Gerald Connolly, D-VA.

H.R.2954 - Securing a Strong Retirement Act of 2021 & Senate Enhancing American Retirement Now (EARN) Act -- these bills would increase both the current required minimum distribution (RMD) age and the catch-up contribution limit for employersponsored retirement plans, including the Thrift Savings Plan. (H.R. 2954 has passed in the House.)

*Public Service Reform Act H.R.* 8550 – this bill is strongly opposed by NARFE as it would allow all federal workers to be considered at-will employees. It would also undermine and/or eliminate a merit-based civil service. This bill is the latest attempt, in addition to Schedule F, to reinstitute the spoils system. Furthermore, H.R. 8550 is likely to contribute to a more divisive and unstable government going forward.

*National Defense Authorization Act (NDAA) 2023* -- Rep. Connolly was successful in having an amendment included in NDAA Fiscal Year 2023 which limits the ability of the executive branch to bypass the framework of the merit-based civil service. Specifically, the amendment would prohibit the (continued on page 6)

(continued from page 5) reclassification of any position in the competitive service to an excepted service schedule that was created after September 30, 2020, and limit federal employee reclassifications to the five excepted service schedules in use prior to fiscal year 2021. Broadly speaking, this amendment would prevent future attempts to implement a new excepted service category (Schedule F) with rules more akin to those covering political appointments. NARFE strongly opposed Schedule F when it was implemented by Executive Order late in 2020. The current administration rescinded Schedule F, but future administrations could simply reverse that decision. If passed into law, the Connolly amendment would prevent this situation from occurring. (NDAA 2023 has passed in the House.)

### VFN Virginia 2023 State Legislative Plan:



The Virginia Federation of NARFE (VFN) State Legislative plan, with 5 priorities, has been formalized and approved by the Federation Board. The 5 priorities are: exempting from state tax a portion of CSRS annuities equivalent to Social Security; removing the means-testing for

the current Age Deduction; allowing Virginians to opt to itemize deductions on their state Tax return when taking the Standard Deduction on the Federal return; support for a Family Caregiver tax credit of up to \$1,000; and support for Nursing Home Standards of Care and staffing. The VFN is currently working to identify legislative partners to introduce or follow through with legislation in the General Assembly. A copy of the Plan is available on our NARFE Annandale Website.
