#### ALZHEIMER'S REPORT – MARK ARPA

During FEDCON22, I learned that NARFE members have donated approximately \$600,000 towards Alzheimer's Research. The following information was shared, and awards presented as appropriate.

Mark and I attended FEDCON22 from August 21-23 at the Westin Kierland Hotel in Scottsdale, Arizona. We had the opportunity to make new friends and renew friendships with NARFE members from around the country. At the NARFE Annual Business Meeting, we heard reports from Ken Thomas, National President and Katherine Hensley, Secretary/Treasurer of NARFE. Two of the candidates for NARFE National President shared their vision for the future of NARFE. A Welcome Reception was held on Sunday evening.



During the Conference, there were concurrent sessions on Chapter Leadership and Excellence; Help Lead NARFE into the Next 100 years; Discover your Family History; Making the Most of your Meetings; How to Maximize Your Social Security Benefits; Debunking Retirement Myths, and Estate Planning. General sessions included Kevin Brown, The Hero Effect; Ken Thomas, NARFE 360, Where We've Been and Where We're Headed; John Hatton, NARFE HEADLINES, Get the Latest Updates on Legislative Action, and Olivia Williams, Alzheimer's National Committee Update. ### MEMBERSHIP REPORT - JAYNE SEIDMAN

We currently have 178 chapter members and 148 National members in our area, for a total of 326 NARFE members in our area. Since our last newsletter, we have two new chapter members. Welcome to Marty Arthur and Leonard Levine. We hope to see them at one of our chapter meetings in the near future.

#### SERVICE OFFICER REPORT – MARY MARGARET MCGOWAN

Fall is around the corner but there is another fall NARFE members must be concerned about the kind where you fall down. Falls are not a normal part of aging. In older adults, falls can jeopardize an individual's safety and independence. Falls account for 70 percent of accidental deaths of individuals who are 75 and older. Risk factors for falls in older adults include cognitive impairment, muscle weakness, stiff joints, pain, fear of falling and presence of two or more chronic illnesses. According to the Center for Disease Control and Prevention (CDC), individuals suffering from dementia are eight times more likely to fall compared to individuals without dementia.

## **NATIONAL LEGISLATION – DAAD PIERCE**

- Congress is on "State Work Period." The Senate will reconvene on September 6<sup>th</sup> and the House on September 13<sup>th</sup>, 2022.
- On August 16<sup>th</sup>, President Biden signed the **Inflation Reduction Act**. Items of interest to NARFE members include:

- Medicare will be able to negotiate the prices of a limited number of prescription drugs. Some of the health care savings offset caps on Medicare Part D enrollee cost sharing and extend some Affordable Care subsidies.
- The Residential Clean Energy Credit will allow subtraction of 30 percent of solar costs from federal taxes, through 2032.
- On August 10<sup>th</sup>, The President signed **The Pact Act**, which provides recognition and health coverage to Vets harmed by burning waste while stationed abroad.

#### **NARFE Advocacy:**

- On August 2<sup>nd</sup>, Senator Tim Kaine, D-VA, joined by several colleagues and with NARFE's endorsement, introduced the **Preventing a Patronage System Act**, a bill that would prevent future administrations from creating new excepted service schedules to bypass traditional merit-system rules, unless Congress changed laws to allow it.
- Meanwhile, NARFE opposes a new **Public Service Reform Act**, introduced by Rep Chip Roy, R-TX, on July 28<sup>th</sup>, which would eradicate merit-based Civil Service.
- On August 3<sup>rd</sup>, the Senate Committee on Homeland Security and Governmental Affairs advanced the **First Responder Fair RETIRE Act, H.R. 521**, that would permit federal first responders who suffer a disabling injury or illness on the job to remain in the public safety retirement system should they continue their federal service in a non-public safety position. NARFE expressed its support for the bill in a letter submitted to the committee.
- On July 29<sup>th</sup>, NARFE National President Ken Thomas joined Rep. Abigail Spanberger, D-VA, Rep. Rodney Davis, R-IL, and other officials at a press conference to celebrate surpassing 290 cosponsors for the Social Security Fairness Act, H.R. 82, which would fully repeal both the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO). Per House rules, hitting this threshold and keeping it for 25 legislative days, could allow these representatives to force a floor vote.

# **Other News**

- Federal agencies are taking precautions to protect employees in the face of growing threats against them, announcing security reviews and encouraging other steps to stave off potential danger.
- The White House and the National Archives and Records Administration are considering how to adjust a looming deadline for transitioning the government to full electronic record keeping, with many agencies expected to miss the target date at the end of this year.

# STATE LEGISLATION – CHRIS GIESELER

**2022-2024 Budget Bill**. On June 1, 2022, the Virginia General Assembly passed the 2022-2024 budget bill for the Commonwealth (HB 30). Governor Youngkin then proposed a number of amendments to HB 30. The General Assembly acted on those amendments (adopted, rejected or "passed over") on June 17 and sent the bill back to the Governor. HB 30, as amended, was signed by the Governor on June 22, 2022 and was effective on July 1<sup>st</sup>.

The General Assembly passed HB 30 and other bills during a Special Session. The Special Session adjourned to September 7, 2022. It's not clear what will be considered when the Special Session resumes on that date. Perhaps the Senate amendments to HB 30 that were "passed over" will be considered. More information will be provided at the September 13<sup>th</sup> Membership meeting.

**2023** Legislative Plan. The Virginia Federation of NARFE's Legislative Team, headed by Debbie Fisk, State Legislation chair, met via Zoom on several occasions during the summer to finalize work on the 2023 Legislative Plan. The Legislative Plan, approved by VFN's Board, focuses on the following issues: state income tax exemption for Civil Service Retirement System benefits; nursing home minimum standards; state tax deduction for family health care providers; elimination of means-testing for Virginia's \$1200 age deduction; and allowing Virginia income tax filers to itemize deductions even if they used the standard deduction on their federal income taxes.

The Plan will be the basis for lobbying/educating members of the General Assembly regular session that will open on January 11, 2023, regarding those issues.

The finalized Legislative Plan—in a trifold brochure-- was printed and has been distributed to local NARFE Chapters. The brochures will be available at our September 13<sup>TH</sup> Membership meeting.

Ms. Fisk will be the presenter at our September Membership meeting and will discuss legislative matters of interest. Members of other NARFE Chapters and members of the general public are invited to attend this meeting!
