PRESIDENT'S CORNER

NARFE is a nonprofit, nonpartisan membership association. Roughly 160,000 members live in every congressional district across the country and consist of both retired and active federal workers from all branches and levels of the federal government, including the U.S. Postal Service. Federal benefits and retirement plans are unique, complex, and subject to change. Change is a key word. We must make sure that change does not dilute our earned benefits in any way. NARFE provides federal workers and retirees with the clear, reliable, and accessible counsel they need to make important changes regarding their benefits.

In exchange for years of hard work, federal employees and retirees were promised retirement annuities and retiree health benefits. These benefits were paid for, earned fairly, and are essential to our financial and health security. Yet, there have been administrations who tried to reduce or eliminated cost-of-living adjustment for federal annuities, tried to dilute already earned benefits for those in or approaching retirement and retroactively change benefits that were already earned through the retiree's past public service.

Since NARFE's founding in 1921, the association's mission has been to defend and advance the earned pay and benefits of America's civil servants. Federal workers dedicate their careers to the betterment of our country, and in return we ask our government to hold up its end of the bargain – keep the promises made when we were hired, including our compensation packages. NARFE honors our service as federal employees, and they seek to ensure we continue to have a secure future.

I hope with all the end of year activities we will be able to take time to reflect on what NARFE means to each of us. As an organization, they work tirelessly to make sure our earned benefits are secure. It is our job to support their programs.

CONGRESSIONAL UPDATES

CDL VA 7th Congressional District

As of January 1, 2023, the 7th Congressional District representing Richmond City, Chesterfield, Spotsylvania and Henrico counties etc. will be history. The seventh as a district number will still exist up in Spotsylvania and counties north of Richmond.

Our representative in congress, Abagail Spanberger will run for the House of Representatives in the neighboring counties up towards Northern Virginia.

She has sponsored bills which favor NARFE and it is much appreciated. If she wins her stay in office we hope she continues in her support of NARFE priorities. Consider sending her a note of appreciation for her past efforts.

Also, on January 1, 2023, I will no longer serve as a congressional liaison or leader of the seventh congressional district. I wish to thank all the members of our chapter and those in Petersburg, Louisa, Spotsylvania and Richmond who have contributed to NARFE's success and support of the NARFE's legislative priorities. Continue to support NARFE's priorities by calling, writing, emailing the person elected to represent you in your congressional district.

New Congressional Districts and Candidates 1st Congressional District

On November 8, 2022 we will have the opportunity to vote for either the incumbent Rob Wittman (R) or the challenger Herb Jones (D).

3rd Congressional District

The incumbent Bobby Scott (D) will run against the challenger Terry Namkung (R).

4th Congressional District

Leon Benjamin (R) will run against the incumbent Donald McEachin (D).

Scott and McEachin have been great supporters of NARFE. Bob Wittman has supported NARFE priorities on occasion. The challengers may require some research as to their support of federal workers and retirees. Whoever is elected will have to be introduced or reintroduced to NARFE's priorities such as reasonable compensation, health care benefits, retirement benefits, Fair COLA for Seniors, opposition to the politicization of the federal workforce and Social Security issues to name a few.

NATIONAL LEGISLATION

In the previous issue of the Newsletter, I mentioned several of NARFE's Legislative Priorities:

Equal COLA Act – S. 4221 and H.R. 304 – the House version

H.R. 951 - Federal Telework Bill - Approved by the House.

House FY 23 Appropriations Bill paves the way for 4.6 percent raise.

H.R. 4315 - Fair COLA for Seniors Act of 2021

H.R. 82 - Support the Repeal of WEP and GPO – The House has enough sponsors to set an upcoming vote. The Senate has a sister bill in progress. The point is both have to vote and approve the repeal by the end of the year – otherwise the bill will have to be reintroduced in the next session of congress.

We need to make sure that these bills get approved by the House and Senate. I recommend a thorough review of these bills in the next week or two by our members to advise the House and Senate of your priorities. Review the NARFE Advocacy website and send a letter to your congressman or senator. If the bills are not passed before Jan 1, 2023, they will have to be reintroduced and go through another lengthy process for approval votes and passage for the President's signature. Politics is a long process – good luck on the outcomes, never give up.

NARFE-PAC

When we support members of the House and Senate - that vote favorably on bills that help us meet our needs – it is a good investment for our future. In addition, call, write and email your needs to congress. Let them know that you care. Use the NARFE Advocacy website – it's a convenient way to advocate.

NATIONAL LEGISLATION

August was National Advocacy Month

We were delighted to have Senator Tim Kaine visit Chapter 2265's meeting in August. It gave our members an opportunity to listen and then, more importantly, to be heard. It is crucial that we continue to speak out so that there is no question about our priorities, especially when it comes to our hard-earned benefits.

Senator Kaine listened, he distributed staff contact information so that our members can cut the red tape and speak directly to consultants, and he promised to sign on to cosponsor Senate 1302 which is the complimentary bill to H.R. 82, WEP/GPO Repeal Legislation. As soon as he got back to Washington from August recess, he did sign on. We now need to make sure we follow up with Senator Warner.

H.R. 82 currently has 296 cosponsors and was placed on the House Consensus Calendar on July 15. It must keep a minimum of 290 cosponsors for 25 legislative days to be forced onto the House floor for a vote. We are almost there and with so many cosponsors we anticipate the bill passing with no problem. There are now 298 cosponsors and gaining a few more each day.

The next step, the Senate. There are currently 42 cosponsors. I don't see Senator Warner officially on board but with his commitment that would be 43. It takes 60 votes, so we are scrambling to identify 17 more votes. This is so important to so many, let us all be vigilant and keep the pressure on to get this finally done.

The Inflation Reduction Act was signed by President Biden in August. The bill pairs about \$300 billion in estimated deficit reduction from about \$739 billion in increased revenue and health care savings with about \$443 billion in energy, climate, and additional health care spending.

Senator Kaine, joined by several colleagues and with NARFE's endorsement, introduced the Preventing a Patronage System Act, a bill that would prevent future administrations from creating new service schedules to bypass traditional merit-system rules, unless Congress makes a change by law.

As the 217th Congress winds down, we all anticipate a great deal of time and energy will be devoted to the mid-term elections. Two things I would like to mention.

- It is your right, privilege, and responsibility to vote. Do your research and vote your conscience, but please VOTE.
- There is still time to easily send electronic messages via the NARFE website. Keep your voice in front of your representatives. Go to: https://www.narfe.org/advocacy/legislative-

action-center/ At the drop-down menu select ADVOCACY and then TAKE ACTION. A really easy way for you to stay in touch.

Recap of the 2022 Legislative Plan

The major emphasis of the VFN Legislative Team is on two major areas and the remainder will be secondary:

- a. Exempting a Segment of CSRS Pensions Equivalent to Social Security Retirement
 - i. Main focus for the team
 - ii. Focusing on the Military Exemption from the last congress
- b. Nursing Home Standards
 - i. Secondary focus for the team
- c. Family Caregiver, Age Deduction, and Itemize vs. Standard Deduction will be handled if given time and volunteer commitment

The VFN Legislative Team continues to meet and collaborate. They update key members of the board and chapters as information is possible. We participated in several chapter meetings, speaking about legislation.

During a visit to Chapter 1116, Vienna/Oakton, D. Fisk was able to gather several great ideas as well as enlist several eager volunteers to join our team. She continues to work very closely with Chris Geisler, who has become our "unofficial" State Legislative Representative.

FEHB Open Season

The 2023 Federal Benefits Open Season is coming! It will run from November 14, 2022, through December 12, 2022. This is the time for you to start thinking about your health, dental, vision, and tax-saving needs and to enroll or change your enrollment in any of the FEHB, FEDVIP programs, and FSAFEDS for those feds who are still working.

I am pleased to announce that the NARFE Chapter 2265 (Midlothian) will be having a Blue Cross Blue Shield representative, Kathy Bass, as our guest speaker

on Wednesday, October 12, to bring you the latest updates for 2023. Put it on your calendar to attend.

During Open Season, you can make selections you usually cannot make any other time of the year. All health, dental or vision plans are not alike. Open Season is about exercising your right of choice. By considering your health plan choices in advance, you will have access to health care services and supplies you need, with a premium you can afford.

Dental and/or vision coverage can fill in the gaps of any coverage you currently have or pay for services you currently do not get. A flexible spending account can help lower your taxable income.

If you are already enrolled in FEHB and/or FEDVIP, those enrollments will continue automatically, although benefits and premiums may change. Be sure to check that your plan is still participating.

Any changes you make to your enrollment will be in effect until the next Open Season in 2023 unless you experience a qualifying life event.

Is Our Chapter in Trouble?

Chapter 2265's current membership is 202 Chapter Members and 126 National Only assigned to Chapter 2265 because of their home address for a total of 328 members. In 2016 the total was about 457. Average monthly income (the Chapter's portion of membership dues) so far in 2022 is averaging \$177; in 2016 it was \$311.

Before joining Chapter 2265, I was the President of Chapter 1310 Imperial Plaza. We met at Imperial Plaza, a large retirement home. They treated us well. We met in the Executive Board Room, a sit-down inexpensive lunch was served by the dining room staff, free coffee and drinks, etc. Some of our members lived at Imperial Plaza. That could have been the reason we were treated so well.

In 2017, membership in Chapter 1310 had dropped to around 40 and about 10 members attended meetings, which were mostly social. It got to the point that no one was willing to step up to leadership positions. So, the painful decision was made to close the Chapter. A difficult process when you have lost contact with so many members.

Only three members joined other Chapters in the area. The remaining members were added to the National database. As I recall, we had approximately \$4,000 in our treasury. We explored the possibility of donating the money to the Alzheimer's Association. We found out, however, that membership money cannot be donated to Alzheimer's. So, the money was surrendered to National minus a small portion that was sent to the Chapter's where 1310 members were transferred.

This brings me to the previous question: Is our Chapter in trouble? Personally, I think we are. We are seeing some of the troubling signs that my old Chapter was experiencing. Loss of members and income, the unwillingness to step up to leadership, poor meeting attendance, and a general reluctance to get involved are all signs of a declining interest and will lead to difficult changes.

Please keep these thoughts in mind. Participation in chapters is important. As one voice we are able to protect our earned benefits, the principal mission of NARFE. We have an outstanding Chapter, one of the best in the state, but it can slip away if we aren't willing to put forth the necessary effort to keep it viable.

ALZHEIMER'S

In the September 7th news article from the Alzheimer's Association, it was noted in a study that the popular TV show, "This Is Us," has had a real impact on people living with Alzheimer's disease and caregiving. In fact, one of the leading characters in the show was living with the disease. It was also pointed out that her adult children disagreed over her care needs.

A survey found that more than 700 people could relate to the mother, Rebecca Pearson, who struggled with her diagnosis, including the early signs of memory loss and her resistance to go and seek out a provider to help her. It was also stated that the storyline in this TV Show could help reduce the stigma associated with this disease and encourage people to seek help. Viewers of the show may also recognize signs and symptoms in themselves or in those close to them. It may further help to de-stigmatize seeking care for the disease and to seek an evaluation.

The showline was developed in close collaboration with medical and health experts at the University of Southern California's Health and Society Program. Beth Hoffman, who conducted the study, found that very little research has been done on the influence of aging, advance care planning and Alzheimer's disease. These storyline topics are not widely depicted on TV. Also, Monica Moreno, the senior director of care and support for the Alzheimer's Association, said that some people think of Alzheimer's only in its late stages, while shows like this depict a fuller picture of the disease. Further information from this article can be found in the August 31 "Journal of Health Communication."

scams and cybercrimes — linking to information from the FTC detailing each crime and how you can protect against them:

- <u>Identity Theft</u>: Someone gets your personal information and runs up bills in your name. They might use your Social Security or Medicare number, your credit card, or your medical insurance along with your good name.
- <u>Unwanted Calls</u>: You get a lot of unwanted calls. Many are from scammers.
- <u>Imposter Scams</u>: Someone calls to ask for money, maybe pretending to be a family member in trouble, like a grandchild. Are they who they say they are?
- <u>Health Care Scams</u>: You have a Medicare card, but a caller says you need a new one.
- <u>"You've Won" Scams</u>: They tell you that you've won a prize! But you can't get it until you send money.

- <u>Home Repair Scams</u>: Someone offers to repair your home. Cheap. For cash now.
- Money Mule Scams: Someone sends you money. Then asks you to send some of it to someone else.
- Work-at-Home Scams: Ads promise big money working from home. For a fee.
- <u>Charity Fraud</u>: Someone asks you to donate money to a charity. Today.

How can potential cybercrimes be reported?

Cybercrime cases often cover multiple jurisdictions and can involve multiple law enforcement agencies, so the FTC and the Federal Bureau of Investigation (FBI) both have consolidated reporting mechanisms. If you think you have been a victim of a cybercrime, you should visit the FTC's reporting page and the FBI's Internet Crime Complaint Center (IC3) for additional resources.
