<u>Chapter Elections</u> – At our Chapter's November 2<sup>nd</sup> meeting, members elected the following individuals to serve on the Executive Board for 2023: **Kim Rendelson**, President; **John Bankson**, 1<sup>st</sup> Vice President; **Pat Drobnek**, 2<sup>nd</sup> Vice President; **Jack Bagnulo**, Treasurer; and **Fran Walinsky**, Secretary. Elected officers will assume their positions in January. We congratulate each of our elected Board members and thank you for ensuring the continued success of the chapter.

<u>Audit Committee Nominees</u> – At our December 7<sup>th</sup> Luncheon the following nominees will be presented for membership approval to audit the Chapter's financial records for 2022: **John Bankson (Chair)**; **Frank Toth**; **and Mara Yachnin**.

<u>Inclement Weather Policy for the Luncheon Only</u> – If Fairfax County Public Schools (FCPS) open two hours late on the day of our luncheon due to inclement weather, the luncheon will be held. If the FCPS are closed, we will decide whether to cancel the luncheon based on conditions in the local area. If we have to cancel, we will attempt to contact everyone who made a reservation. In addition, we will post notice of any cancellation on our website and Facebook page. You also can contact Kim Rendelson at 703-204-0388 to learn if the luncheon will be held.

November Program - Two speakers made presentations. First, Arlene Arthur, VFN Service Officer, discussed "Federal Employee Health Benefits Plan Changes Throughout the Year". Open Season is November 14th through December 12th this year. You have 29 days to look at your health insurance needs and go through the FEHB plans to decide if it would be better for you to make a change. Note OPM is going to include a Medicare Advantage Plan as an option this year. Be aware the Medicare Advantage Plans you see advertised on television, or whose literature comes to your home, do not apply to federal employees. Of course, not everything affecting your health insurance happens during Open Season. Ms. Arthur discussed several such events. For example, if you decide to move to another state and you are enrolled in a health benefits plan that serves a limited geographical area, you need to verify coverage in your new location. Our second speaker was Michele Nesbitt-Johnson, Account Manager with Blue Cross/Blue Shield (BC/BS). She provided some general information about BC/BS and discussed changes in BC/BS plans for 2023. With BC/BS, there are three plans from which to choose - Standard Option, Basic Option, and FEP Blue Focus, which is a fairly-recent plan added to meet your needs and budget. Now, what are the updates for 2023? First, Standard Option monthly premiums in 2023 will be \$308.53 (Self Only (104)), \$690.84 (Self + One (106)), and \$753.77 (Self & Family (105)). Ms. Nesbitt-Johnson said your Service Benefit Plan coverage works best when original Medicare is your primary coverage because this means Medicare pays first. BC/BS also has a Medicare Reimbursement Account (MRA) whereby Basic Option members enrolled in Medicare Parts A and B can receive up to \$800 per calendar year to offset Medicare Part B premium payments. The MRA applies to each member of the household. She went on to address several value-added programs/enhancements to your medical benefits such as Hearing Aid Benefits whereby both Standard and Basic Option members receive an allowance of up to \$2,500 every five years for the purchase of hearing aids and hearing aid supplies. In terms of wellness incentive programs, both Standard and Basic Option members can earn \$50 the first time they fill out a Blue Health Assessment (BHA) questionnaire. The goal is to help you identify health risks before they become issues. Other value-added BC/BS programs include an Online Health Coach who encourages you to complete manageable activities each day to reach wellness goals you have set. You could earn \$40 for each goal accomplished up to \$120 for three goals. In total, then, by completing the BHA and a maximum of three health goals during the calendar year, you could earn up (continued on page 4)


(continued from page 3) to \$170 to use toward qualified medical expenses. There are about 271 plans under FEHBP so you have choices, and there are plan-comparison tools available to help you in your research. OPM's comparison tool can be found at <a href="https://www.opm.gov/healthcare-insurance/healthcare/plan-information/compare-plans">https://www.opm.gov/healthcare-insurance/healthcare/plan-information/compare-plans</a>. Mark Your Calendars – The 2023 Virginia Federation of NARFE Chapters (VFN) Annual Meeting is scheduled for April 2 - 5, 2023 in Hampton, Virginia.

<u>Legislation Report</u> – *Election News*: Congratulations to our House Representatives **Don Beyer** (8th District), **Gerry Connolly** (11th District), and **Jennifer Wexton** (10th District) who all won re-election. Upon return to

Congress to finish out their current terms, they will be facing a very busy Congressional schedule to resolve many important issues, not the

least of which is the Fiscal Year 2023 Federal Budget. As of this writing, control of the incoming 118<sup>th</sup> Congress is not yet decided.

*Federal Budget*: The current Continuing Resolution (CR) to fund the government expires on December 16<sup>th</sup>, at which time Congress will need to enact a final spending bill (desirable), pass another CR (likely), or risk a government shutdown (unlikely). Stay tuned.

COLAs for Annuitants and Social Security Beneficiaries for 2023: CSRS and Social Security 8.7%; FERS 7.7%.

Federal Employee Salary: President Biden formally announced his plan to give civilian federal employees a 4.1% base pay increase, plus an average locality pay boost of 0.5%, creating an overall average increase of 4.6% for 2023. Since the House was silent on the pay raise in its appropriations bills, the President's plan will most likely be implemented.

H.R. 82, Social Security Fairness Act, would eliminate the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO) from Social Security law. The bill has bi-partisan support among its 305 co-sponsors. A Discharge Petition (a process that requires 218 in-person signatures) was filed September 30, 2022 — only twenty-two Representatives signed the petition before leaving for the election recess. The Discharge Petition is a tool employed to move a bill forward in opposition to the committee of jurisdiction, in this case, the Ways & Means Committee, and majority House leadership. Simply put, this action would bypass the committee and House leadership, forcing H.R. 82 to a vote regardless of what the powerful Ways & Means Committee or House majority leadership desired. When Congress returns, H.R. 82 is just one of many pieces of legislation pending before the end of the 117th Congress.

*Virginia Legislation*: At our November chapter meeting, copies of the Virginia Federation of NARFE (VFN) "2023 State Legislative Plan" were distributed.
