SCAM ALERT

PROTECT YOURSELF FROM HOLIDAY SCAMS – To ensure you have a safe and celebratory holiday season, be wary of these common holiday scams: phony selling, fake invoices and bank notifications, lookalike pages, 'your order has been canceled,' and 'renew your membership for the purchases you have made.' To help avoid getting scammed, here are some "best practices" offered by the FBI.

- Do not click on suspicious links or attachments in emails, websites, or social media.
- When buying from a website, check the URL to make sure it is legit and secure. According to the FBI, the website should have "https" in its address.
- Verify the buyer and check feedback ratings.
- Avoid sellers who act as authorized dealers or factory representatives.
- Beware if the seller responds to your questions by saying they are out of the country or away at a family emergency.
- Do not wire money directly and avoid using prepaid cards.
- Get tracking numbers and follow the delivery process.
- According to the Better Business Bureau, federal law requires that orders be shipped by the date promised and if you don't receive the items on time, you can cancel and demand a refund.

Most needed items include:

- Fresh fruits (oranges, apples, bananas, tomatoes, avocados, grapes, berries)
- Fresh vegetables (cucumbers, celery, peppers, lettuce, eggplant)
- Oil
- Cereal
- Canned tomato products (crushed, peeled, diced, etc.), 4oz – 1 lb.
- Canned meat (chicken, turkey, or seafood), 2oz – 15oz
- Rice, 16oz packages
- Spaghetti sauce, 14oz 1 lb. (ideally in cans instead of glass)

- Canned fruit (packed in fruit juice instead of syrup) 11oz – 20oz
- Dried or canned beans (black, kidney, pinto, etc.)
- Pasta
- Fruit juice (100% juice) 32oz 64oz

Non-Food Items:

- New or Clean Reusable Grocery Bags 8 ½ x 14 x 15
- Can openers

We are also happy to accept perishable items including meat and dairy products that are sealed, in their original packaging, and **UNEXPIRED**. We are unable to accept donations of items that are more than 3 years expired, opened items, food that is not labeled, homemade items, or cooked food.

LEGISLATIVE NEWS

(As of November 16, 2022)

NATIONAL LEGISLATION – Returning from an extended recess, Congress has just four scheduled working weeks in which to decide on a range of federal workplace issues before the new Congress convenes in January and the process would have to restart. Democrats will be pressing to enact their highest priority bills while still in control of both chambers.

Foremost among them is a proposal to change the law so that a future administration could not issue an order similar to one issued by the Trump administration in late 2020 creating a new exceptive service schedule known as "Schedule F," essentially turning tens of thousands of competitive service jobs involved with making or carrying out policy into political appointive positions, without civil service protection or ending requirements for competition in filling those positions. While President Biden last year revoked that order, the prospect of a future Republican administration revoking Biden's order and reinstating a Schedule F has made changing the law to prevent such a sequence a high priority for federal organizations and their Democratic supporters in Congress.

The most likely course remains an amendment to the "must-pass" DoD authorization bill that will come to a Senate vote in a post-election session, with a conference to follow with the House and final enactment by the end of this year.

The DoD bill will also likely become the vehicle for a number of relatively minor improvement to benefits, including payments on the death of a federal employee in the line of duty and creating a presumption that certain conditions suffered by federal firefighters is work-related for purposes of injury compensation benefits.

Federal unions are also pushing for end-of-session action on measures that have progressed in the House such as putting TSA employees under standard civil service rules for pay, bargaining and other purposes; broadening whistleblower protections; and expanding bargaining rights of certain VA medical personnel.

In addition to the DoD bill, another top priority for Congress before year's end will be the need to extend agency funding beyond the December 16 expiration of the current stopgap measure. It is uncertain whether a new extension will go through the remainder of the fiscal year ending next September 30 or only until sometime early in 2023.

Several nominations of importance to the federal workforce meanwhile remain pending, including the five-member TSP board; the OPM deputy director position; and the Merit Systems Protection Board chairwoman. **(FEDweek)**

Insurance premiums for the Federal Employee Health Benefits Program will jump by an average of 8.7% in 2023, the largest increase in more than a decade. When OPM released the new rates, agency officials cited the increased use of healthcare services as the reason for the higher costs. **(Government Executive)**

Medicare Part B's standard monthly premium will fall to \$164.90 in 2023, a \$5.20 decrease from this year, welcome news after 2020, when the Centers for Medicare & Medicaid Services hit beneficiaries with the highest ever increase. The annual Part B deductible for 2023 is also decreasing to \$226, a \$7 decline. (AARP Bulletin)

<u>VIRGIINIA LEGISLATION</u> – Governor Glenn Youngkin has released his vision for a comprehensive Virginia Energy Plan, which he says would diversify the energy sector by tapping into nuclear energy, natural gas, renewables, and other energy sources. The plan, diverging from Democratic-passed legislation signed by former Gov. Ralph Northam to gradually shut down carbon-emitting energy sources by 2050, has received mixed reactions from lawmakers, with Republicans applauding the governor's vision and Democrats expressing concern about scaling back the state's fight against climate change. Most of the governor's recommendations will require action by the General Assembly to move forward. (**The Center Square**)
