Linda Sanders called the meeting to order at 10:30am. Marie Collins led the invocation and Linda led the Pledge of Allegiance.

Linda introduced our speaker, David J. McCauley, Director, Hampton Department of Parks, Recreation and Leisure Services. Also attending with Mr. McCauley were Susan, Senior Center Director, and Linda, Senior Citizens Advisory Committee. He oversees 300 employees and 400 assets. His budget is \$2.5 M - (he needs \$10M). Most recent activities: upgrade of the Air Power Park and the completion of the 2.5 mile Water Walk Trail from the Air Power Park to Blue Bird Gap Farm and the completion of the Aquaplex Center, which will open at the end of October 2022. He provided copies of the Senior Programs Hampton provides and a summary of Hampton P, R & LS programs.

Election of First Vice President: Mike Thurber was elected by acclamation as First Vice President after Linda requested nominations from the floor.

Installation: Marilyn Riddle, Area VP District 1, formally installed Mike Thurber as our new First Vice-President

Secretary's Report – October board meeting notes will be provided at the November chapter meeting.

Treasurer's Report – Maggie noted that our balance as of 30 September was \$4,317.12.

Area VP 1 Marilyn Riddle (Williamsburg Chapter 685) spoke briefly, introducing herself and discussed the future plans of the Virginia Federation. She provided us with copies of our State Legislative Plan for 2023. She announced that the Virginia Federation Conference will be held in Hampton 2-5 April 2023. She will need volunteers from each chapter in Areas 1, 2 and 4 to assist. More information will follow soon.

NARFE DIASTER RELIEF PROGRAM

In the wake of Hurricane Ian's devastation, NARFE reminds affected members that they are eligible for cash grants through the NARFE-Federal Employee Education and Assistance Disaster Fund.

After a declared natural disaster, NARFE members may request a NARFE Disaster Assistance Grant. (The grant maximum is \$500.) Documentation will be required to show loss or destruction of property or how the applicant was injured as a result of a natural disaster. Grant checks are payable directly to the applicant or to a specific creditor.
