Watch 'Town Halls' with questions by the audience and answers by the candidates for congress, the senate and president. As best as you can, evaluate who is more empathetic and knowledgeable of your needs and understands the consequences of the actions they take when enacting legislation for all Americans.

STATE LEGISLATION

The VFN 2020 State Legislative Plan met with partial success in two important areas in the last General Assembly session.

VFN had urged legislation that would expand the "No Excuse" absentee voting period to at least 45 days prior to an election, the same period allowed for absentee voting in general in the Commonwealth. This legislation was only one of other significant changes in voting which was signed by the Governor, including removal of the photo ID voting requirement, and to extend in-person polling hours by an hour (from 7 pm to 8 pm), and expanded absentee voting timeliness, and made Election Day a state holiday.

The VFN recommendation that the General Assembly pass the exact same language regarding a proposed constitutional amendment for redistricting reform that was approved by the 2019 General Assembly, which is necessary to allow Virginia voters to vote on the issue also was successful. This amendment would create a bipartisan commission made up of 16 members. Eight members would be legislators-two each form the minority and majority parties of both House and Senate, and the other eight would be citizens that the legislature would pick from a group selected by a panel of judges. The commission would submit a map to the legislature for an up-or-down vote without changing the map. If the General Assembly does not approve a map, the Virginia Supreme Court would take over. There is legislation to accompany the amendment to establish criteria for drawing the political maps. The rules require preservation of communities of interest, equal opportunity for minorities, not favoring any political part, and districts that are similar in population and are compact that follow political boundaries as much as

possible. This redistricting amendment will be on the ballot this fall for final voter approval.

- 3. As you know, NARFE exists to safeguard and enhance federal employee health benefits, retirement benefits, and pay issues for active federal employees and annuitants as well as retired employees and annuitants.
- 4. Your membership is a small price to pay about 86 cents a week or a little more than a dime a day. Be sure to renew your membership when it comes due and help us help you to protect your hard-earned pay and benefits.
- 5. If you have not subscribed to dues withholding, do you know you can get a 15% discount. Your net savings is \$5.96 annually and annual renewals are seamless.
- 6. EMAIL ALERT: If you are a member and have not been receiving monthly email notices, please send an email to narfe2265df@gmail.com and we can talk about investigating whether your membership is strictly NATIONAL or NATIONAL plus Chapter 2265. Also, you may be assigned to a different Chapter and we can assist you by contacting our Federation or National Member Records.
- 7. Even one member can make a difference in NARFE's mission. Remember that numbers count! The number of federal retirees and employees who join, adds volume to NARFE's voice and augments NARFE's legislative outreach. NARFE is the only association that lobbies for federal benefits. There is no one else looking out for you, your family and your future!

- 11. You may not know this:
 - a. When you join NARFE you are assessed a fee of \$40. That covers National Dues for 1-year and a 1-year subscription to any Chapter; however, you must specify which Chapter you want to be assigned to.
 - b. When your annual subscription is renewed your annual dues drop to National only. You must specify that you want to remain in a Chapter. You have options:
 - i. You can pay \$40 for National
 - ii. You can pay \$34 for National (Dues Withheld \$6.00 savings)
 - iii. You can pay \$40 National and \$10 Chapter
 - iv. You can pay \$34 National and \$9.96 Chapter (Dues Withheld \$6.04 savings)

ALZHEIMER'S COMMITTEE

Here is some of the latest news from the Alzheimer's and Dementia newsletter. In the midst of the COVID-19 crisis in our nation here are some tips for caregivers of dementia and Alzheimer's patients.

- 1. Unless a person has severe symptoms like difficulty breathing or a high fever, it is recommended that the caregiver call a healthcare provider instead of going directly to the emergency room.
- 2. Persons with dementia related illnesses may need extra and or written reminders and support to remember important hygienic practices from day to day. These written signs may be placed in the bathroom and elsewhere to remind the patients to wash their hands with soap for 20 seconds.
- 3. Try to seek out a pharmacist or a doctor about prescriptions for a number of days to reduce trips to the drug store or pharmacy.
- 4. Have alternate care plans for the person with dementia just in case adult day care or respite care is cancelled or modified in response to the virus.
- 5. Also, think and plan ahead in case the primary caregiver becomes ill.

These are just a few suggestions among many that are available to caregivers during this time.

In addition, I have spoken with Barbara Montieth who works with the Alzheimer's Association. She sent me a copy of some great fundraising ideas for us to consider in the future. It was entitled "Fundraising Ideas from A to Z." For each letter of the alphabet, there is at least one suggestion of an activity to raise funds for the disease.

Some of them include an adult spelling bee, birthday party, change jar, dance competition, errand service, fashion show, game night, hot dog contest and ice cream social. I look forward to sharing several of these ideas with our group.

Be sure to check on your love ones during this time in our country. Find ways to reach out to neighbors and friends with words of comfort and encouragement. We need each other now more than ever, so let us show some genuine love and compassion for one another.

Total Assets: \$16,380.28. The 2019 Tax Return has been filed. The Chapter received 4 donations in memory of our former member Tom Behm which were sent into National. We are expecting at least 13 Chapter members to attend the 2020 Conference in April and their conference registrations were paid by the Chapter.

- 2. It may be necessary to postpone the Conference due to the impending virus threat. You will be notified if and when things change.

3. I was asked to join the Bylaw's Committee. As of this date there are no nominations for changes to the Bylaw's submitted. There is an opportunity to make changes each year, a great deal of work was done in 2019 so there may be little work done in 2020.

Committee Reports:

Alzheimer's: Faye McKay, asking for volunteers and looking for additional fundraising opportunities. Faye is in contact with Barbara Monteith from our local Alzheimer's Association collaborating on fundraising ideas.

Membership: Pat Warhurst, issues with the web portal continue and we will investigate why officers who should be authorized to access the reports cannot do so.

- 1. From the Net Coordinator report, the President reported that we currently have 254 Chapter Members, 144 National Members for a total of 398 NARFE Members registered online. Our President shared that she is in receipt of a membership application and will report that it is not reasonable that there is no place to input the Chapter number.
- 2. Clarification that new members are assessed \$40 for the first year which pays National Dues and allocates \$10 to a Chapter. If you don't physically write in a Chapter that money is not disbursed to any Chapter. In the second year of membership, if you do not specify a Chapter number you are invoiced for National dues only and you are not assigned to a Chapter. There is some confusion from members who incorrectly assume they are assigned to a Chapter and we will do our best to identify members and get them set up correctly.
- 3. It will be important as we move forward to escalate our membership programs. We will rely on all members to help with this as we move forward. "Recruit/Retain/Reclaim" will be particularly important in 2020.

National Legislation: Don Utton, Absent, No Report

7th **District CDL:** Bob Zombron – March is designated as a time to contribute to the NARFE PACT which is used to support/fund politicians that vote for NARFE interests and objectives. Go online and research politicians and see what they are doing. Pay attention to make sure they are

supporting our goals. Be vigilant as you do your research which will help you in your choices come November.

Net Coordinator: Deborah Fisk reported:

- 1. She is trying to gain access to reports that were created prior to July 1, 2019. Working on identifying new members so that they have more information about our Chapter and can remain members after their first year.
- **2.** The web seminars are informative and many attendees have the same questions we have.
- 3. Cybercriminals are using concerns about the virus to launch phishing attacks. These emails may try to entice you with the promise of the latest virus protection information, the sale of scam products or the request for personal information. Please beware of clicking on email links or opening attachments referencing coronavirus, unless you are sure they are from a trusted source.
- **4.** Coronavirus recommendation from the CDC for elderly and physically fragile individuals to use caution in scheduling flights or cruises. Please use caution and good sense. Proper handwashing, hand sanitizers, distance and common sense is critical. Let's not panic, just stay cautious.

Programs: Verona McLeod shared:

- A bulletin from DSGR that had photographs taken at our February meeting. Personnel from DSGR presented our monthly program and we feel like initiatives like this helps keep our name in front of prospective members who are still actively employed.
- 2. Shared the results of the survey that was taken from our membership in February. If you have suggestions, please contact Verona.
 - a. We have a person from Medicare scheduled for September and our regularly scheduled October meeting with Blue Cross may include a representative from GEHA.
 - b. New locations for our annual Christmas party are being discussed along with adding more music to programs.
 - c. Additional items include hearing aid assistance, tax information, medical, and

- climate change. Maybe have a program about brain power. We frequently talk about exercising our bodies but not our brains.
- d. Today's program is "Real ID" as presented by Larry Jarrell from the Division of Motor Vehicles.

Public Relations: Norma Smith, Absent, (continues to put information about the Chapter Meetings in the Chesterfield Observer)

Special Activities: Lynn Osborne – Absent, but please remember:

- 1. May 3rd is the Virginia International Tattoo at the Scope Arena in Norfolk. The Tattoo is a military tribute performed by military bands from all around the world. Lunch at the Free Mason Abbey which is a church that has been converted into a restaurant. This year's theme is the 75th Anniversary of the end of World War II.
- **2.** Tangier Island is June 17, Skyline Drive in October and The Rudy Christmas Show in Selma, North Carolina in December.

State Legislation: Steve Stastny listed a few items that are part of the VFN 2020 State Legislative Plan. More information will be forthcoming, possibly by the April meeting.

- **1.** Exempting Certain Federal Pensions from Virginia Income Tax (not likely at this time)
- 2. Income Tax Subtraction for Retiree Health Insurance and Long-Term Care Insurance Premiums
- 3. Minimum Nursing Home Standards
- **4.** Redistricting Reform (both Houses have passed and likely the Governor will sign so it goes to the 16-member Commission before it goes on the ballot in November)
- **5.** Absentee Voting a change from no excuse policy from the 7-day requirement to 45 days (likely to pass)
- **6.** Tax Credit for Family Caregivers

7. Additional Changes: Reduced Sales and Use Tax on essential personal hygiene products, higher level of transparency on hospital costs, increase minimum wage in increments to reach \$11.50 per hour by July 1, 2023, decriminalize simple possession of marijuana, driver privilege cards to immigrants, make Virginia electric grid carbonfree by 2045.

Hospitality: Cathy Dorsett, reviewed changes that will be made to the hospitality calendar. She thanked everyone for their continued support in supplying refreshments for the meetings. There are still openings on the calendar, please contact Cathy. She expressed appreciation for those who remember donations to the Hospitality Jar.

Unfinished Business:

- The April Conference will be held at the Doubletree on Midlothian Turnpike, Richmond, VA. An email will let everyone know if it is cancelled.
- **2.** Our Chapter is registered for the Chesterfield Triad Senior Day on May 6th, Victory Tabernacle Church on Genito Road.

New Business: Virginia Bozarth, Audit Committee Member reported on the state of the audit. An audit of the 2019 books and records was completed by Virginia and Shirley Alexander. No significant findings or discrepancies were noted in this audit. All income and disbursements were accurately documented and accounted for in the records. Deposits were done timely and bank records were reconciled. Checkbook register was annotated correctly and reconciled to bank statements and treasury reports. Audit completed by Shirley Alexander and Virginia Bozarth, March 2020.

A motion made by Virginia Bozarth coming out of the Audit Committee recommended that the audit be accepted.

Motion passed unanimously.

Programs: After a short break, a program was presented by Larry Jarrell, a representative of DMV, about the new Real ID which will be necessary for entrance into U.S. facilities and domestic flights if you do not possess a Military ID or valid Passport.

The meeting was adjourned at 11:55 A.M.

Cruise to Tangier Island Wednesday- June 17, 2020

Tangier Island is a small, largely unspoiled, fishing village lined with quaint narrow streets. It is considered the "soft crab capital" of the nation. Although modernization has come to the Island it still has not lost its charm. The people of Tangier, who speak with a lingering trace of Elizabethan accent, are warm, friendly and proud of their Island. Once arriving in Reedville, you will board the Chesapeake Breeze for a 1½ hour cruise to Tangier Island. On your way you will learn about historic Reedville, the center of one of the largest fishing industries in the U.S. The Chesapeake Breeze often passes fishing boats working their nets or large ocean freighters traveling between Baltimore and Norfolk. Once arriving at Tangier, enjoy 2½ hours to explore the island - lunch is included at the Chesapeake House for a family-style lunch (including crab cakes and oyster fritters) at this favorite island restaurant.
