# PRESIDENT'S CORNER

As some of you may know, I am a fan of Presidential history. I've read a book about every President except the last two. (It takes a few years to get a perspective on the mission and accomplishments of those Presidents).

I recently read a book entitled "James Madison: The Father of Religious Liberty" by Rodney K. Smith. This book chronicles how the right to religious freedom became sacred to Madison and how he carefully wove this aspect into the Constitution and the Bill of Rights.

Our constitution was ratified in 1787 and almost immediately work began on the Bill of Rights. The Bill of Rights refers to the first 10 amendments of the constitution. The Constitution gives us a framework for our government, while the Bill of Rights specifies our individual rights.

Much of this book centered around the first amendment. This is the amendment regarding freedom of religion, freedom of speech, freedom of the press and the right of the people to peaceably assemble and to petition the Government for redress of grievances.

Madison was instrumental in getting the Bill of Rights to the finish line. This was no small feat. After

Congress approved these amendments, the States by 2/3 majority ratified the amendments in 1791, two years after Congress passed the amendments.

This is significant because it gives all of us, including our NARFE group, the freedom to let our representatives know our opinions. NARFE has made it easy to make our opinions known through the letter-writing feature on its website.

# "House Democrats will target tech giants with a major set of bills."

"Drafts of five bills obtained by The Technology 202 show that lawmakers are weighing a range of changes to federal law to empower regulators to rein in the business practices of Facebook, Google, Apple and Amazon."

"One draft bill would enable the Justice Department or Federal Trade Commission to sue to break up large tech companies when their role as operator of a platform presents an "irreconcilable conflict of interest" in their other lines of business. Another bill would prevent companies from giving their own services preference over rivals. One measure would block tech giants from acquiring nascent competitors."

"One is similar to a measure that recently passed the Senate, which would increase merger filing fees for large companies to ensure antitrust enforcers have more money. Another is focused on data interoperability, which could make it easier to use products from different tech companies together."

"These bills all take aim at practices that the House Judiciary Committee last year concluded tech giants used to solidify their dominance across the Internet, following a historic, 16-month investigation into their business practices. The measures are a sign that Congress is moving from grappling with the problems in the tech industry to actually debating legislation that would address long-running concerns."

"Even before the bills have been formally introduced, tech industry groups have come out swinging against them. NetChoice, which represents Amazon, Google, Facebook and other tech companies, said the measures would "kneecap" American companies and undermine American innovation amid increasing concerns about the competitive threat posed by China."

Senator Kaine News Release, May 26, 2021 King, Brown, Kaine Introduce Bill to Empower IRS to Close Trillion Dollar "Tax Gap" "The Stop CHEATERS Act would provide \$80 billion in mandatory funding to the IRS over the next decade, set audit rate goals for high-income individuals and corporations.

WASHINGTON, D.C. – U.S. Senators Angus King (I-Maine), Sherrod Brown (D-Ohio), Chairman of the Senate Committee on Banking, Housing, and Urban Affairs, and Tim Kaine (D-Va.) are introducing legislation to provide additional funding to the Internal Revenue Service (IRS), so it has the necessary resources to take on high-income tax evaders. The Stop Corporations and High Earners from Avoiding Taxes and Enforce the Rules Strictly

(Stop CHEATERS) Act aims to reverse trends that have undermined the IRS's enforcement ability; over the last decade, the IRS's budget has been cut by 20%, leading to the IRS disproportionally auditing lower income earners. As a result, IRS Commissioner Chuck Rettig estimates that tax cheats – frequently in the highest-income brackets – are shortchanging the country by as much as \$1 trillion. Today's legislation would allocate \$80 billion to the IRS over the next decade, direct the agency to set audit rate goals for high-income individuals, corporations, and estates, and increase the penalties for tax noncompliance on taxpayers who earn more than \$2 million of taxable income."

## REP. SPANBERGER PROGRESS

As reported in the May-June 2021 Newsletter, Representative Abigail Davis Spanberger is definitely a friend of NARFE. She co-sponsored two bills that could be of great benefit to federal public servants. We thank her for her action. Getting the bills above the House Ways and Means Committee will take extraordinary effort. She co-sponsored H.R. 82 – The Social Security Fairness Act of 2021 on 1/4/21 and H.R. 2337 – Public Service Protection and Fairness Act of 2021 on 4/1/21.

When the above bills get 290 sponsors, House rules grant a floor vote. H.R.82 has 167 co-sponsors sponsors and H.R. 2337 has 160. What we need to do is call Ms. Spanberger and ask her to suggest to her colleagues to co-sponsor and eventually vote for passage of both bills.

# LEGISLATIVE TRAINING CONFERENCE

Between June 21 and 23 I will attend NARFE's virtual Legislative Conference called LEGcon21. From what I see in the training videos it looks like they have all aspects of technology covered. This training is a great

leap from the in-person conferences that I have attended since 2013 in the Washington D.C. area. Instead of a crowded room of inquisitive minds at a hotel, you attend with your computer at your home office or living room. This will be very similar to our chapter ZOOM meetings.

On Tuesday I expect to see Representative Spanberger remark on her progress in the House of Representatives to her constituents, federal employees and retirees and members of NARFE.

What will come up at the conference will be NARFE's request to congress for the improvement of our benefits. Items of interest will be the key concerns of NARFE. The first key includes two bills: H.R. 82 – Social Security Fairness Act of 2021. This bill repeals provisions that reduced benefits for retired federal CSRS employees who are receiving Social Security. The second bill will be H.R. 2337 – Public Servants Protection and Fairness Act of 2021. This bill establishes an alternative formula to calculate Social Security retirement benefits for those who receive pensions for certain non-covered employment. Take note that Representative Spanberger sponsored both bills.

The second key point is Federal Employee Health Benefits (FEHB). Premiums could rise if the Postal Reform Act of 2021 is passed. H.R. 3076 and S.1720 moves most postal workers into a new Postal Service Health Benefits program. The new program would leave postal retirees without Medicare. Those costs would be moved into FEHB in which non-postal workers presently are a part of. The most costly to insure - those without Medicare - would apparently be a financial burden to retired non-postal retirees. NARFE is against passage of this bill.

The third key point for discussion will be to have congress support a bill for a more accurate cost of living adjustment for annuities and Social Security. Presently the cost of living for retirees does not reflect our actual cost of living for seniors. Let your representative or senator know what you think about this proposed bill.

# VIRGINIA REAL ID UPDATE

The following update was published in late April and we wanted to make sure that anyone interested in getting the Real ID knows that they have been given an extension of time.

"VIRGINIA — U.S. residents will have an additional 19 months to get their REAL ID after the Department of Homeland Security delayed the requirement for air travelers to have a REAL ID-compliant form of identification by Oct. 1. The deadline has been postponed until May 3, 2023, for Virginia and all other states."

# **Getting Back to NORMAL?**

Why getting back to normal may seem terrifying. "After a year of anxiety, anger, and burnout, many people are struggling with returning to pre-pandemic behaviors." Does this sound familiar?

Some call it "the fourth wave" of the COVID-19 pandemic. Mental health impact can be profound and far-reaching, likely outlasting the physical health impact. As restrictions are lifting, many people are feeling the lingering psychological effects from what has been a collective traumatic experience.

The pandemic produced a great many unexpected factors that could lead to emotional health problems: anxiety, brain fog, depression, and PTSD. Symptoms of fatigue, exhaustion, and burnout are common, and stress can have a long-lasting effect on brain function. As things come back to normal, most people rebound as they lose their fear of infection; however, a sizeable minority may confront new or long-term mental health issues.

Researchers have reported that people are sleeping poorly and/or forming unhealthy habits. Do not fall victim to this. Our Chapter recently hosted an inperson meeting. We gathered outside but I wish I could have bottled up all those smiles and laughs. It is proof that people who manage to keep strong social connections are less likely to show negative, depressive attitudes.

We all know that mental health holds a stigma in our society. For my purposes I am talking about brain health, not mental health. I want people to begin to remind themselves that the brain is actually an organ,

just like your heart. Brain health is greatly dependent on attitude, sleep, exercise, nutrition, and fellowship.

# Alzheimer's Legislation

Alzheimer's Advocates lobby at U.S. Congress. More than 6 million Americans are living with Alzheimer's disease, including 150,000 in Virginia in addition to their 349,000 caregivers. As an Alzheimer's advocate and a former caregiver for my father who died in 2008, I feel the need to speak out.

Without medical breakthroughs, the number of Americans struggling with Alzheimer's is projected to rise to nearly 13 million by 2050, more than two times the current number. Compare this to decreases in some cancers and other serious diseases, and this trend is even more alarming.

Recently, my U.S. Representative Donald McEachin, D-4th met with some of his constituents to explain why Congress must continue to prioritize legislative action against Alzheimer's. Specifically, he was asked:

- Cosponsor the Comprehensive Care for Alzheimer's Act, SB 1125 and HR 2517.
- Cosponsor the ENACT Act (SB 1548 and HR 3085) which seeks to increase representation in Alzheimer's clinical trials among traditional underrepresented groups.
- Support a \$289 Million increase for Alzheimer's research at the NIH to attempt to slow, stop or cure the disease.
- Cosponsor the bipartisan Alzheimer's Caregivers Support Act (SB 56 and HR 1474) to expand training and support services for families and caregivers of those with Alzheimer's.

Please reach out to Rep. McEachin and any other legislator to let them know how important you think it is to invest in policies that address the critical national public health challenge that this disease poses.
