Have you had your vaccine? As of April 12, 2021 there have been 4,768,777 doses of the vaccine administered. That represents 36.6% of the population in Virginia and an average of 75,000 doses per day.

Who gave these vaccines? The local health departments put 1.4 million shots in arms. Closely following are pharmacies which recorded 1.2 million doses; hospitals administered nearly a million; medical practices 700,000 and other providers provided 500,000 doses.

What type of vaccines?

- **Pfizer** 2,200,000 doses
- **Moderna** 2,037,500 doses
- Johnson & Johnson 236,000 doses

Ask your lawmakers to Cosponsor NARFE's Centennial Resolution. Reps. Gerry Connolly, D-VA and Brian Fitzpartick, R-PA, introduced a resolution in the House, H. Res. 131, to recognize this extraordinary achievement. Senate passes via unanimous consent, S. Res. 76, congratulating NARFE on the celebration of its 100th Anniversary on February 19, 2021.

NATIONAL LEGISLATION

US Postal Service Legislation H.R. 695/S. 145 USPS Fairness Act

These bills repeal the requirement in the Postal Accountability and Enhancement Act (PAEA) of 2006 for USPS to pre-fund USPS employee pensions more than fifty years in advance. This requirement has caused the USPS to accumulate billions in debt annually in recent years.^[3] If the USPS Fairness Act were passed, the USPS could still continue to pay

benefits from the accumulated funding (about \$56.8 billion in 2020) until depleted, but the intended purpose of the Act is to remove the pre-funding requirements placed on the agency by the PAEA.

PAEA was the first major overhaul of the <u>United States</u> <u>Postal Service</u> (USPS) since 1970.^[5] It reorganized the <u>Postal Rate Commission</u>, compelled the USPS to pay in advance for the health and retirement benefits of all of its employees for at least 50 years,^[4] and stipulated that the price of postage could not increase faster than the rate of inflation.^{[6][7]} It also mandated the USPS to deliver six days of the week.^[8] According to Tom Davis, the Bush administration threatened to <u>veto</u> the legislation unless they added the provision regarding funding the employee benefits in advance with the objective of using that money to reduce the federal deficit.^[2]

Between 2007 and 2016, the USPS lost \$62.4 billion; the <u>inspector general</u> of the USPS estimated that \$54.8 billion of that was due to prefunding retiree benefits.^[10] By the end of 2019, the USPS had \$160.9 billion in debt, due to growth of the Internet, the <u>Great Recession</u>, and prepaying for employee benefits as stipulated in PAEA.^[11] Mail volume decreased from 97 billion to 68 billion items from 2006 to 2012. The employee benefits cost the USPS about \$5.5 billion per year;^[12] USPS began defaulting on this payment in 2012.^[10] The <u>COVID-19 pandemic</u> further reduced income due to decreased demand in 2020.^[11] The latest quarterly financials of the USPS do not suggest the <u>COVID-19 pandemic</u> further reduced income due to decreased demand in 2020.

Lawmakers <u>gave USPS a \$10 billion loan in the</u> <u>CARES Act</u>, which Congress then turned into a onetime appropriation under its latest COVID-19 pandemic spending package.

Because of this, USPS has more cash on hand than it's ever had in recent years. <u>It ended 2020 with more than</u> <u>\$14 billion in cash</u>, but USPS executives warn it's still a matter of when — not if — the agency will run out of cash.

Mike Plunkett, the president and CEO of the Association for Postal Commerce, said USPS should have enough cash to keep operating through at least 2023, but warned it would be unwise for Congress to continue to delay action on postal reform until the last minute.

H.R. 2382 (An earlier version of the Fairness Act) passed the House in the 116th Congress, but died in the Senate.

H.R. 695 has been referred to the House Committee on Oversight and Reform and S. 195 has been referred to the Senate Committee on Homeland Security and Governmental Affairs.

SPANBERGER PROGRESS

Representative Abigail Spanberger recently cosponsored two bills that could be beneficial to a number of federal retirees. Most of it has to do with previous Social Security reductions or offsets from CSRS annuitants who didn't contribute to Social Security up to 1983; however, may have paid Social Security while working in private employment prior or in tandem to working for the federal government.

On January 4, 2021, H.R 82 - Social Security Fairness Act of 2021 was introduced by Rep. Rodney Davis (R-IL-13) and Rep. Abigail Spanberger was the first to cosponsor the bill. Three of ten remaining Virginia representatives also cosponsored. The bill as of April 12 has 127 cosponsors. This bill when enacted will fully repeal both the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO). The Fairness Act bill eliminates the government pension offset, which reduces Social Security survivors' benefits for spouses, widows, and widowers. Elimination of the WEP will more fairly distribute average monthly earnings times a higher percentage formula which may increase monthly benefits.

On April 1, H.R. 2327 Rep. Spanberger cosponsored a bill introduced by Rep. Richard Neal (D-MA-1) – 'To amend title II of the Social Security Act to provide an equitable Social Security formula for individuals with non-covered employment and to provide relief for individuals currently affected by the Windfall Elimination Provision.' Two other Virginia congressmen cosponsored the bill. This bill has 139 cosponsors. (Sponsorship – House rules grant a floor vote when a bill reaches 290 cosponsors.)

Both bills were sent to the House Committee on Ways and Means for review.

Also, the April edition of NARFE Magazine on page 6 discusses the Bill to Repeal WEP and GPO reintroduced in House. This article sums up a little history on WEP/GPO and its impact on retirees.

NARFE's ADVOCY POSITIONS

It is worthwhile for all members to take a look at NARFE's Advocacy positions for the 117TH Congress (2021-2022). They are well noted in great detail in the NARFE website NARFE.org/advocacy. Headlines such as Retirement, Federal Pay and Workforce Policies, Health Care and U.S. Postal Service Reform are broken down into many paragraphs of specific interests. The position papers further check the areas NARFE supports and which items require legislation. The Advocacy Positions stated are easy to read; the four pages should not take up too much of your time – however it will be worth your time. If you require further study, various NARFE position papers and Issue Briefs are available on the Advocacy portion of the website for an explanation in greater detail.

THE FAIR ACT

H.R. 392 – Federal Adjustment of Income Rates – The Fair Act proposes a 3.2 percent pay increase for federal employees in 2022. Please note that retirees are not included in this act. The bill consists of a 2.2 percent across the board increase and an average 1 percent locality pay adjustment. The Federal Salary Council's most recent data indicates that federal employees make 23 percent less on average than their private-sector counterparts.

Visit NARFE's Legislative Center at <u>www.NARFE.org</u> to ask your Representative to sponsor the Bill. Thus far by April 15, 2021, four of eleven Virginia Representatives show support for this bill. Please write Reps. Spanberger, McEachin and Scott for your support.

VIRGINIA REAL ID UPDATE Deborah Fisk

The new enforcement deadline means that, beginning October 1, 2021, Virginians who want to use their state-issued driver's license or **identification** card to board a domestic flight will have to present a **REAL ID**-compliant credential, displaying a small star in the upper-right corner, when passing through Transportation Security Administration screenings. Several other forms of ID, including a U.S. Passport, a Passport Card, and some military IDs, will also be accepted for federal identification.

REAL ID also impacts access to secure federal facilities and military bases. Because these facilities have the ability to set their own entry requirements,

DMV advises Virginians to verify the identification needed for access prior to their visit. In order to obtain a REAL ID, customers must visit DMV in person with certain documents which show proof of:

- Identity and Legal Presence (e.g., unexpired U.S. passport, U.S. birth certificate or unexpired permanent resident card).
- Social Security Number (e.g., Social Security card or W-2 form displaying full nine digits).
- Residency two proofs required and must display name and current Virginia residential street address (e.g., recent utility bills, mortgage statements, valid Virginia driver's license); and
- Any name changes (e.g., marriage certificates or divorce decrees). Note: If the name on your identity document is different than your legal name, you must show proof of your name change. Multiple documents may be necessary if your name has changed more than once.
