## NATIONAL LEGISLATION

#### Fair COLA for Seniors

On July 1, Rep. John Garamendi, D-CA, reintroduced the Fair COLA for Seniors Act, H.R. 4315, which would change the basis of the cost-of-living adjustment (COLA) calculation from the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) to the Consumer Price Index for the Elderly (CPI-E). It has been referred to the Committee on Ways and Means, and in addition to the Committees on Veterans' Affairs, Oversight and Reform, and Armed Services.

The CPI-W considers spending habits of younger workers who are more likely to spend their dollars on electronic devices and consumer goods. Seniors are more likely to spend money on medical services and housing expenses. The prices of these items rise significantly higher than what the CPI-W calculates.

Previous versions of this proposed legislation have been considered by the House of Representatives since at least 2016 (114<sup>th</sup> Congress) but have died in committee.

## **CONGRESSIONAL UPDATES**

#### **REP. SPANBERGER PROGRESS**

Bills requested to congress for passage often take a long and arduous journey. When our member of congress supports us by sponsoring a bill – it doesn't mean that it will suddenly become law. Before the bill arrives for a vote it has to go through various committees such as Ways and Means – can it be supported financially etc.

Then it usually is not voted upon unless there are enough votes by the members to pass the bill. If it is approved – it goes to the senate for a similar process. Once agreed by both legislative bodies it will be submitted to the President for approval or be vetoed.

Recently I wrote Representative Spanberger in regard to her progress on specific NARFE priorities. Two of the five priorities have already been addressed by the congresswoman. As reported in the previous newsletter, HR 82 – Social Security Fairness Act; and HR 2337 – Public Servants Protection and Fairness Act bills have been cosponsored.

Additionally, I have requested her to cosponsor additional bills in the hopper. I requested action for the HR 3076 - Postal Service Reform Act of 2021. This bill may require an amendment since NARFE was concerned about its impact as written. The bills approval as written may drive up the cost of health insurance because it does not require Medicare for Postal employees. Details need to be worked out before a final sponsorship request.

The other bill, HR 4315 - Equal COLA for Seniors Act also requires sponsorships. If this bill gets traction, it will change the way Social Security is calculated. Ask your congressman to vote to switch to CPI-E which better reflects cost of living expenses for retired people. The CPI-W for urban wage earners and clerical staff, presently used, is not sufficient, especially with projected cost rises and apparent inflation. I will continue to keep an eye on progress that is achieved by Representatives Spanberger, McEachin and Scott. Thus far, they all have a very good record in supporting NARFE priorities. There are many more issues to consider in addition to the bills previously noted. Patience and persistence is required to move forward. Meanwhile you are challenged to get in touch with your congressman to tell your story and your particular needs. They are waiting to hear from you.

# Biogen's Alzheimer's drug has been the subject of much controversy.

#### July 9, 2021

The head of the Food and Drug Administration asked the agency's watchdog on Friday to determine if any interactions between a biotechnology company and FDA officials were inappropriate in the review process for an Alzheimer's drug that has been the subject of controversy.

Acting FDA Commissioner Dr. Janet Woodcock sent a letter to the acting Health and Human Services Department inspector general following several controversies surrounding the review process for Biogen's drug Aduhelm that was approved on June 7. This was FDA's first approval for an Alzheimer's treatment since 2003. The drug was given "accelerated approval," which is expedited approval for an unmet medical need, against advice from FDA's own advisory committee in November and other medical experts.

"As you know there has been significant attention and controversy surrounding the process for review for Biogen's biologics license application," which "includes an ongoing focus on interactions between Biogen and [FDA] staff during the review process," Woodcock wrote. Therefore, she asked for an independent review of the interactions between agency and Biogen staff during the process "to determine whether any of those interactions were inconsistent with FDA policies and procedures."

Woodcock said she has great confidence in the "integrity of the staff and leadership" at the agency's Center for Drug Evaluation and Research that were involved; however, she noted there have been concerns raised about communications that possibly happened "outside the formal correspondence process." She said the agency will fully cooperate should the IG take up the probe, which she said she would like to happen "as soon as possible."

HHS IG Spokesperson Tesia Williams said in a statement, "We received the letter and are reviewing it for appropriate action. We do not have any further comments at this time."

A Biogen spokesperson said, "We will, of course, cooperate with any inquiry in connection with a possible review of the regulatory process."

According to *Stat News*, it's "rare" for an IG to probe the FDA and even more so for it to look at a specific drug approval.

"Earlier calls for an OIG investigation have focused on the close relationship between Billy Dunn, head of the FDA's neuroscience division, and Biogen executives," said *Stat's* report. "Biogen had an off-the-books meeting with Dunn in May 2019, enlisting his support for the treatment that would become Aduhelm. A month later, Dunn and his FDA colleagues proposed using a regulatory shortcut called accelerated approval to get the drug approved, contradicting the agency's claim that it raised that option only this past March. The FDA was so supportive of Aduhelm that, even in 2019, some inside Biogen believed its approval was inevitable."

The letter comes a day after the FDA limited its recommendation on who should receive the drug. "This is a welcome step and addresses one of many problems with this drug approval," tweeted Dr. Aaron Kesselheim, professor of medicine at Harvard Medical School. "But the FDA/Biogen should be doing much more now to help patients by actively combatting misperceptions about this drug." He was one of three advisory committee members to resign in wake of the FDA's approval of Aduhelm.

Last month, the top lawmakers on the House Oversight and Reform Committee and Energy and Commerce Committee launched an investigation into the approval as well as the pricing of the drug.

"We have serious concerns about the steep price of Biogen's new Alzheimer's drug Aduhelm and the process that led to its approval despite questions about the drug's clinical benefit," they said in a statement on June 25. "We strongly support innovative treatments to help the millions of Americans who suffer from Alzheimer's disease, but Aduhelm's approval and its \$56,000 annual price tag will have broader implications for seniors, providers and taxpayers that warrant close examination."

#### July 12, 2021

This message is sent to all Alzheimer's Association and Alzheimer's Impact Movement board members, all Alzheimer's Association staff, Zenith Society members and volunteers and supporters of AIM and the Alzheimer's Association.

As you know, the Alzheimer's Association has advocated strongly for approval of aducanumab, now called Aduhelm, which received accelerated approval from the Food and Drug Administration (FDA) on June 7. This treatment, while not a cure, has the potential to give more time to those with Mild Cognitive Impairment (MCI) due to Alzheimer's or those with early stage Alzheimer's dementia.

Thanks to your strong support of our work in so many ways, this is the first treatment ever to achieve such approval to address Alzheimer's disease itself, not just the symptoms.

Since I last communicated with you about the approval, much has happened. The FDA has now clarified the people who would likely benefit from this new treatment. It is the same group I described above and the group that the Alzheimer's Association has advocated to have access to this treatment throughout the approval process.

Achieving access to treatment for those who would likely benefit is now our focus.

Regrettably, Biogen, the company that developed Aduhelm, priced it at \$56,000 annually. That is simply unacceptable. The Alzheimer's Association continues to call on the company to change that price. To fail to do so would deny access for many who could benefit.

To achieve access for this treatment, and other treatments that will one day follow, the Alzheimer's Association is committed to working with the Centers for Medicare & Medicaid Services (CMS), as well as health insurance companies and others in the private payer community, to expedite coverage and access.

You might have also heard that there have been multiple calls for investigation of the approval process for Aduhelm. The Alzheimer's Association strongly

We firmly believe that the FDA's accelerated approval was the right decision, given the publicly available science, especially for such a devastating and fatal disease — one that otherwise has no treatment to even slow it down. Having the availability of such an option and access to it are needs we've long heard from the patient and caregiver community that we serve.

You can be assured that the Alzheimer's Association will continue to advocate for coverage of this now approved treatment for everyone who is likely to benefit.

Thank you so much for all of your support to make it possible to improve the lives of so many others!
