## **NATIONAL LEGISLATION**

### **Postal Service Reform Act of 2022 Passes House with Bipartisan Support**

On February 8, the House of Representatives voted on long-sought-after postal reform, passing the NARFE-supported version of the Postal Service Reform Act of 2022, H.R. 3076, with strong bipartisan support, 342-92.

The legislation gained NARFE's support after it was amended to address our concerns. In particular, changes were made to prevent unintended increases to Federal Employees Health Benefits (FEHB) program premiums for federal employees and retirees. And unlike past iterations of postal reform, this bill preserves choice for current postal retirees regarding whether or not to enroll in Medicare Part B.

NARFE is also pleased with included provisions to repeal the burdensome mandate to prefund future postal retiree health benefits and the bill's codification of mail delivery at six days per week.

H.R. 3076 will provide financial relief to the Postal Service that will improve the agency's ability to remain a public entity providing a crucial service to the American people while simultaneously protecting the earned health benefits of postal and federal workers and retirees. The bill creates a new, parallel Postal Service Health Benefits (PSHB) program that is required to have the same benefits and cost-sharing requirements as the health plans offered through FEHB. The bill is also expected to provide cost savings for FEHB, as the FEHB risk pool will become cheaper to insure.

The Postal Service Reform Act of 2022 now awaits Senate consideration. Senate Majority Leader Chuck

Schumer planned to bring the bill to the floor for a vote this week, but his efforts hit a procedural snag after the House clerk sent an incorrect version of the bill to the Senate. While the House quickly corrected the error via unanimous consent last Friday, Senator Rick Scott, R-FL, objected to expedited consideration of the new bill on Monday. While Leader Schumer vowed to bring the bill to the floor for a vote and pass it, it's unclear whether that will occur before the Senate leaves town for two weeks.

"Unfortunately, there are pieces of this bill that blocks the opportunity for us to achieve our shared goal of responsibly reforming the Postal Service. ... I want the Senate to have the opportunity to work on this and improve it and deliver a bill that works," Senator Scott said, noting that he supported some provisions in the bill.

"We can't afford to add stress on our already enormous national debt with poor financial planning, which I think this bill absolutely does," Scott added.

Schumer then pulled the vote. Democrats started the process on Monday of putting the corrected legislation on the Senate calendar, which will let Schumer tee it up for a vote.

## **STATE LEGISLATION**

Here is some information on two of the NARFE State Legislative proposals. These legislative actions themselves show that progress is being made and emphasize the importance of NARFE members contacting our state legislative representatives to support those and other items in our state legislative plan.

1. We support Minimum Nursing Home Standards. A House of Delegates bill (HB 646) was introduced establishing hourly staffing minimum nursing

home standards of 2.8 hours for nurse aides (CAN) per resident per day, 1.3 hours for registered nurses (RN) and licensed practical nurses (LPN) combined per resident per day, 0.75 hours for RNs per resident per day, and for a combined total of 4.1 hours of nursing care per resident per day-including RN, LPN and CAN. As of February 8, a House subcommittee had recommended continuing this bill to 2023.

2. We support a Family Caregiver Tax Credit. A House bill (HB291) was introduced creating a 2022-2036 nonrefundable income tax credit equaling 50 percent of eligible expenses up to \$1,000 incurred by an individual in caring for an eligible family member who requires assistance with one or more activities of daily living. To qualify, the caregiver must not receive any compensation for the eligible expenditures and have a federal adjusted gross income not greater than \$100,000 for an individual or \$200,000 for married persons. The bill required the Tax Commissioner to establish guidelines and provided that any unused credit may not be carried forward by the taxpayer for five taxable years following the taxable year for which credit was issued. As of January 26, this bill had been referred to the Committee on Appropriations.

## **CONGRESSIONAL UPDATES**

### **Bill Tracking**

The 117th Congress is scheduled to return to work on January 10, 2022. They have approximately one year to complete NARFE's legislative priorities. The priorities are Postal Reform, Federal Annuities, DC Statehood, NARFE Centennial, Federal Personnel Policy, Federal Compensation and GPO/WEO. The above priority areas encompass thirteen bills that NARFE is presently tracking. Of the 13 bills only one – H.R. 3076, the Postal Service Reform Act is not favored in its present form. All Postal employees and retirees would be moved to the new Postal Service Health Benefits (PSHB) program, except Medicare

eligible postal employees who do not enroll in Medicare. This bill risks increasing premiums for federal employees and retirees enrolled in Federal Employee Health Benefits (FEHB) program plans. For a total explanation of all thirteen bills currently in congress and the senate, review the NARFE Bill Tracker in the January/February 2022 issue of NARFE Magazine. Check the current sponsors of the above bills to see if your representative or senator has supported twelve of the thirteen bills that NARFE is advocating for you. The congressional web site has the current status of all bills and their sponsors in the House and Senate. Also, the NARFE.org website has been upgraded – it is aesthetically appealing and the format makes it easier to review items of interest.

### **The 7th Congressional District**

According 2020 census results and the Virginia Supreme Court the latest plan submitted by the state for congressional representation changes the boundaries of Virginia's eleven congressional districts. The 7<sup>th</sup> district has been moved further north to as far as Prince William County. Many of us in the present 7<sup>th</sup> district may be moved into the new 1<sup>st</sup> and the rearranged 4<sup>th</sup> district. For example, if you live in Brandermill a definitive map has not been published to define the edges of the proposed districts. Therefore, we will have to wait until more information is provided. Abigail Spanberger, the current 7<sup>th</sup> District representative will run for reelection this fall in the new 7<sup>th</sup> district. A boundary map was published in the Richmond Times-Dispatch in late December 2021; however, it did not identify boundaries such as streets, creeks, or rivers. Hopefully, we will have an answer by Election Day.

Since we will lose Representative Spanberger to another area of the state, she appears to be voting for our priorities until the end of her term in the 117<sup>th</sup> Congress. She is a good friend of NARFE and we thank her for her advocacy.

## **Are you Confused about Re-Districting?**

The long-awaited redistricting saga is almost complete. It took a vote, waiting for the delayed census, a bipartisan redistricting commission who failed to accomplish their work, and finally the Virginia Supreme Court had to intervene. Now sorting out who will run and where they will run will unfold. We await a pending lawsuit to see if there will be a special election in November 2022 for House Delegates in districts that were changed since the redistricting was originally supposed to be completed in time for the November 2021 elections. The Court could determine that an extra election is necessary or not necessary. We will wait and see. What a puzzle this has been.

General consensus from every source I have read seems to think this process was as fair as possible. The Court unanimously found that in preparing the Final Redistricting Maps, the Special Master followed the Court's instructions and fully complied with federal and state law in their proposal.

The redistricting plans were approved on December 28 by the Virginia Supreme Court after the state's bipartisan redistricting commission was unable to reach agreement on maps earlier this year. The court said it did not take into account the residences of incumbents. Representatives do not have to reside in the district they represent.

The new maps are effective immediately. The two map drawers – Bernard Grofman, a Democrat, and Sean Trende, a Republican both stated in a memo filed with the court that the three maps they recreated for Virginia reflect “a true joint effort” between the two. They agreed on almost all issues initially, and the few issues on which they initially disagreed were resolved by amicable discussion.

The first full election will be in effect for the 2023 elections for both the 100-member House and the 40-member Senate. Now that is all I know in a “nutshell.”

What does that mean for members of Chapter 2265? If you were in the 7<sup>th</sup> District, Congresswoman Abigail Spanberger, you have probably been moved to District 4 (Congressman Donald McEachin) or District 1 (Congressman Rob Wittman) or District 5 (Congressman Bob Good). It appears that our Chapter members will be mostly distributed between Districts 1 and 4 going forward.

If you need any help figuring any of this out, please reach out and I will do my best. And that folks is a wrap for a very long, drawn out slice of Virginia history at its finest.

## Update on Congressman McEachin

Throughout 2021, Congressman A. Donald McEachin, 4<sup>th</sup> District Representative, and his staff have been

working to serve us – the people of Virginia’s Fourth Congressional District – and ensure that our interests are being advocated for and represented in Washington. As January 2022 approaches, 117<sup>th</sup> Congress comes to a close, I would like to take this opportunity to present all that was accomplished in 2021.

### Milestones and Accomplishments from 2021

1. Support of the “Build Back Better Act”. Disappointed in Senator Manchin’s announcement that he intends to discontinue good-faith negotiations with his Senate colleagues and the White House. This legislation would make a meaningful difference in the lives of all Americans, including those in West Virginia, and would ensure expanded Medicare benefits, lower prescription drug prices, unparalleled investments in clean energy and environmental justice priorities, and so much more.
2. Support of “the Lead Pipe and Paint Action Plan” that will help supplement and bolster investments made in the Bipartisan Infrastructure Law to replace lead-ridden pipes and remediate lead-based paint. Jobs and better health for Virginians.
3. Delivered approximately \$217 million in tax cuts for more than 84,000 hardworking families in Virginia’s 4<sup>th</sup> Congressional District through expanded Child Tax Credit. This has had monumental impact on more than 4 million children who have been lifted out of poverty.
4. Secured a grant from the Department of Health and Human Services to the Virginia Department of Health for home health care visits for \$1,763,968. Home health care visits are essential to many homebound individuals, especially as they recover from the coronavirus pandemic.
5. Verbally opposed Governor-elect Glenn Youngkin’s announcement that he plans to withdraw Virginia from the Regional Greenhouse Gas Initiative. This will significantly reduce revenue for the Commonwealth and slow our efforts to mitigate climate change while further disenfranchising historically underserved communities.

6. Helped pass the bipartisan, bicameral “National Defense Authorization Act” for Fiscal Year 2022 and secure key priorities in the legislation. This crucial piece of legislation supports American servicemembers and their families, protects our national security interests, and invests in our nation’s defense systems.
7. Secured funding for all ten of the Community Project Funding requests. These include projects in Prince George County Central Water System, Surry Water Systems Upgrade, Petersburg Sewer Service Upgrades, Charles City County District Three Broadband Fiber Connectivity, Hopewell’s Cattail Creek Crossing Project, Historic Village at Dismal Swamp, Ettrick Train Station, RTR Teach Residency Early Childhood Pathway at VCU, An Achievable Dream Certified Academy at Highland Springs Elementary School, and VCU’s RVA Gun Violence Prevention Framework.

opportunities beyond 2022 and allows NARFE to steer the conversation about our benefits in the face of the midterm elections.

### **What is FEDHub?**

I am excited to share with you a very new platform that NATIONAL has implemented to keep us in touch with NARFE members across the country. It is a community designed just for us. You join the group, you setup your profile and you are asked to adhere to a few very basic rules about user etiquette. Log into your NARFE.org portal and there is a menu selection for FEDHub.

I am amazed at some of the topics of discussion that I have found. One thing for certain, we may all be different but when it comes to protecting our hard-earned federal benefits there is a commonality.

There was a conversation the other day about "Is NARFE structure still relevant?". How many times have we engaged in discussions about what is to become of Chapter as we know it today? There is a reference to a book by Tom Friedman, *The World is Flat* first published in 2005 with two subsequent editions. Friedman argues that the world has become flat due to globalization which is in turn fueled by changes in technology. So many of us can relate to that after the last 18-months.

Consider that the IBM personal computer was introduced in 1981, NARFE membership peaked in 1982 at 500K, the internet started to become popular in 1991 with the introduction of the Netscape browser, and the iPhone (smartphone) was introduced in 2007. These technological advances "flattened" hierarchical organization making communications within and between organizations much easier. I cannot begin to imagine the impact that FEDHub is going to have on the future of NARFE.

I have long believed that the decline in membership and finding volunteers in civic organizations was due, in part, to the rise of technology including the internet. People have begun to think that they can find solutions on the internet, software applications and smart devices. It seems we have lost our appreciation for



fellowship and the satisfaction we can find as we interact with like-minded adults.

It is true, membership in NARFE continues to decline. We have quickly reduced that 500K membership base down to 158K in thirty-plus years. I do not have a solution to the organizational issues, I wish I did. Membership in Chapters is declining but membership in National Only is increasing by only small percentages. It is increasingly difficult to find volunteers to serve in leadership positions from the Chapter level. In talking to some National Only members, they see Chapters as more directed to social purposes and they have no interest or time for that. However, I do believe that NARFE serves a purpose and I strongly recommend it to all Federal active and retirees.

The 2014 Future of NARFE Committee report provided a blueprint for NARFE reorganization. However, it was met with limited success. Some recommendations were approved by the membership including reducing national officers from four to two and providing for optional chapter membership. But that may not have been enough.

2022 may be a good year to launch an updated reorganization study. I am encouraged by the FEDHub platform which gives us an opportunity to interact with like-minded federal employees and retirees. We can stay in touch and with time bring NARFE into the 21<sup>st</sup> century by providing relevant information directly to members and make these resources easily available on the website by keeping information current.

My thought is that we can have the best of both worlds. There is a human interest in the social aspects of Chapters, but we have to continue to up our game in technology. I would like to begin a dialogue with our Chapter members to talk about what you need from our association. I know we can work together and make it happen.
