- Fresh fruits (oranges, apples, bananas, tomatoes, avocados, grapes, berries)
- Fresh vegetables (cucumbers, celery, peppers, lettuce, eggplant)
- Cooking Oil
- Cereal
- Canned tomato products (crushed, peeled, diced, etc.), 4oz − 1 lb
- Canned meat (chicken, turkey, or seafood), 2oz – 15oz

LEGISLATIVE REPORT

(As of Dec 14, 2022)

NATIONAL LEGISLATION- Lawmakers leading the negotiations on a bill to fund the federal government for the current fiscal year announced on December 13 that they had reached agreement on a "framework" that should allow them to complete work on the bill over the next week to avoid a government shutdown.

Congress faced a midnight December 16 deadline, the ending date of a stopgap funding measure, to pass a spending bill to prevent a partial government shutdown. Another short-term measure before then to keep the government running through December 23, allowing negotiators time to complete work on a full-year bill, was expected. (WTOP News)

Negotiators needed to agree on top-line spending numbers for an "omnibus" package. Senator Richard Shelby, R-Ala., vice chair of the Appropriations Committee, said the two parties were about \$26 billion apart on domestic spending. Democrats wanted parity between domestic and defense spending, but Shelby and other Republicans were pushing to pare back the domestic number because of billions in new spending Democrats passed in Covid relief and inflation reduction packages.

The government funding bill was likely to be the last train leaving that session of Congress, with a number of other provisions possibly riding along. Chief among them was a major overhaul of election laws, designed to prevent another Jan. 6 by making it harder for losing presidential candidates to claim victory. Asked if the election bill will get a vote on the Senate floor this year, Senate Majority Leader Chuck Schumer, D.-N.Y., said: "First job is to get an omnibus." (NBC NEWS) The final version of the annual DoD authorization measure provides a 4.6 percent pay raise for military personnel and assumes that civilian employees of DoD will receive the same amount. While that effectively is an endorsement of that figure for federal employees, the raise formally is determined through an administrative process. Congress was on track to allow an average 4.6 raise, with some variations by locality, to take effect by default since it had remained silent on the issue throughout the year. Dropped from the DoD authorization measure was House-passed language that would have changed the law so that a future administration could not issue an order similar to one issued by the Trump administration creating a new exceptive service known as "Schedule F," turning thousands of competitive service jobs involved with making or carrying out policy into political appointive positions. That development was a disappointment for federal employee organizations and Democratic sponsors of the language, since the House is considered unlikely to approve such a ban in the new Congress with Republicans in control. <u>VIRGINIA LEGISLATION-</u> The 2023 Virginia General Assembly session begins on January 11, 2023, and is scheduled to adjourn in late February. It is the 45-day "short session." The General Assembly will consider a myriad of issues, including amendments to the budget signed last year. Gov. Glenn Youngkin is proposing an additional \$350 million to prepare business-ready sites as Virginia vies with other states to lure industry. (Richmond Times-Dispatch)

WINTER DRIVING TIPS

- **1. Drive Super Smoothly -** The key to safe driving in snow is being smooth with the steering wheel, accelerator, and brakes. Why? Jerky movements with the controls easily unstick tires that have a tenuous grip.
- **2. Look Far Ahead -** Anticipate what you'll need to do next. Slow way down for turns. Allow double the stopping distance when the road is wet, triple on snow, and even more on ice. Driving carefully and safely takes extra concentration. Is there a uniform coating of powder, or bare spots interspersed with snow in the shade? Is the temperature cold enough to ensure crunchy, light, snow, or is it warm enough to create a slushy mess? In general, shiny is bad, since it means ice or water.
- **3. Heed the Flashing Lights** Understand what one small amber flashing light in the instrument cluster means. (It's an outline of a car with squiggly lines behind it.) If you're accelerating in a straight line and this light is blinking, this is the stability-control system warning you that the wheels that drive the car are slipping so slow down.
- **4. Use Your Anti-Lock Brakes -** If all else fails and you need to stop as quickly as possible in snow or on ice, push the brake pedal down hard, and don't let up. The Anti-Lock Brakes System will do the rest, keeping each wheel braking as aggressively as possible based on the available traction and the computer will adjust the braking force at each wheel to allow you to maneuver so keep steering.
- **5. Plan Ahead -** Check your route and the weather. For a long trip, plan your route around bad weather.
- **6. Carry the Right Supplies -** A snow shovel, kitty litter, salt and a tow strap can help get you unstuck. Many cars have a tow eye that screws into a threaded socket (usually behind a square plastic cover that pops out of the bumper) and can be used to attach a tow strap to vehicles that don't have a hitch or bumper-mounted tow hooks. The tow eye is usually under the rear cargo floor, with the spare tire. Warm clothes, flashlight, water and snacks can help during a prolonged problem.
