Legislative Corner By Ed Weiler

House Ways & Means Committee Derails the WEP-GPO Repeal Express

To all appearances, it began to seem--at long last--that success was at hand for NARFE and allied advocacy groups in the long slog to repeal both the Windfall Elimination Provision (WEP) and the Government Pension Offset (GP0). Over the course of the 117th Congress, they were able to garner 305 co-sponsors for a full-repeal bill (HR 82), a level well above the threshold needed to trigger a process in the House of Representatives that would have forced a floor vote. (A more detailed explanation of this process may be found on p. 9 of the Dec. '22 edition of NARFE Magazine).

Alas, no floor vote ever happened. In a Lucy-takes-away-the-football maneuver, Ways & Means on 9/21/22 held a perfunctory hearing, thereby removing *HR 82* from the floor-vote triggering process. Accordingly, the Committee reported the bill to the full House, "without recommendation." R.I.P., WEP-GPO repeal in the 117th Congress? Most likely, although not necessarily, since as of this writing (mid-Dec. '22), efforts continue on Capitol Hill to have WEP-GPO repeal included in the FY23 Omnibus spending bill. Check in with NARFE's website to see if this effort panned out.

Meanwhile, a pox on Ways & Means, right? But before we reduce the Committee's actions to a reductive good vs. evil morality tale, consider what underlying issues might have been in play here. Enter from the vault an article in the March 2010 edition of *NARFE Magazine* explaining why a WEP-GPO repeal bill (*HR* 235) failed to advance during the 111th Congress. Herewith the crux of this analysis, which is as relevant today as in 2010:

"Key lawmakers are reluctant to take up WEP and GPO bills unless they are considered as part of a comprehensive overhaul of Social Security. Working on one Social Security issue without addressing the entire program, particularly its long-term solvency, has been a non-starter for legislators. The Social Security Trustees reported last year that the program will be forced to reduce benefits to 75 cents on the dollar starting in 2037 unless Congress makes changes to the program."

Fast forward to 2022, where the most recent Trustee's Report states that, beginning in 2034, the program will be forced to reduce pay-outs to retirees to 77 cents on the dollar---and this analysis, of course, does not include additional pay-outs due to WEP-GPO repeal. The cost of full repeal, according to Ways & Means (*H.Rept. 117-482*) would be approximately \$195 billion over the period 2022-2032, thereby advancing the "exhaustion date" for the combined trust funds (Old Age and Disability) by six months (this latter figure provided by Social Security's Chief Actuary). *(continued on p. 3)*

At minimum, then, our legislators' concerns over the fiscal implications of WEP-GPO repeal are not without foundation. Nevertheless, real people---many of whom are NARFE members—continue to be hurt by the inequity of these provisions. Perhaps our only way out of the proverbial box is for Congress to finally take up Social Security reform during its 118th Session. The good news here is that Rep. Larson's *Social Security2100* bill (*HR 5723* in the 117th Congress), which most likely will be re-introduced in 2023, already includes the full repeal of WEP and GPO. The not-so-good news is that this bill attained **no** Republican co-sponsors during the 117th Congress. Keep checking the "advocacy" page on NARFE's website to see how you can help move ball forward in the 118th.
