Bob Sottile delivered 169 pounds of food for the chapter. Needed items include:

Food Items (no more than 3 years expired, unopened, labeled, not homemade):

- Fresh fruits (oranges, apples, bananas, tomatoes, avocados, grapes, berries)
- Fresh vegetables (cucumbers, celery, peppers, lettuce, eggplant)
- Cooking Oil
- Dry goods cereal, pasta, rice, (16oz packages), dried beans
- Canned vegetables tomatoes (crushed, peeled, diced, etc.), beans, corn, etc.)
- Canned meat (chicken, turkey, or seafood), 2oz 15oz
- Canned fruit (packed in fruit juice instead of syrup) 11oz 20oz
- Spaghetti sauce, 14oz 1 lb (ideally in cans or plastic instead of glass)
- Fruit juice (100% juice) 32oz 64oz

#### **LEGISLATIVE REPORT**

**NATIONAL LEGISLATION** - Washington is in another big fight over whether to raise or suspend the nation's debt limit, which caps the amount of money the federal government can borrow. The fight began in earnest on February 1, when President Biden and House Speaker Kevin McCarthy met at the White House to discuss the debt limit and other issues.

The United States borrows huge sums of money by selling Treasury bonds to investors across the globe and uses those funds to pay existing financial obligations, including military salaries, safety net benefits and interest on the national debt. Once the United States hit the current debt limit of \$31.381 trillion set by Congress on January 19, the Treasury Department began using "extraordinary measures" – suspending some investments and exchanging different types of debt—to try to stay beneath the cap as long as possible. That option could be exhausted by June. Responsibility for lifting or suspending the borrowing cap falls to Congress, which must get a simple majority in both the House and Senate to vote any change to the debt limit. Raising the debt limit has become a perennial fight, with Republican lawmakers using it as leverage to try to force spending cuts.

This year is shaping up to be the messiest in at least a decade. Republicans now control the House and have adopted new rules governing legislation that make it more difficult to raise the debt limit and strengthen Republican's ability to demand that any increase be accompanied by spending cuts. Senate Republicans have also insisted that increases to the debt limit should be tied to "structural spending reform."

The government could wind up defaulting on its debt if it is unable to make required payments to its bondholders. Economists and Wall Street analysts warn that such a scenario would be economically devastating and could plunge the globe into a financial crisis. (New York Times)

There are continuing negotiations. House Speaker McCarthy expressed optimism that both he and Biden can reach consensus. Republican Rep. Brian Fitzpatrick, co-chair of the House Problem Solvers Caucus, said on February 5 that GOP members of his bipartisan group were ready to break with their party leadership on some aspects of the debt ceiling negotiations, but remain committed to attaching some spending cuts. Democratic Rep. Josh Gottheimer, the caucus' other co-chair, pushed back on previous assertions of the White House that it would not negotiate on the debt ceiling. (CNN)

**VIRGINIA LEGISLATION** - February 7 marked the halfway point of Virginia's 2023 General Assembly Session, a date known as "crossover," where bills that don't pass either chamber effectively are done and bills that do pass are considered in the other chamber.

Fiery debates about abortion, voter access and other topics will likely lead to few changes in the law as the House of Delegates, with a 52-48 Republican majority and the Virginia Senate, with a 22-18 Democratic majority, cancel one another out. Measures similar to proposals backed by Republicans in the House of Delegates aimed at restricting access to the ballot box, limiting access to abortion at various cutoff points and cutting corporate and income tax rates have already been rejected in the Democratic controlled Virginia Senate. (Washington Post)

The House of Delegates and the Senate have adopted their budgets, and the battle is on over how to bridge a \$1 billion gulf between the two chambers. Senior leaders of the two parties will try to hash out a final agreement in a conference committee before the assembly's scheduled adjournment Feb. 25, knowing that Gov. Youngkin is waiting his turn with vetoes and proposed amendments. (Richmond Times-Dispatch)
