SECRETARY'S REPORT ON THE FEBRUARY 14TH MEETING - CHRIS GIESELER

The Chapter's Membership Meeting was held on February 14, 2023—Valentine's Day—at the Vienna Community Center. After the meeting was called to order at 1:10 pm by Chapter President Kathy Arpa, the Pledge of Allegiance was recited, birthdays were recognized (Dave Graf and Mark Arpa), and guests were recognized.



Our Second Vice President Jayne Seidman introduced the speaker, Ms. Maddy White (pictured here). She is the Deputy Director of Outreach for Congressman Gerald (Gerry) E. Connolly (D-VA). Ms. White described how the 11th Congressional District boundaries have changed as a result of redistricting. The district no longer includes Prince William County. It now comprises the portion of Fairfax County outside the Beltway. Demographically, there are 11,000 more voters in the Hunter Mill and Providence Supervisory Districts alone.

With control of the U.S. House of Representatives having shifted to the Republican Party for the 118th Congress, Rep. Connolly's assignments have changed. He is still on the House Committee on Oversight and Accountability (the Committee's new name), including the subcommittees on (1) Government Operations and the Federal Workforce, and (2) Cybersecurity, Information Technology and Government Innovation. He also serves on the House Intelligence Committee and on the

Committee on Foreign Affairs and two of its subcommittees, including the one on the Indo-Pacific region. Plus, Rep. Connolly is on the Select Committee on the Weaponization of the Federal Government.

Ms. White stated that the previous Congress had been very productive. Rep. Connolly had the most bills enacted in the 117th Congress. The Inflation Reduction Act and the various Appropriations Acts provided a lot of money for roads and, also for our area, funds for health and child development centers and mental health care funding. She also cited the First Responder Fair RETIRE Act, which Rep. Connolly sponsored. It was enacted and gives retired first responders the same benefits they would have received if they had not been injured on the job.



In Rep. Connolly's office, Ms. White works on IRS, OPM, Social Security, security clearance and passport issues. She can be reached at (703) 256-3071 or via email at Maddy.White@Mail.House.gov. For other issues when staff do not know the answer, they will take the issue to someone in an agency who can respond to the issue. The office no longer handles matters regarding the data centers in Prince William County since that county is no longer part of the 11th District. But they are getting more complaints on local issues, especially the Virginia Department of Transportation and traffic in the western part of Fairfax County. Regarding Metrorail, Rep. Connolly wants a Special Inspector General for Metro to improve its accountability by determining whether Metro's funds are being properly used. Ms. White also noted that the IRS still has a large backlog of prior year tax returns to process.

The upcoming Annual Meeting/Conference of the Virginia Federation of NARFE was discussed. The Conference will be held April 2-5, 2023 in Hampton, Virginia. (More information about the conference appears on the front page of this newsletter.) Members were encouraged to attend the Conference. A final call for convention supporters was made by Kathy.

Following a break, Kathy provided an interesting discussion of the history of Valentine's Day. Thereafter, reports were given by the Secretary, Treasurer, and the Chairs for Membership, Legislation, and Sunshine. (See updated reports elsewhere in this newsletter.) Kathy presented information about upcoming Chapter meetings and events as listed on Page 2 of this newsletter.

Treasurer Dave Graf presented the proposed Chapter Budget for this year. It was approved by the attendees. There was a discussion concerning the declining membership in NARFE, largely the result of the aging of current members and attracting fewer new members. Kathy discussed the types of NARFE memberships, specifically Lifetime memberships and dues withholding. Lifetime memberships allow members to pay a onetime dues payment, depending on their age, to NARFE. They still get invoiced by NARFE for the annual Chapter dues if they want to be a member of their local chapter. For everyone else, rather than receiving a dues renewal from NARFE, the dues can be withheld by OPM from a retiree's/survivor's monthly annuity. More information is in the NARFE Magazine, including the form needed to request Lifetime membership.

Kathy announced that the Chapter needs a Newsletter Editor. Please let Kathy know if you are interested. The Newsletter Team will assist the new editor. The 50/50 drawings for Alzheimer's Research were conducted by Margaret Murphy and raised \$42.25. Lastly, March Newsletter articles are due to Dave Graf by March 1. A motion was made and seconded and the meeting adjourned at 2:46 pm.

TREASURER'S REPORT – DAVE GRAF

Since the February Newsletter, the Chapter received \$145.88 for membership dues collected by NARFE's National Headquarters for January. Also, \$2.00 was contributed to the Coffee Fund at the February 14th Membership Meeting. The only expense was a \$311.50 payment for the annual per capita dues to the Virginia Federation of NARFE (VFN).

The 50/50 drawing for Alzheimer's Research raised \$42.25 at the February 14th Membership Meeting. These donations will be sent to the VFN Coordinator for the NARFE Alzheimer's Research Fund.

The Chapter Budget for Calendar Year 2023 (as approved by the Board of Directors at its January 26th meeting) was adopted by the members at the February 14th Membership Meeting. The budget funds the regular operation of the Chapter for this year. To encourage members of our Chapter to attend the VFN Convention in April, funding was included in the budget to reimburse some of the expenses of our members who attend.

MEMBERSHIP REPORT – JAYNE SEIDMAN

Total current Chapter membership is 179; total National members in the Chapter area is 143, for a Grand Total of 322 members. We welcome our new member, Cornelia Newbold. Our longtime member and former Chapter Officer Nancy Linn passed away in February. (See the Sunshine Report on Page 6 of this newsletter.).

LEGISLATION REPORTS

National Legislation – Daad Pierce

- On February 1st, Representative John Garamendi of California, reintroduced the Fair COLA for Seniors Act (H.R. 716). The bill would provide more accurate COLAs for federal retirees by calculating their COLAs using the Consumer Price Index for the Elderly (CPI-E), which better tracks the spending habits of seniors than the current methodology. National President William Shackelford expressed NARFE's support for the legislation with a letter of endorsement.
- On February 1st, the House passed the "Stopping Home Office Work's Unproductive Problems Act of 2023" or "SHOW UP Act of 2023" (H.R. 139), which had been introduced on January 9th. The bill would require each executive agency to reinstate the telework policies that were in place on December 31, 2019. Agencies would not be able to implement expanded telework policies unless the Office of Personnel Management certifies that such policies, among other requirements, would have a positive effect on the agency's mission and operational costs. The bill has now gone to the Senate for consideration.
- On February 7th, Representative Don Beyer of Virginia and Senator Brian Schatz of Hawaii reintroduced the Comprehensive Paid Leave for Federal Employees Act (H.R. 856/S. 274). The bipartisan bill would expand paid leave options for the federal workforce. NARFE endorsed the legislation and will push for its advancement in the House and Senate.
- On February 8th, Representative Gerry Connolly of Virginia reintroduced the Equal COLA Act. The legislation would standardize the annual increase in annuity payments for retirees across the two retirement systems (FERS and CSR).
- On February 14th, Representative Gerry Connolly of Virginia and Senator Tim Kaine of Virginia, introduced the Saving the Civil Service Act (H.R. 1002/S. 399) in the House and Senate, respectively. This legislation marks the latest attempt by lawmakers to prevent the return of Schedule F, a statutory loophole created by the previous administration. NARFE has encouraged members to call on their lawmakers to cosponsor the bills.
- On February 21st Democratic State Senator Jennifer McClellan won the Virginia special election to fill the vacant House seat for the 4th Congressional District (Richmond area).
- On February 27th, the Office of Management and Budget issued a guidance memorandum (M-23-13) requiring Federal agencies to remove TikTok from their government-owned devices, subject to certain exceptions (law enforcement, research, etc.). This memorandum implements the "No TikTok on Government Devices Act" which was passed by Congress in December 2022. Agencies have 30 days to comply.

• On March 1st, Senator Sherrod Brown introduced a bill to repeal the Government Pension Offset and Windfall Elimination Provisions of current law (S.597). This is a companion bill to H.R. 82 in the House.

Virginia Legislation – Chris Gieseler

The Virginia General Assembly ended its 2023 legislative session on Saturday, February 25th. As of this report, lawmakers are only saying that budget negotiations are ongoing. There is no news yet regarding a special session that would be required to vote on and pass additional budget amendments. Described below are certain significant bills passed by the General Assembly during its 45-day session.

- Nursing Home Standards (H.B. 1446). This bill addresses nursing home staffing and related matters and has been sent to the Governor for his signature. The bill has a delayed effective date of July 1, 2025. This bill was supported by the Virginia Federation of NARFE.
- **Budget Bill**. Although no agreement for sweeping changes to the state budget for both tax cuts and massive new spending was reached, the legislature passed a slimmed-down budget bill (H.B. 1400). It provides additional funding of \$250 million into the Virginia Retirement System, \$100 million to cover shortfalls in capital construction funding, \$133 million in direct aid to public education, and \$406 million to the Revenue Stabilization Fund for Fiscal Year 2024. That bill is awaiting signatures by the Speaker of the House of Delegates and the President of the Virginia Senate, before it goes to the Governor for his signature.

2023 Virginia General Assembly Elections. According to information from Debbie Fisk, VFN State Legislation Committee, over a dozen Virginia legislators are retiring as a result of the redistricting that has occurred in Virginia. These legislators include Democratic Senate Leader Dick Saslaw, Republican Senate Minority Leader Tommy Norment, and legislative veterans such as Republican Delegate Kathy Byron, Democratic Senator John Edwards and Democratic Delegate Ken Plum (the House's longest-serving member).

All 140 seats in the politically divided General Assembly are on the ballot this year. Candidates will be running for the first time under the redistricted maps. Many legislators were paired in many of the re-drawn districts. This could lead to additional retirements.
