Summary of Chapter Discussions

H&R Block Presentation Highlights

Ms. Ballard summarized the 38-page IRS Publication 554 Tax guide for Seniors: https://www.irs.gov/pub/irs-pdf/p554.pdf. Topis included:

- Increase in standard deduction amount increased for all filers.
- Elimination of age restriction for contributions to a traditional IRA; Alternative minimum tax exemption increased.
- Standard mileage rate increased. Increase in age for mandatory distributions; Some social security benefits may be taxable.
 Charitable contributions are deductible, only if itemized; Energy credits.
