This reminder to members who joined recently: We have been having trouble for two years with the chapter membership list provided by national headquarters, which also serves as our mailing list. Not everyone is being placed on both the membership list and the mailing list. If you do not receive monthly announcements about Tuesday meetings (September through May), the two summer events, or the newsletter please let us know.

### You Can Charge NARFE Membership To Your Credit Card

Last year in this column we discussed two types of membership that are convenient and economical, namely, life membership and dues-withholding membership. Perhaps the least publicized method of membership renewal is via credit card.

When we enter the NARFE website www.narfe.org most of us probably use "My Account" most frequently to update our contact information in "My Profile" or perhaps to sign up for webinars. But in addition to "My Profile", "My Registrations", and "My Invoices", there is the less-explored option called "My Settings." One of the many options you will find here is "Manage Credit Card for Automatic Renewals."

First you provide the usual credit card information (type of credit card, number, expiration date, security code), then your name and address. You next will find a statement saying, "Payments Authorized by PayPal". This means that NARFE does not save your credit card but instead authorizes it through the PayPal system.

You now have reached the line "Pre-authorize this credit card for renewals of," and there are two options. One is "Membership" and one is "PAC & Contributions". If you only want your credit card to be used for membership renewal, select "Allow" under the "Membership" option and select "Do not allow" under the "PAC & Contributions" option. Then select the tab "I agree to Pre-Authorize this card" and you're finished.

From then on, NARFE will renew your membership when it's due via your pre-authorized credit card usage and send you an email that serves as a receipt. There no longer is the concern that your membership will expire. If you later decide that you prefer to renew your membership by one of the more familiar methods, you can revoke the authorized credit card by returning to this form and selecting "Cancel" to negate your authorization.

### **Lunch Guest Speaker** By Ginny Taylor, Program Chair

Our speaker for March 14 will be Francis Gary Powers, Jr. whose father, Francis Gary Powers, Sr., was shot down while flying a reconnaissance mission over airspace in the Soviet Union in 1960. Here's some background about our guest speaker.

Gary Powers Jr. is the Founder and Chairman Emeritus of The Cold War Museum, a 501(c) (3) charity located at Vint Hill, VA, 45 minutes west of Washington, DC. He founded the museum in 1996 to honor Cold War veterans, preserve Cold War history, and educate future generations about this time period. As Chairman of the Presidential Advisory Committee for the Cold War Theme Study, he works with the National Park Service and leading Cold War experts to identify historic Cold War sites for commemorating, interpreting, and preservation. Recently, he consulted for a Steven Spielberg Cold War thriller, Bridge of Spies, about James Donovan who brokered the 1962 spy exchange between KGB spy Rudolph Abel and CIA U-2 pilot Francis Gary Powers, Sr.

Francis Gary Powers, Sr. was an American pilot whose Central Intelligence Agency Lockheed U-2 spy plane was shot down while flying a reconnaissance mission in Soviet Union airspace, causing the 1960 U-2 incident. He later worked as a helicopter pilot for KNBC in Los Angeles and died in a 1977 helicopter crash.
