#### SECRETARY'S REPORT – CHRIS GIESELER

Chapter 1116 President Kathy Arpa called the March 14<sup>th</sup> Membership Meeting to order at 1:09 p.m. at the Vienna Community Center (VCC). She then asked the guest speaker, Ms. Linda Colbert, Mayor of Vienna, to lead us in the Pledge of Allegiance, whereupon the assemblage rose and recited the Pledge. Kathy acknowledged attendees having birthdays in March: Ralph Dantinne (No. 80!) and Jim Hathaway. The assemblage sang "Happy Birthday" to the honorees.

PROGRAM: Kathy asked 1st Vice President and Program Chair Ralph Dantinne to introduce our speaker. Ralph made some prefatory comments, including Ms. Colbert was born in Vienna and attended Madison High School; She holds

Bachelor's and Master's degrees in Math; she was elected to the Vienna Town Council in 2014 and was elected Mayor of the Town in 2020. Her mother, Jane Seeman, was also Mayor of Vienna.

The Mayor then updated us on quite a few things going on in Vienna:

- In light of a change in the Commonwealth's laws, municipalities must now hold their elections when the general elections take place. All seven Town officials (Mayor and six council members) will be up for election or re-election at the November 7, 2023, general election. The officials will each serve 2-year terms.
- The Mayor's Volunteers Reception is to be held on April 18 at the Vienna Fire Hall. The Mayor's Fitness Challenge (Vienna vs. the Cities of Falls Church and Fairfax) starts Saturday March 18 through May 13. The Mayor's Coffees are held every month at various locations in Town.
- There's also the Green Expo; Taste of Vienna on April 29; Viva Vienna on Memorial Day weekend (including the Beer Fest which will be near the other activities along Church Street); the Liberty Amendments months starting in June; and an archeological dig near the Freeman House.
- The Mayor discussed the status of various business projects in Vienna. The lot at the corner of Maple & Nutley is still vacant; the owners have not officially filed a business application but are interested in doing so. Sunrise Assisted Living is expected to be completed in April. There is an issue with their sidewalks being too narrow. Regarding Vienna Marketplace (where Marco Polo used to be) the ground floor businesses have not opened yet because the builder did not build them according to the plan approved by the Town. Compass Real Estate will move into most of the retail space. Vienna Court (across from the Vienna Presbyterian Church) will become duplex-housing. New cottage-style homes will open up at Cottage Court (located behind the Jiffy Lube). The former Amphora will open with fare at "middlin" prices. The new restaurant will maintain the external structure of the building but will be renovated inside. Brusters Ice Cream has opened on Glyndon Street near Café Renaissance. Also, a grand opening was held recently by the new owner of the Virginian restaurant.

- In a question-and-answer discussion, the Mayor explained that the Town was updating and reorganizing its zoning code to make it easier to understand. Among the changes: height restrictions for at least some businesses were increased; outdoor dining facilities may need to be reduced; and residences can build front porches out a bit closer to the street.
- Regarding [recurring] rumors that the Giant property in Vienna would be sold, the Mayor responded that those rumors started when a site drawing had been released. No proposal has yet been submitted to the Town of Vienna. The Mayor wants new businesses to open in town that are "exciting".
- Efforts are underway to improve the landscaping of the town (e.g., flowers and irrigation on Maple Avenue and Church Street); provide more sidewalks; and update the "winter" street-pole decorations on Maple Avenue by changing from the aging wreaths to the new snowflakes. Under the auspices of the Vienna Art Commission, a mural will be built in town whereby residents can donate \$5 per brick for the mural. Also, traffic lights on Maple are being updated to have real-time timing for the lights.
- The Town Council is considering measures to increase lower-cost housing, but those measures could result in higher density housing. Also, public hearings are anticipated for considering the "look" of residences in Town. And, there may be a tax rate decrease for the Town.

Dave Graf complimented the Mayor on the depiction of Vienna on a recent episode of the PBS series "If You Lived Here". The series was shown every Monday night on WETA.



Following the Mayor's remarks, Chapter Photographer Mark Arpa snapped a picture of the Mayor and all attendees wearing green.

As Old Business, Kathy reported that 15 Chapter members were financial "Supporters" of the conference. The Supporters donated a total of \$375 for the Conference, an exceptionally good figure. [No New Business was discussed.]

#### SERVICE OFFICER REPORT – SUSAN LARSON

As Service Officer for NARFE Chapter 1116, it is my responsibility to keep you up to date with information pertaining to your federal benefits and retirement. Each month I attend zoom meetings with VFN Service Officer Arlene Arthur and other service officers throughout Virginia where we discuss various retirement and benefit topics. At our last meeting, we discussed my Social Security online accounts.

my Social Security is an online service provided by the Social Security Administration that allows you to review your earnings history, check current or future benefits, and access many other Social Security services. Go to <a href="mailto:ssa.gov">ssa.gov</a> to log in or create your account. SSA is using <a href="Login.gov">Login.gov</a> to allow you to sign in to your personal account safely and securely. If you created your account prior to September 2021 you can log in using your username and password.

I suggest that you access the <u>ssa.gov</u> website and your *my* Social Security account to review the wealth of information that SSA provides. Wondering about that one-time lump sum death benefit, it is there. Cannot find your SSA-1099, it is there. Need verification of your future Medicare Part B premium, yes that is there also. Need to replace a lost, stolen or damaged Social Security card? Yes, that is there also.

As you navigate the main page you will find a video at the bottom titled "What is *my* Social Security". View that for a short tutorial. At the top of the page is a question- "What should I do if I get a call claiming there's a problem with my Social Security number or account?" If you click on that line you will find a link that will allow for reporting a Social Security-



related scam online. Please note that the next line on that page starting with the American flag and "An official website of the United States government <u>Here's how you know</u>". When you see this on a government website, you can feel comfortable using it and enter your personal information. As we all know, you cannot be too careful when using the internet and providing personal information.

I hope you find this information helpful and useful.

#### LEGISLATION REPORTS

#### National Legislation - Daad Pierce

- On March 1<sup>st</sup>, Senators Sherrod Brown and Susan Collins reintroduced the Senate version of the Social Security Fairness Act (S.597). It would fully repeal the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO) laws that adversely affect many CSRS retirees. The House's version of the bill (H.R.82) was reintroduced earlier in the year. NARFE continues to encourage its members to ask their lawmakers in both chambers of Congress to cosponsor the bills.
- On March 9<sup>th</sup>, OPM's Director Kiran Ahuja testified at a hearing of the House's Committee on Oversight and Accountability. Before the hearing, NARFE submitted a statement for the record outlining its concerns with OPM and federal benefit programs, along with the association's support of a merit-based civil service.
- By March 21<sup>st</sup>, the House's Social Security Fairness Act (H.R.82) has already garnered 200 cosponsors, just 18 shy of a majority, and 90 shy of the 290 cosponsors needed to trigger the House Consensus Calendar rule process that would require either committee advancement or a floor vote.
- On March 28th, Speaker Kevin McCarthy asked President Biden to set a date by the end of the week for their next negotiation meeting on the debt limit. NARFE continues to monitor the debt ceiling debate and push back on proposals that would harm the retirement security of federal employees and retirees.

#### **Other News:**

The White House's 2024 budget (published the second week of March) includes the following NARFE-supported items:

- Proposes a 5.2 percent average pay raise for federal employees, in line with the requested military pay raise and recent changes in private-sector wages.
- Requests \$6.6 million for OPM to help reduce retirement processing times and improve retirement customer satisfaction, expand a pilot for online retirement applications, and begin to fund additional IT modernization initiatives.
- Advocates legislation to prevent a return of Schedule F. This was a broad new exception to merit-based civil service rules that was pursued by the previous administration.

#### Virginia State Legislation – Chris Gieseler

The Governor of Virginia has signed 739 of the 820 bills presented to him, including the Nursing Home Staffing Standards Bill (HB 1446), which the Virginia Federation of NARFE supported as part of its 2023 State Legislative Plan. The bills that were signed have become law, and most of them will go into effect on July 1 of this year. One of the exceptions is HB 1446, which has a delayed effective date of July 1, 2025.

He vetoed three bills, none of which seem of interest to NARFE. The Governor returned to the General Assembly 78 bills for which he recommended amendments, including HB 1400, the Budget Bill (where he could make line-item vetoes), for which he submitted four recommendations. These recommended amendments make "technical adjustments" for certain budgeted programs. The Governor did not call for a Special Session of the General Assembly but did urge the legislature to consider his amendments. He repeated a previous intention to work with the General Assembly to pass \$1 billion in tax relief to Virginia taxpayers as well as to deliver over \$2.6 billion towards "job growth, public safety, education excellence and behavioral health services."

The amended and vetoed bills, together with the Governors objections and/or recommended amendments, will go back to the General Assembly for consideration during the so-called Reconvened Session, which starts on Wednesday, April 12, 2023.

To override the veto of a particular bill, the House of Delegates and the Virginia Senate would each need a two-thirds majority vote to do so. If both houses successfully override the veto, the version of the bill sent to the governor becomes law. Otherwise, the bill does not become law.

For bills with recommended amendments, the process is more complicated. Regardless of what the legislature does in terms of adopting or rejecting the Governor's amendments, once both houses agree (assuming they do agree) to a bill during the Reconvened Session, they will send the bill back to the Governor. He can then sign, veto, or let the bill become law without his signature. He has 30 days from the date the Reconvened Session adjourns to act on the bill.
