What eventually became Arlington County is part of a 1790 carve-out from Fairfax County, which the Commonwealth of Virginia ceded to Federal jurisdiction for the Seat of the National Government. The 1846-47 process of returning whatever territory Virginia contributed was enabled by Act of Congress and Presidential signature. Update on WEP-GPO Repeal

Since we last visited this issue back in February, a companion bill to *HR* 82 has been introduced in the Senate (*S* 597), with 35 original co-sponsors. Meanwhile, as of this writing (3/20/23) the number of co-sponsors for *HR* 82 stands at 200, including 6 from Virginia. In case you have forgotten, the threshold under the House's Consensus Calendar Rule for forcing either a committee hearing or a floor vote is 290; thus, we're already well on our way.

Among Virginia's cosponsors are the three Congress(wo)men who collectively represent the totality of Chapter 7's membership---Reps. Beyer, Connolly, and Wexton. A word about Rep. Beyer (D-VA-8) is in order, since he has only recently come onboard (3/14/23). Noting his absence from the list of cosponsors, I asked Beyer (Annandale Town Hall Meeting, 3/13/23) if this meant that his previous support for WEP-GPO repeal in the 117th Congress had changed. Simply an oversight due to an overload of issues competing for attention was (in essence) his reply. In any event, he committed to becoming a co-sponsor; and true to his word, he signed on the very next day---3/14/23). Lesson for us as advocates? Even in today's oh-so electronically-connected world, there is still a role for face-to-face communication.

There is also work for us on the Senate side. Missing in action from the list of cosponsors of *S 597* are Senators Kaine and Warner. You know the drill. Go to www.NARFE.org, click on "Advocacy", then on "Take Action," and follow the prompts.

Increased Funding for Virginia's *Livable Home Credit* (HB 2099)

Among the smorgasbord of miscellaneous credits allowed against your Virginia state income tax that must be filed on VA Schedule CR is the Livable Home Tax Credit. Pursuant to *HB 2099*, the amount of funding to cover this program will be doubled in FY2024 to \$1M each for new construction and for retrofitting. While this credit is not means-tested, the maximum amount a taxpayer may claim for "eligible activities" in a given year (beginning in FY2023) is \$6,500 toward the purchase of a new home, or 50% of the cost of a retrofit not to exceed \$6,500. To qualify, an expenditure must embody (or enhance, in the case of retrofit) the design principles of accessibility or universal visitability. (Think design for "aging-in-place)."

Eligibility for the credit is not automatic. Application must be made through Virginia's Department of Housing & Community Development (dhcd.virginia.gov/LHTC). Since funds are limited, they are awarded on a first-come-first-served basis. Finally, if you succeed in snagging this credit, when tax time rolls around, you will file it on Virginia Schedule CR Section 1, Part 16, Line B.

Hello! Is everyone---or even *anyone---*still awake? Details, details, eh? Moreover, in today's economy, the Livable Home Credit might not be enough to make your proposed project financially feasible. But if you itemize on for your Federal 1040, expenses for accessibility/visitability home improvements most likely will be deductible. In order to be sure, check out the menu of eligible expenses under the category of "capital expenses" in IRS Pub. 502.
