FEDERAL LEGISLATION

The Shrunken Gavel

House Speaker Kevin McCarthy, after eking out an agonizing, five-day 15-ballot victory savored the gavel for the first time at 1:13 am Saturday morning, 1/7/2023.

His first remarks to the congress "My father always told me: It's not how you start – it's how you finish." But it is how McCarthy got there that signals a new depth of dysfunction for the American government.

This matters because McCarthy's desperate fight for speaker provides a preview, not just of a new era of divided government, but a new reality where even basic governance will require the art of pursuing harmony and consensus among a divided forum.

Speaker McCarthy will have his work cut out for him. He will preside over a GOP that is ungovernable, and a House that is so narrowly split that little productive work looks possible. We may have just witnessed an incredibly shrinking speakership given the concessions McCarthy had to give to win the vote.

NARFE will work tirelessly to advocate for our earned benefits. It is important that every one of us is aware of their priorities and help in any way we can with direct communications with our legislators.

What About WEP/GPO in 2023?

The Consolidated Appropriations Act, 2023 (FY23 budget) was wrought with disagreement between

parties and infighting among party organizations. Critical to us was the inclusion of a full repeal of the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO).

For some of us, our dream to see the penalties removed during the 117th Congress came to an end on December 31, 2022, but do not lose hope because the movement has accomplished great things last year. We have grown awareness in Congress and the public arena and educated those affected, expanding our grassroots effort exponentially.

Solvency of the trust fund played a major role in closing down negotiations in the 11th hour of 2022. With predictions that in 11 to 13 years the fund could be almost broke, that is a sobering fact for most of us. Yes, social security is an earned benefit, but to think that when our youngest retirees reach the age to retire in 11 to 13 years they may face a fund that is empty; one can begin to understand. However, that does not negate the fact that legislators did not work harder in the 117th Congress to make sure funding was addressed as part of the legislation. It is no secret that the fund has been failing to meet standards of solvency for years.

In the 118th Congress there is continued discussion and review of managing the fund in a way that will be sustainable for years to come and retirees will also receive the money they rightfully earned. Rep. Garret Graves and Abigail Spanberger are continuing to pursue H.R. 82, to date there are 250 cosponsors. Only 40 more are required to force a vote on the House Floor and it with the current progress we will reach our goal more quickly than years passed.

Also, let us begin to talk with Senators Kaine and Warner about S.597 that was introduced by Senator Sherrod Brown. This is the companion bill to H.R. 82 that will help bring repeal to WEP/GPO which we all know is the fair and right thing to do. These are earned benefits that are withheld from hard working citizens.

More importantly, the movement has come further than ever before, and we have no intention of giving up. NARFE leadership will once again join forces to focus on the repeal movement and design better and more effective methods to get the job done in the 118thCongress.

VA STATE LEGISLATION

After over two decades of work by Delegate V. Watts and many dedicated advocates, there is legislation that has begun to address nursing home staffing standards. It is not everything that we asked for but is a beginning that can be further examined.

H.B. 1446 Certified Nursing Facilities; minimum staffing standards, administrative sanctions were signed by Governor Youngkin on March 24, 2023. Although the effective date is in 2025, we feel incredibly grateful to all who supported this important legislation over the years and we know it will make a tangible difference in the lives of the elderly in Virginia.

"Critical Alzheimer's & Dementia Priorities Signed Into Law"

The Alzheimer's Association and the Alzheimer's Impact Movement (AIM) commend the passage of the fiscal year (FY23) budget which was signed into law on December 29, 2022 to include policy priorities to address Alzheimer's and Dementia across the nation. This legislation received bipartisan support from several organizations. The Alzheimer's Association and the AIM also commend the bipartisan

congressional commitment to those who are directly affected by this disease. This will mean more people of the underrepresented population will be able to participate in dementia-related clinical trials and gain access to new and innovative treatments. The NIH and their critical investment will insure a "robust" research budget to impact public health response. Thanks to the bipartisan congressional champions and dedicated advocates, our nation has taken action to address health disparities in Alzheimer's and Dementia research.

There are many options in VoterVoice. Click the "hamburger menu" (three horizontal lines, sometimes called the "options menu") at the top left of the screen to see your choices. I recommend you fill in your profile to save later typing. The directory gives you an easy list of all elected officials for your address as well as nearby media with contact information.

Community, but there are many others. Click the "+" button to add a new post in your current community.

NOTE: From the Connected Community App you cannot edit your profile or account settings, you will be prompted to view and edit them within a browser.

VoterVoice – download the app on your smart device, enter your email used on your narfe profile record. There is a place for password but I leave it blank. On the next screen "Find Organization" enter "NARFE", then from the list of organizations presented below the search box tap "NARFE."

The home screen carrousel rotates through top advocacy issues. If you select an issue, you will see a summary of the bill in question, and how you can help. Just like the computer version, you can take the text of a message template, customize it with your background and position on the issue. Based on your profile the app will select your elected US Congressional
