#### Welcome & Swearing New Treasurer:

#### **President Bails**

President Constance T. Bails, Ph.D. welcomed the Board of Directors to the 2021 July Board Meeting... followed by welcoming and swearing in Thomas A. "Tom" Rachele, the New Treasurer, of Virginia Federation of NARFE (VFN). Frances E. Boatman, VFN 2<sup>nd</sup> Vice President, Acting and Esther L. Nash VFN Secretary, Acting.

#### Approval of Agenda:

- The President called for a motion for the approval of the agenda. A motion was made by Immediate Past President Leslie Ravenell that the agenda be approved and seconded by Treasurer Thomas Rachele Motion carried.

#### **President's Comments**

- Due to this year's first full in person attended board meeting due to the pandemic. Connie requested that everyone introduce themselves this included their board positions, committees and chapter position.
- That as a professional courtesy that five-dollar charge be made for those talking on the telephone disturbing of the meeting by telephone ringing or buzzing, will pay five dollars to the Sergeant of arms who in turn will give it to the Alzheimer's Chair. Discussion followed. The board was in agreement.

Motion carried. Discussion: Reimbursement up to \$1,000.00 based on voucher.
- Suggestion was offered during the Alzheimer report that a 50/50 at a Board could be done at the board meeting. **OPEN**
- Discussion: What would benefit a group concept with several VFN Areas and Chapters coming together in a group to bond under the umbrella of the Federation. This is because the decrease size of Areas and chapters. She explained what they could be doing in their Chapters and Areas and group activities that might allow for a more cohesive group. President Bails suggested a committee be formed to develop this concept. # Region X Vice President's Report:

## **Bill Shackelford**

- Region X Conference being held September 21 September 23, 2021, Room rare \$119.00 at Frankfurt, Kentucky. See Bill for additional information. Deadline for registration August 28, 2021.
- All CDL positions are filled.
- VFN budgeted for Region X Conference, approximately six to eight members intend to attend conference. A maximum amount would be allotted but not exceeding, depending on travel voucher.
- Provided an in-depth report of NARFE Headquarters' status of Region X. Bill emphasized NARFE's focus for the 117<sup>th</sup> Congress to advocate for: 

   A federal pay increase in 2021 and beyond
   Modifying postal reform proposals to preserve health care choices for postal retirees
   Enacting full colas for FERS retirees
   Supporting current efforts to reform the Windfall Elimination Provision (WEP)
   Ensuring adequate oversight of proposals to reorganize the Federal government
- Bill ended his report thanking the board for their membership, leadership, and for everything they do to helps NARFE be a better organization.

# <u>Treasurer's Report:</u> (subject to audit) – <u>Treasurer Bill Martin/Thomas A. Rachele</u>

- Bill provided a detailed financial category report to the board.
- Revenue Source \$45,074.29, expenses. (See documents distributed in meeting)
- PAC payment was made early, no issues. Miscellaneous Income (source of funds) of \$3,000.00, will remain in that account. Budget for FY 22 is \$96,190.

**NOTE**: Dr Bails thanked Mr. William "Bill" Martin, the VFN Acting Treasurer all of his tireless dedication and time for stepping in assuming the role of Acting Treasurer.

#### Budget Review:

Discussion held on Region X Conference budget continued: increasing it to \$1,000.00 per person. Discussion continued. Lesile made motion to increase the Region X Conference up \$9,000.00. Seconded. Discussion followed. Question why the increase? Increase would allow payment up to \$400.00 additional funds per person in the budget to cover the cost depending on travel voucher turned in. Depending on the distance \$1,000.00 will not cover the entire trip. Question - How many in favor of allocating \$9,000 to Region X budget., majority agreed to the increase and motion carried. Nine people are intending to attend. Leslie made the motion that proposed budget FY22 be accepted as presented with the additional of \$4,000.00 be added for the Region X Conference Budget. Seconded By Donna. Motioned carried.

#### 1<sup>st</sup> VP Comments & AVP Reports:

Areas have been having zoom meetings and they discussed a number of issues. Each Area Vice President will give activities in their areas. Suggested joint area meetings in future.

Referenced NARFE's 2021 National Legislation Conference which was held on June 21-23, 2021. Because of the financial support of the VFN, 10 members of our 13 person VFN National Legislation team were able to attend this year's virtual conference and participated on June 26 in NARFE's virtual Advocacy Day with 12 of VA's 13 Congressional Delegation Offices. Plus, an additional five other VFN attendees. These are the NARFE Priorities we carried to the Hill and where the VA Congressional Delegation support is and where we need to do more work.

1) **Repeal** of WEP &GPO <u>**HR 82</u>**- Social Security Fairness Act,</u>

<u>S 1302</u>-Social Security Fairness Act -

2) Reform WEP & GPO HR 2337-Public Servants Protection and Fairness Act,

# 3) Postal Service Reform Act of 2021 <u>HR 3076</u>

**S 1720**-: Need to determine what impact the bill would have on Federal Employees Health Benefits BEFORE considering to pass this bill.

### 4) Fair COLA for Seniors Act (HR 4315) Issue Use CPI-E (Which better represents cost of the elderly)

5) HR 304 Equal COLA Act (Treat FERS fairly and equally with other COLA recipients 6) House Resolution 131- To recognize NARFE's 100th Anniversary (2) Requesting that Area Vice Presidents and CDLs get word out to our NARFE members to encourage them to call their Representative and Senators office and ask those who have yet to sign on as cosponsors to now sign on as cosponsors.

(3) Consider sending out a NARFE email to both Virginia National and Chapter NARFE members to encourage them to call their representatives.

## Alzheimer's:

- Apologized to Area IX for not recognizing their outstanding support of Alzheimer's
- Checks should be made out to NARFE Alzheimer's Research but sent to her.
- Provided the status of VFN's donations. Provided the latest information on treatment for Alzheimer's (Drug called Aduhelm ) Discussion followed.
- 2021 Conference will have the 50-50 drawings and Silent Auction.
- Advised the board to review her video on the website proving more information.

#### Public Relations:

- Attended all committee meetings and participated in VFN training.
- Appointed to the Training Committee and have promoted it on social media.
- Social media accounts are updated.

## Service Officer:

Thanked the VFN Board for their support during her time of need. Provide monthly newsletters for Service Officers to connect with them and also to give them a tool with which to connect with their members.

- Since chapters went from monthly in person meetings to either no meetings or electronic meetings the need to stay connected felt crucial. OPM has 11 situations that affect members (annuitants), their spouses and/or their children. These situations are termed by OPM as Life Events.
- Since January my monthly Service Officer Connections have been covering Life Events, item by item. Eight of the Life Events were covered through June. Because of personal reasons the April through June newsletters were combined. The Service Officer Connections for April through July have been issued.
- The newsletter is sent to both chapter Service Officers and chapter Presidents (even if the chapter has a Service Officer).
