PRESIDENT'S MESSAGE

What has NARFE done for you lately? Ever asked that question? I know I have. However, after reading the latest NARFE magazine, I realize they have done a lot!

a. Protect Health Care Benefits and Insurance. NARFE's advocacy protected the earned health care benefits of retired US Postal Service employees and prevented unintended premium increases for all Federal Employee Health Benefits program participants.

b. Support for WEP/GPO Repeal and Reform. Although these bills did not pass, support for these bills increased thanks to NARFE's advocacy.

c. Rescind Schedule F Executive Order.

d. Oversight to improve OPM'S Retirement Services. As many of you know, there have been lengthy delays in processing survivor benefits processing, health insurance benefit updates and many other changes. NARFE requested congressional report language providing additional oversight of the OPM's Retirement Services division.

So, you can see, NARFE is working for you. You can find more information about these and other legislative actions in the March issue of the NARFE magazine or on the NARFE website.

What has NARFE Chapter 893 done for you lately? NARFE-PAC

NARFE-PAC protects NARFE members' pay and benefits by raising and spending money to elect members of Congress who support the federal community. The PAC works for you by building strong relationships with lawmakers and providing NARFE with additional opportunities to share our most pressing concerns.

NARFE-PAC is financed through NARFE members' direct, voluntary contributions to a separate fund. Federal law prohibits NARFE-PAC from soliciting contributions from anyone other than NARFE members and the immediate family of these individuals. Any contribution received from any other person will be returned to the contributor.

NARFE members can sign in to access the NARFE-PAC members page where you can make contributions to the PAC, view contribution and disbursement reports, access NARFE-PAC materials and read through the PAC toolkit.

Chapter 893 is the third largest donor in the Virginia Federation!

LEGCON 2023 June 20-22

Policy experts and congressional leaders and staff will address NARFE's legislative priorities and outlook for the 118th Congress. The conference culminates with a virtual lobbying day where you join your fellow NARFE members in bringing our message directly to lawmakers and their staff.

TSA PRECHECK

WHAT IS TSA PRECHECK, AND IS IT WORTH IT?

If you've ever been in a long security line at an airport and wished there was a faster way to get to your flight, it's time for you to consider TSA PreCheck.

WHAT IS TSA PRECHECK?

TSA PreCheck is an expedited security program for travelers departing or traveling within the United States. Eligible low-risk travelers experience expedited security screenings and don't have to remove their shoes, liquids, gels, laptops, jackets, or belts during the screening process at airports. The program is eligible to US citizens or Lawful Permanent Residents (LPR) that haven't been convicted of certain crimes. Enrollment is \$85 and lasts for five years.

HOW DO I ENROLL IN TSA PRECHECK?

Enrollment in TSA PreCheck is very easy. It takes under five minutes to submit an online application for the program and schedule an in-person appointment in your community that includes a background check and fingerprinting at an enrollment center. Before applying, make sure you review the various Department of Homeland Security trusted traveler programs to ensure that TSA PreCheck is the right option for you.

HOW WILL I KNOW WHEN I'VE RECEIVED TSA PRECHECK?

According to the TSA, most applicants receive their Known Traveler Number (KTN) within three to five business days. However, some applications may take up to 60 days. Applicants can check their status at any time online. If approved, participating airlines display a TSA PreCheck indicator directly on your paper or digital boarding pass if you are eligible for TSA PreCheck. You will need to provide or validate your KTN to your airline when making a reservation. The name submitted on your airline reservation must match the name you provided on your application. If you use a frequent flyer account or an online travel profile, ensure that your name is saved correctly to avoid any issues.
