<u>Adopt-a-Road</u> – Due to the extreme heat and poor air quality, we cancelled our July





LEGISLATION REPORT – Federal Budget Progress: Congress is still working



on finalizing the budget for Fiscal Year 2024 (FY24) which starts on October 1, 2023. However, both the House and Senate appropriations committees have made progress advancing the appropriation bills, with the Senate advancing all 12 appropriations bills out of committee, and

the House advancing 10 of the 12. Most likely, a Continuing Resolution will be needed to get all 12 Appropriation Bill through their respective floor votes and final Budget Reconciliation process. (*Legislation Report continued on next page*)

S.2226 / H.R. 2670 National Defense Authorization Act FY 2024: Both the House and the Senate and the House have passed their version of the bill. The House bill authorizes defense programs with spending up to \$866 billion and a 5.2% military pay raise, although the actual budget authority for such spending is subject to final passage of congressional appropriations.

S.2127/H.R.4366 Military Construction/Department of Veterans Affairs Appropriations: The bill would provide \$17.5 billion for military construction projects and \$137.8 billion in nondefense discretionary spending for veterans' medical care.

Financial Services and General Government Funding Appropriations: Both the House and Senate Committees on Appropriations advanced their versions. This legislation funds the Office of Personnel Management (OPM). Both the House and Senate version remain silent on a 2024 Federal pay raise, increasing the likelihood the Administration's 5.2% proposed increase will go into effect. The House bill would provide OPM with a total of \$373 million in FY 24 vs the Senate's proposed \$457 million. Both House and Senate versions of their committee reports express concern with OPM Retirement Service customer service levels. The Senate appropriations committee's accompanying report recommends \$35 million for the new Postal Service Health Benefits program rollout; improvements to OPM's Retirement Services; and OPM's IT modernization improvements; and also directs OPM to brief the committee on its plan to monitor, identify and remove ineligible family members from the Federal Employees Health Benefits (FEHB) program. The House committee approved legislation also keeps language that would effectively force the end of the Thrift Savings Plan new mutual fund window; and, force agencies to return to telework policies in place before the pandemic while the Senate report differs on telework policies, directing OPM, OMB and agencies to analyze how telework affects agency productivity. The report language also called on OPM to work on ways to reduce hiring times and to report to the committee on processing retirement applications. Both the House and Senate versions of their bills await floor votes.

H.R. 4583/S. 2280 Social Security 2100 Act: If passed, for the period 2025-2034, these bills would repeal the Windfall Elimination Provision (WEP) (continued on next page)

and the Government Pension Offset (GPO), and would extend by a few years the solvency of the Social Security Trust Fund; provide a 2% across-the-board benefit increase; improve cost-of-living adjustments (COLA) by using CPI-E; and improve survivorbenefits for middle-income widows and widowers from two-income households. The bill would make permanent the tax changes necessary to pay for expanded benefits provided by the bill which includes applying social security taxes to earnings above \$400,000 per year (with credit towards future benefits), and applying a 12.4 % net investment tax on those earning more than \$400,000 year. The Bill would also combine the "Old-Age and Survivors Insurance" (OASI) and the "Disability Insurance" (DI) Trust Funds into one fund to ensure seamless benefit payments. This bill has been modified from similar bills passed in the last Congress. Stay tuned.

H.R. 82/ S. 597 Social Security Fairness Act: The House Bill currently has 289 co-Sponsors, getting closer to the 290 co-sponsors needed to calendar a floor vote. This bill would repeal the Government Pension Offset and Windfall Elimination Provisions which negatively impact many federal and state/municipal retirees by cutting their earned Social Security benefits.

Virginia General Assembly: Since May, the General Assembly has been called back



to a few special sessions to address outstanding concerns and issues with the FY 2024 State budget. Virginia approved a 2-year budget last year, but the State budget can be amended in year 2. At issue is the revenue surplus – one side wants to enact tax cuts (per the

Governor's request) to reduce the surplus, the other wants to retain some of the surplus in case a recession unfolds and spend some of the surplus. No agreement has been reached thus far, so, the surplus is just being held until a decision is reached. All told, not a bad problem to have, but frustrating to not have a decision.

Make sure your voter registrations are up to date – in November, all seats in the Virginia State General Assembly are on the ballot, as well as many important County seats: Board of Supervisors, Sheriff, School Boards, Soil and Conservation, etc.
