FOOD FOR OTHERS

In March we collected 196n pounds of food for "Food for Others". Needed items include:

Food Items (no more than 3 years expired, unopened, labeled, not homemade):

- Fresh fruits (oranges, apples, bananas, tomatoes, avocados, grapes, berries)
- Fresh vegetables (cucumbers, celery, peppers, lettuce, eggplant)
- Cooking Oil
- Dry goods cereal, pasta, rice, (16oz packages), dried beans
- Canned vegetables tomatoes (crushed, peeled, diced, etc.), beans, corn, etc.)
- Canned meat (chicken, turkey, or seafood), 2oz 15oz
- Canned fruit (packed in fruit juice instead of syrup) 11oz 20oz
- Spaghetti sauce, 14oz 1 lb (ideally in cans or plastic instead of glass)
- Fruit juice (100% juice) 32oz 64oz

Perishable Food (Meat and Dairy unexpired, sealed, in original packaging):

Non-Food Items (New or Clean Reusable Grocery Bags 8 ½ x 14 x 15 and can openers)

After the May meeting, Bob Sottile delivered 180 pounds of food for the Chapter.

LEGISLATIVE REPORT

NATIONAL LEGISLATION- The Congressional Budget Office said on May 12 that there was a "significant risk" that the federal government could run out of cash sometime in the first two weeks of June, setting the United States up for a default. The warning came as the White House and congressional leaders spent the week in negotiations on how to raise the \$31.4 trillion borrowing cap. The Treasury Department has been using accounting measures known as extraordinary measures to keep paying the country's bills without breaching the debt ceiling, which was officially reached on Jan. 19. Republicans moved through the House on virtually a party-line vote a bill to raise the federal debt ceiling while squeezing "discretionary" budgets for federal agencies that pay for day-to-day operations including salaries for employees. It had virtually no chance of passage in the Democratic-led Senate and President Biden said he would veto it if it did pass there.

A face-to-face meeting on May 8, between President Biden and the four top congressional leaders, including House Speaker Kevin McCarthy, produced no agreement. A second meeting, originally scheduled for Friday, May 12, was to take place before President Biden's departure for a May 17 G7 leaders meeting.

While the decision to delay the meeting was viewed as a positive development that could allow both sides to reach a consensus, it remained unclear whether an agreement could be reached in time. Speaker McCarthy has insisted on deep spending cuts and a rollback of President Biden's clean energy agenda as a prerequisite to raising the debt limit. The President has insisted that Republicans raise the borrowing cap, arguing that it simply allows the United States to pay bills that Congress has already approved.

Karine Jean-Pierre, the White House press secretary, said the scheduled May 12 meeting was delayed so that the administration and congressional staff could continue private discussions. While the White House continued to insist that raising the debt ceiling it is not negotiable, she said the president was willing to discuss other spending and budget matters with Republicans.

The nation's long-term fiscal outlook continues to be problematic and could only harden the Republican position that the government must rein in spending. In a separate report, the Congressional Budget Office said it projected a federal budget deficit of \$1.5 trillion this year, slightly higher than its forecast in February. Annual deficits are projected to nearly double over the next decade. (NY Times)

Support for the Social Security Fairness Act (HR 82) has now gained co-sponsorship by a majority of House Republicans. If passed, the legislation would fully repeal both the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO). "Now momentum is building to finally do away with them," said NARFE National President William Shackelford. (My Federal Retirement)

<u>VIRGINIA LEGISLATION-</u> For the eighth time since 2013, Virginia's General Assembly failed to agree on terms of the state's government budget by the regular session adjournment deadline.

The 2023 regular session ended in February. Lawmakers have already had their one-day reconvened springtime session to consider gubernatorial amendments and vetoes to the bills they passed. The most consequential legislation of any session, the budget, was not among them. Partisan wrangling or parochial horse-trading by legislative budget negotiators are blamed.

Differences between the House and Senate over tax cuts, mental health reforms and pay raises for teachers have stalled an agreement on amendments to the current two-year, \$167 billion budget that took effect last July 1. If the General Assembly can't reach a consensus, the existing budget remains in place as a safety net. Governors can't make new appropriations, but they have authority to move money around to address some needs. (Richmond Times-Dispatch)
