#### Notes from the First Vice President:

This month we welcome as our speaker, our very own Christine Almassy. Christine will speak to us about her experiences as a National Park Service employee. She will focus on some of the things she's involved with at the George Washington Birthplace National Monument, or GEWA as it's known in the park service.

Christine grew up in the Fredericksburg area and later attended Lycoming College in Williamsport, Pennsylvania, where she majored in history and archeology. After teaching for a couple of years, she realized that while she loved the kids and interacting with them, she didn't like sitting in a classroom for 8 plus hours a day. #### OPM Issues Guidanceon Hours of Work Policies for Offsite Work

OPM has issued guidance to clarify when travel time for teleworkers and remote workers constitutes hours of work for purposes including eligibility for overtime.

The guidance covers both telework-in which an employee is expected to regularly report to work at an agency site and that remains the official duty station for purposes such as locality pay rates-and remote work, in which there is no such expectation and the offsite work location is the duty station.
