ALZHEIMER'S

As we begin the 'entrance' to Fall, there is new "positive" info re Alzheimer's. First, there may soon be another option for an Alzheimer's drug capable of slowing the progression of this disease ... an experimental drug from Eli Lilly, called *donanemab*; however, side effects were serious in some cases. The news of this drug came on the heels of the Food & Drug Administration first fully approved drug, *Leqembi*, that aims to slow the progression of the disease. Both drugs are monoclonal antibodies that work by targeting amyloid in the brain, a hallmark of Alzheimer's disease. The thinking goes that by targeting amyloid, disease progression could be slowed. It doesn't make people better, but it delays the progression. The success of donanemab and Leqembi are yet another pivot on the long road of research. The potential of these drugs is a source of hope, but is hampered by concerns about their potentially life-threatening side effects including brain swelling and brain bleeding; however, there are patients and families who are going to want the drug, despite the side effects.

Another bit of good news: on July 31st, a new Centers for Medicare & Medicaid Services (CMS) initiative to improve the way dementia care is delivered for people living with Alzheimer's disease and other dementia, the **Guiding an Improved Dementia Experience (GUIDE)** Model, run thru the Center for Medicare & Medicaid Innovation (CMMI), was announced. There is growing support in Congress for the Comprehensive Care for Alzheimer's Act (H.R.1637/S.626). CMS said its **GUIDE Model** will test an alternative payment for participants who deliver key supportive services to people with dementia, including comprehensive, person-centered assessments and care plans, care coordination, and 24/7 access to a support line. People living with dementia and their caregivers will also have access to a care navigator who will help them access services and support.

This initiative from CMS comes at an extremely important time as new disease modifying treatments introduce new challenges and opportunities for care providers. While these treatments are only for individuals living with early Alzheimer's, this care model aims to benefit all those with dementia at any stage. HOWEVER, these programs will not develop on their own because health care practitioners would need to provide unreimbursed services without capturing offsetting savings. To encourage and facilitate the development of dementia care management programs under Medicare, a change in the payment structure is necessary.

As research continues and small measures of progress are being made, please consider a donation for 2023. All monies go directly to Research.
