#### **BCBS Federal Employee Program (FEP)**

The new **FEP Medicare Prescription Drug Program (MDPD)** – is a prescription drug benefit exclusively for BCBS FEP members with Medicare and is part of the BCBS Benefit Plan coverage. Ms. Fletcher distributed the MDPD brochure to all members and discussed the plan features and the four drug tiers. Ms. Dickerson elaborated on the pharmacy benefits of the MDPD compared to the benefits with Medicare today for each BCBS plan (Basic, Standard and FEP Blue Focus). Both representatives answered questions and concerns from the group.

She discussed the medical benefits, plan rates, pharmacy benefits, annual deductibles, and the Medicare Reimbursement Account.
