Looking Beyond the Current Budget Imbroglio on Capitol Hill

By the time you read this, we will be either in the midst of a Federal Government shutdown, or at the beginning of what might turn out to be a string of continuing resolutions (CRs), as Congress struggles to come to agreement over FY24 funding. Then what? While anything is possible in the free-for-all that reigns on Capitol Hill these days, here are three items worthy of your attention.

Ending Government Shutdowns

Back in September, Rep. Don Beyer (D-VA-8) introduced a bill (*HR 5353*) that would initiate an automatic CR on October 1st, should appropriations bills not have passed by that date. This bill (as well as a companion Senate bill---*S.2041*, introduced by Sen. Kaine, D-VA) would also prohibit the Senate from moving forward with any other legislation (except in an emergency) until Congress might reach a deal on a long-term spending bill. Significantly, three other similar bills---all sponsored by Republicans---were introduced in the Senate earlier this year. Thus, at least in the Senate, there would appear to be bipartisan support for ending the use of shutdowns as a weapon in the chronic budget wars.

Establishment of a Bipartisan Fiscal Commission

Also back in September (9/18), the Committee for a Responsible Federal Budget (CRFB, a widely-respected non-profit research firm frequently cited by both the news media and academia on Federal budgetary matters) wrote to Speaker McCarthy and Leader Jeffries in the House, and to Leaders McConnell and Schumer in the Senate, requesting that a bipartisan fiscal commission be established to address the Nation's many fiscal and economic challenges. Further, any such commission should, "...put all parts of the budget and tax code on the table."

As you might recall, we've been here before. Back in 2010 during the first Obama Administration, the National Commission on Fiscal Responsibility and Reform (aka, Bowles-Simpson Commission) produced a wideranging report (dubbed, "The Moment of Truth"), that recommended a variety of new taxes and cuts to entitlement programs. In addition, benefits for Federal workers and retirees were also targeted for significant cuts, causing NARFE to mount a sustained campaign in opposition. NARFE members need to stay alert in the coming year for any similar efforts to unfairly reduce or eliminate our benefits.

More of the Same---i.e., Continuing Political Deadlock

As posited by *Wall Street Journal* reporter, Richard Rubin, the reigning political dynamic is such that: "...both parties agree that Social Security and Medicare, the two biggest Federal spending programs must not be touched, [and] they also agree that income taxes on the overwhelming majority of Americans can go down but never up. That tacit, politically popular consensus keeps tax revenue as a share of the economy flat or declining while spending's share rises. *(continued on p. 3)*

It also locks in a permanent budget imbalance that both parties bemoan but neither seems eager to change." (Tax Cuts Are Here to Stay---and So Are Budget Deficits," WSJ, 9/14/23, p. A-1).

What *should* we make of this chronic budgetary sound and fury on the Hill? On the one hand, it would be tempting to conclude, along the lines suggested by Rubin, that the status quo, stormy though it might be, will prevail indefinitely. On the other, there are those who predict that our fiscal situation is so dire that it simply cannot be ignored. In a recent editorial, the *Washington Post* (9/10/23, p. A-24) --- a voice not usually associated with worries about fiscal rectitude---thundered mightily as follows: "This [referring to a severe mismatch between expenditures and revenue collection] can't go on unchecked. Federal debt is on track to hit a record level by 2029, meaning it will be higher as a percentage of the U.S. economy than even World War II's peak. And it will get uglier from there if politicians continue to ignore it."

At the end of the day, however, it is not our job as NARFE members to resolve the Nation's fiscal morass. But it is our responsibility to ensure that if/when Congress comes to grips with the problem that any resulting budget cuts are not taken disproportionately out of our hide. Department of Defense (DOD) Civilian Retiree Cards No Longer Valid

Please note, as of August 31st, Department of Defense (DoD) Civilian Retiree Identification (ID) cards are invalid. Instead, to access morale, welfare and recreation activities at DoD installations, DoD retirees will need to enroll their REAL ID-compliant driver's license for future use at an installation's Visitor Control Center.
