## **LEGISLATIVE REPORT**

**NATIONAL LEGISLATION**- Returning to Capitol Hill following an August recess, House Speaker Kevin McCarthy was confronted with a twin set of challenges: avoiding a costly government shutdown when current spending expires after September 30, and addressing growing calls on the right to impeach President Biden, despite resistance from the party's moderates.

Throughout the August recess, leaders in the House and Senate continued conversations on the federal budget, with both Senate Majority Leader Chuck Schumer (D-NY) and House Speaker Kevin McCarthy (R-CA) agreeing that a short-term spending measure, known as a continuing resolution (CR), would be necessary to keep the federal government funded for the short term, giving lawmakers more time to reach an agreement on a fiscal year (FY) 2024 funding package. **(CNN)** 

While both Democrats and Republicans had voiced a commitment to avoiding a shutdown, the path to enacting a CR remained unclear. The White House, along with most of the Senate and many members of the House, supported attaching a supplemental funding measure to the CR that would provide additional funding for purposes like disaster relief, as well as continued aid to Ukraine. Members of the far-right House Freedaom Caucus, however, roundly rejected calls for supplemental spending, instead insisting on attaching provisions to the CR reducing federal spending. **(CNN, National Low Income Housing Coalition)** 

Hard-right Republicans subsequently added another item to their list of demands: the launch of an impeachment inquiry against President Biden. "I've already decided I will not vote to fund the government unless we have passed an impeachment inquiry on Joe Biden, said far-right Marjorie Taylor Greene (R-GA).

After another hard-right House Member, Matt Gaetz of Florida, warned that House Speaker McCarthy's failure to act on impeaching Biden could cost him his speakership, McCarthy announced on September 12 that he was directing the House to open an impeachment inquiry into President Joe Biden over his family's business dealings, setting the stage for divisive House hearings that could distract lawmaker's efforts to avert a government shutdown and supercharge the 2024 presidential race. **(The Guardian, CNN Reuters)** 

The Senate had bipartisan support for many of its funding measures and hoped to put pressure on the divided House. It advanced a three-bill "minibus" appropriations measure funding the departments of Veterans Affairs, Agriculture, Transportation and Housing and Urban Development, all within budget caps established by the Fiscal Responsibility Act that President Biden negotiated with House Republicans in exchange for raising the debt ceiling earlier this year. Leaders in the Senate suggested a strong bipartisan vote would demonstrate theirs was the path to follow to ensure normal funding for agencies when current funding expired after Sept. 30. (GovExec.com)

Based on consumer price data released in August, the trend toward a 2024 COLA for retirement programs is 3.3%, much lower than the 8.7% 2023 increase. **(My Federal Retirement)** 

**<u>VIRGINIA LEGISLATION</u>**- The Virginia General Assembly passed long-delayed amendments to the two-year state budget on Wednesday, Sept. 6, ending a six-month stalemate and sending the document to Republican Gov. Glenn Youngkin for his signature.

The budget deal, which many in Richmond had worried would not be reached after negotiations briefly collapsed in July, combines major short-term tax reductions with significant one-time and ongoing spending on priorities such as education, behavioral health and pollution reduction investments.

While Republicans praised the plan's emphasis on one-time spending, including almost \$420 million in flexible payments to school divisions, \$200 million to programs to prepare sites for industrial development and \$58 million for expansion and modernization of state crisis services facilities, Democrats applauded the reliance on one-time tax relief in the form of rebates rather than longer-term tax cuts. **(Virginia Mercury)**
