#### PRESIDENT'S MESSAGE

Hopefully I'll remember to cover everything that is important to our chapter and the future.

The October meeting turned out to be a discussion among the executive board about possible scenarios for the future. Unfortunately, a few members who planned to attend the meeting and were just as interested as I was to visit the Louisa Historical Society and the Sergeant Museum had last minute issues and let us know that they would not be able to make the meeting. Our chapter did use the funds in the charity fund supplemented by donations from a few of us to thank the Historical Society for hosting our chapter meeting and to have the chapter recognized on their website and in documentation.

As we've all been aware, the November Chapter meeting is our annual meeting that is required in the Bylaws. The 2022 annual meeting was when the current officers volunteered to try another year to keep the Louisa Chapter going. Along with that we made some adjustments to the scheduled meetings so that members who are current employees could attend a couple dinner meetings and/or those who needed help getting to the meeting could do so. I, for one, don't really feel that these changes have enabled much of an increase in attendance. Thus the 2023 annual meeting finds us in the same spot as last year but with one important change; we **need a secretary as required in our Bylaws.** 

From what I've heard the reason most chapters that have closed do so because no one wants to take on the duties of Chapter Officers. This is definitely not the case for the Louisa Chapter. The only open position is Secretary since Marilyn Root moved to be closer to family. Discussions at the October meeting included a number of options for consideration:

- $\Rightarrow$  Dissolve the chapter
  - O Discussion: None of us really want to see this happen. We've heard from some of you that you enjoy the newsletter even though you cannot make it to meetings. However, the NARFE magazine does provide a lot of the

magazine does provide a lot of the information that is important to us as

retired or active federal employees. There are also several emails that anyone can sign up for that provide information on items/articles relative to federal employees and retirees.

- o If the chapter closes, all members have the option to transfer to another chapter or to become a national only member.
- There is a defined process with steps that have to be taken before a chapter can close. It is a good bit of effort on all parts to complete the process.
- ⇒ Maintain the Louisa Chapter with a reduced number of meetings; possibly 2-4/year
  - This would enable us to continue to keep Louisa as a NARFE chapter name. Possibly step up attendance in that it would be a better opportunity to learn about legislative, service and programs at the meetings.
  - This would require new Chapter Bylaws which Dick Shrum and I have said that we'd take on if this option were chosen.
  - Schedule of meetings would be TBD at this point.
  - Newsletters would only be published with the meeting scheduled.
  - Thoughts with meeting infrequently is that members will forget the meeting.

A large part of that was her coverage of the several permanent exhibits that focus on the Louisa area, including native Americans, the

Revolution and Civil Wars, education, transportation and government, all found in the Sargeant Museum. There is an excellent selection of merchandise available, including books, historic maps, magazines and a variety of memorabilia. As planned, we brought lunch for all chapter members and Katelyn, including soft drinks, water and "fruit juice" (aka Chardonnay), with a choice of sandwiches and salads from Food Lion. If you haven't visited the facility, give it thought and even consider membership. It's an excellent experience and a definite benefit to the Louisa County region.

The November meeting is our annual business meeting, and, as such, no program is planned. Karen has described the agenda and importance in her President's message above. ### NATIONAL LEGISLATION REPORT

Status of the FY2024 Appropriations: **Agriculture (H.R. 4368/S. 2131)** passed the House - 9/28/2023

**Defense (H.R. 4365/S. 2587**) passed the house 9/28/2023

**Energy-Water (H.R. 4394/S. 2443)** passed the house 10/26/202 and is being consider as part of a minibus.

**Homeland Security (H.R. 4367/S. 2625)** passed the house 9/28/2023

Legislative Branch (H. R. 4364/S. 2302)

Military Construction-Veterans Affairs (H.R.

**4366/S. 2127**) passed the house 7/27/2023 and is being considered in the Senate as part of a minbus

State-Foreign Operations (H.R. 4665/S. 2438) passed the house 9/28/2023

Transportation-HUD (H.R. 4820/S. 2437) being considered in the Senate as part of a minibus

An item of note, we are halfway into the Continuing Resolution (CR) that Congress passed at the last minute on September 30 in order to keep the government running. Since the House finally elected a speaker Mike Johnson of LA, they should start moving again. However, there is talk of enacting another CR which could go to Jan 15 of 2024. More to come.

The following are updates on items that we have been keeping track of:

- Social Security Fairness Act of 2023 H.R. 82 and S. 597 – has 298 Cosponsors (201 Democrats, 97 Republicans) and S. 596 has 46 co-sponsors (36 democrats, 7 republicans and 3 independents) Virginia cosponsor representatives remained at 8 plus Senator Kaine is a cosponsor to S. 597.
- With newly elected Speaker of the House, Mike Johnson, and his stance on Social Security, Medicare and Medicaid as America's entitlement programs. Since he has vigorously championed budget resolutions proposing trillions in cuts to these programs., I'll only be updating this item if anything changes.

Consider going to the advocacy page of the NARFE.org website where there are prepared letters on some of the topics discussed above or you can write your own and they will ensure that it is emailed to your representative and senators plus notify you that the e-mail/letter has been sent.
