#### **LEGISLATIVE REPORT** (As of November 14, 2023)

**NATIONAL LEGISLATION**- On Tuesday, November14, the U.S. House of Representatives passed a stopgap measure to avert a partial government shutdown, as wide swaths of lawmakers from both parties showed support for the bill. The short-term legislation then headed to the Senate, where Democratic and Republican leaders have voiced support.

To prevent a shutdown, the Senate and Republican-controlled House had to enact legislation that President Joe Biden can sign into law before current funding for federal agencies was to expire at midnight on Friday, November 17.

The 336-95 vote was a victory for House Speaker Mike Johnson, who faced down opposition from some of his fellow Republicans, in the first consequential vote of his tenure. Republican leadership brought the bill to the House floor under a procedure known as suspension of the rules, which required a two-thirds majority vote to pass.

The strategy was risky, as backlash from some conservatives forced House Republicans to turn to Democrats for votes to pass it as the GOP holds only a narrow majority in the chamber. A number of conservatives opposed the stopgap bill because it does not implement the deep spending cuts that they have demanded.

The stopgap spending bill extends government funding at current levels into 2024. It extends funding for military construction, veterans' affairs, transportation, housing, urban development, agriculture, the Food and Drug Administration and energy and water programs through Jan. 19. Funding for all other federal operations – including defense – will expire on Feb. 2. The proposal does not include additional aid for Israel or Ukraine.

The plan gives lawmakers more time to attempt to negotiate and pass full-year spending bills, though major partisan divisions make that effort fraught and complicated. Johnson argued that his plan would prevent Congress from passing a massive spending bill in December- a scenario that has played out many times before when lawmakers have faced a deadline right before the winter holidays. House Democratic leadership released a statement ahead of the vote saying they would support the stopgap bill. "House Democrats have repeatedly articulated that any continuing resolution must be set at the fiscal year 2023 spending level, be devoid of harmful cuts and free of extreme right-wing policy riders. The continuing resolution before the House today meets that criteria and we will support it," the joint statement from House Democratic leader Hakeem Jeffries and other top House Democratic leaders said. <u>VIRGINIA LEGISLATION</u>- The two-year period before the arrival of Gov. Glenn Youngkin was the first time in decades that Democrats controlled both chambers of the Virginia General Assembly. Come January, they'll be back in charge.

That sets up a policymaking dynamic that hasn't been seen in Virginia since the 1990s: A Republican governor working with a fully Democratic legislature.

Because Youngkin will still be able to veto anything the slim Democratic majorities send to his desk, it won't be anything like the burst of legislative breakthroughs on big topics that Democrats pushed through in 2020 and 2021. With a 21-19 majority in the state Senate and a 51-49 majority in the House of Delegates, Democrats lack the supermajorities needed to override vetoes and enact new laws over Youngkin's opposition.

It's unclear what might top the state's legislative agenda once the new legislature is seated, but the November elections results could mean for a few big policy issues.

Winning both chambers gives Democrats the chance to play offense on abortion rights. At a post-election news conference, abortion rights advocates said they want the new Democratic majorities to begin the multi-year process of amending Virginia's constitution to protect abortion access. Under Virginia's system, constitutional amendments have to pass the General Assembly two years in a row, with an election in between.

Youngkin has portrayed himself as being the vanguard of a parents' rights movement by restoring a preeminent role for parents in K-12 schools that he says have been derailed by left-wing leaders. Democrats have attacked him as an enemy of public education and accused him of stoking culture war fights over critical race theory, sexual content in books and accommodations for transgender students. These fights could very well continue.

Bipartisan efforts to legalize sales of marijuana failed in the last two sessions largely because of the Youngkin administration's quite opposition. Democrats and some Republicans have argued that moving forward with regulated dispensaries is the best way to rein in the booming unregulated market for cannabis products.
