Legislative Corner By Ed Weiler

.. Reigning In our Ballooning Health Care Costs: The Health Care Solutions Summit (HCSS)

In early November I attended the HCSS, a conference sponsored by the Committee for a Responsible Federal Budget (CRFB) and Harvard University's Healthcare Markets and Regulation (HMR) Lab. Implicit in the agenda was an assumption that national health care expenditures are too high, and that the level of waste in the current system is such that there is ample opportunity to bring costs down if we just get the policy right. *(continued on p. 2)*

While this is by no means a new problem, and both government and academic policy experts have been working on it for years, our equally-ballooning Federal debt brings an added sense of urgency to the matter. In the words of Rep. Jodey Arrington (R-TX-19), who chairs the House Budget Committee and also sits on Ways and Means, "Healthcare is the driver of our Federal over-spending."

Not all was doom and gloom, of course, and partial (or tweaking) reforms are indeed possible, such as: >>>the *Site-Based Invoicing and Transparency Act (S. 1869)*, sponsored by Sens. Mike Braun (R-IN), Maggie Hassan (D-NH), and John Kennedy (R-LA). Among other things, this bill would prevent the practice of billing Medicare patients at hospital rates for services rendered in an off-campus outpatient facility or in a doctor's office. This unnecessarily costly practice has been growing in recent years as hospitals buy up individually-owned physician practices.

>>>reigning in payments to Medicare Advantage providers. According to research by HMR, the methodology for determining payment levels to Medicare Advantage to providers (based as it is on the fee-for-service model characteristic of Traditional Medicare) is becoming increasingly outdated as Medicare Advantage attains greater market share among retirees. The end result is often substantial overpayments to these providers. The flood of offers that typically show up annually in our mailboxes during Open Season suggests that HMR might well be on to something.

A more sweeping reform proposed by Rep Bruce Westerman (R-AR-04) should give us all food for thought. Under a bill he submitted last year in the 117th Congress (*The Fair Care Act—H.R. 8588*), the Federal Government would fund a Health Savings Account (HSA) for individuals who could then use such funds to purchase insurance on their respective state-based health care exchange (i.e., so-called Obamacare). As one element designed to broaden the risk pool in the exchanges, *Section 114* of the bill would eliminate FEHBP eligibility for all Federal **employees**, and instead fund them with an HSA which they could also use to purchase coverage on their state exchange. The dollar amount of HSA funding would be benchmarked to the cost of the second-lowest cost Silver Plan within an employee's Zip Code.

Perhaps you noticed that *Section 114* covers employees, but appears to be silent on Federal annuitants. Should any legislation embodying this provision ever come to pass, my speculation (and it is purely that) is that Congress would simply force all Federal retirees into Medicare Part B, in the same way it did to Postal employees a few years ago. For many Federal retirees this might not be all that jarring, since nearly two-thirds now participate in Part B. Moreover, with prodding from OPM, there is a growing convergence between the FEHBP and Medicare. For those retirees subject to the Income-Related Monthly Adjustment Amount (IRMAA) provisions in both Medicare Parts B and D, however, this change could be quite costly.

Just to be clear, the *Fair Care Act* has **not** been introduced in the current session of Congress (the 118th); and so far as I know, there is no active consideration on the Hill of *Section 114's* provision regarding Federal employees. That said, in view of the looming debt crisis, and given health care's significant contribution to the problem, Congressional action in this domain is quite likely. Somewhat ominously, this is often the sort of political climate in which an idea thought to be off the table suddenly comes back around. As former NARFE Legislative Director, Dan Adcock was fond of saying: Remain vigilant!

Pending Legislation to Establish a Bipartisan Fiscal Commission

Recently, two bills have been introduced in the House (*H. R.* 5779) and Senate (*S.* 3262) that would establish a bipartisan commission to make recommendations for legislation that would ensure that the level of Federal debt would not exceed the national GDP---a level deemed to be "sustainable." While there are some differences between the two bills with regard to the specific charge to such a Commission, its primary focus would be on discretionary appropriations. *(continued on p. 3)*

While the Trust Fund programs (*e.g.*, Medicare) are also included, the Commission's charge is restricted to recommendations (but not legislation) that would improve solvency for at least a 75-year period.

Although it is still early days in this story, don't be surprised if a commission along the lines prescribed in either of the above-mentioned bills actually becomes law. And if such comes to pass, stay tuned to the "advocacy" page on NARFE's website. To be sure, we all should bear our fair share of the pain that will inevitably accompany any meaningful attempt to rein in the national debt. But in too many instances in the past, soft targets like us have been the first to face the firing line.
