REPORT ON NOVEMBER 14TH CHAPTER MEETING – CHRIS GIESELER

Kathy introduced two new Chapter members: Eugenia Bodnar and Nancy DeVera.

Treasurer Dave Graf introduced our guest speaker, Dr. Kelsey Trinka (pictured here). She is a licensed and certified audiologist and since 2018 has worked at Hearing Associates of Northern Virginia, located in McLean. Dr. Trinka explained that she believes in providing personalized care to find solutions regarding a patients' hearing loss. She also does work with cochlear implants. Her advice: be your own advocate when you are not hearing well!

Dr. Trinka discussed the prevalence and causes of hearing loss, emphasizing its impact on individuals' daily lives and its impact on communication. Additionally, she provided valuable insights into the multi-faceted aspects of hearing loss, the solutions available through hearing aids and cochlear implants and the <u>essential role of</u> early intervention.

LEGISLATION REPORTS

National Legislation – Jim Hathaway

2024 Employee Pay Raise. The temporary budget extension carrying funding for federal agencies—some to January 19 and others to February 2—virtually guarantees that federal employees will receive an average 5.2 percent raise in January (0.5% to be designated for locality pay).

That would be the largest since an increase of 9.1 percent in 1980 and would be 0.6 percentage points above the average 4.6 percent raise paid in January of this year, which had been the largest since an average increase of 4.6 in 2002.

The 5.2 percent average figure has been the most likely for 2024 through the course of the year, after President Biden proposed it in his budget submission and Congress started writing spending bills with no mention of a raise. Under the pay law, if Congress does not enact a figure by the end of the calendar year, the President can set the recommended figure by default.

The locality adjustment is based on findings of pay gaps in more than four dozen areas with their own rates, as reported by the Federal Salary Council. Also, effective in 2024 four new localities (Fresno, Calif.; Reno, Nev.; Rochester, N.Y.; and Spokane, Wash.) will be created and the boundaries of most current localities will be expanded. These actions will provide an additional pay boost to about 16,200 employees in the new localities and about 17,100 employees in areas to be added to existing localities.

Effort to Repeal WEP and GPO. The House Ways and Means Committee held its first hearing in years on the two provisions, dubbed the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO). Backers are hopeful the panel will take up bills to get rid of the laws as a next step in 2024. To force a vote on the House floor, a bill must be placed on the "consensus calendar," a step that so far has not been taken.

Lawmakers enacted the WEP and GPO provisions in the late 1970s and early 1980s to make sure that public employees like state government workers, firefighters, police and teachers do not get unfairly high Social Security payouts.

The intent was to prevent these public sector employees from "double dipping" — receiving both their own government pensions as well as full Social Security benefits, even though they didn't fully pay into the Social Security system via payroll taxes during their careers.

A majority of lawmakers are on board with overturning the laws, which they say dock benefits too severely, make it harder for public workers to retire comfortably and create a disincentive to enter public service.

Those arguing against repealing WEP and GPO say it would be costly and possibly grant unfairly high benefits to some retirees. They contend that a new formula is needed to avoid draining Social Security's retiree trust fund even sooner as it faces insolvency in the coming decade. The Congressional Budget Office estimated last year that removing WEP and GPO would cost \$183 billion over a decade and make Social Security unable to fully fund benefits about six months sooner.

One bill to overhaul the WEP and GPO would replace it with a new formula based on how much of a career the beneficiary spent working in Social Security-covered jobs. Even with the House Ways and Means Committee taking up the issue and a speaker, who's been an ally in the past, the panel's top Democrat said the cost remains a critical hangup.

State Legislation - Chris Gieseler

The VFN 2024 State Legislative Plan. The Virginia Federation of NARFE (VFN) has released its Virginia 2024 State Legislative Plan for distribution to VFN chapters. The Plan sets forth the VFN's Legislative priorities for the upcoming Regular Session of the Virginia General Assembly. The four priorities are:

- Exempt a segment of Civil Service Retirement System pensions equivalent to Social Security Retirement benefits;
- Extend the Virginia age deduction by eliminating the current income-level requirement;
- Enact a Family Caregiver Tax Credit;
- Address certain nursing-home priorities.

The plan was developed by the VFN State Legislation Team for submission to, and approval by, the VFN Board of Directors. The plan will be shared with members of the Virginia General Assembly, which meets January 10, 2024.

The 2024 General Assembly. This is an update from retiring VFN State Legislation Chair Debbie Fisk:

Almost half of the newly elected Virginia Senate arrived in Fairfax County on November 15, 2023, for a "first day of school" on the state budget, as 17 newly elected senators prepare to take office in January and replace veteran leadership transformed by retirement and political defeat. Nowhere is the generational change of leadership more apparent than on the Senate Finance & Appropriations Committee, which is losing nine of its 15 members, including its co-chairs. The three-day retreat began with what retiring Senator Tommy Norment (R-James City) described as an "extraordinary" tutorial on the state budget by April Kees, the committee's staff director.

One of Kees' first lessons for new senators was the separation of powers between the governor and legislature, especially in adopting a two-year budget in even-numbered years and revising it in odd-numbered years. Governor Youngkin will propose a new two-year budget on Dec. 20 for the newly elected General Assembly to revise and adopt in a 60-day session that will begin January 10. The budget that the new legislature adopts will be in place from July 1, 2024 through June 30, 2026.

The senators got a full overview of projected revenues and costs in a presentation by Kees on November 16. The House Appropriations Committee already has sounded an alarm about the state's overreliance on multibillion-dollar year-end surpluses in the last three fiscal years, as emergency federal aid during the COVID-19 public health emergency disappears.

In the House committee's budget retreat held on November 14, 2023 in Richmond, Staff Director Anne Oman said projected revenues barely exceed the base operating budget of state government in the general fund, which relies on income, sales and other state taxes. Youngkin and the General Assembly will have some money to spend because of continued revenue and money carried forward from the current fiscal year, but they also face more than \$2 billion in mandatory spending obligations, primarily for K-12 public education and the state's Medicaid program of health care for more than 2 million elderly, disabled and low-income Virginians.

This all seems like an overwhelming amount of information to absorb, even for the 11 newly elected senators who previously have served in the House or Senate. Retiring Senator Dick Saslaw (D-Fairfax) commented that "for a lot of these new people, this seems like drinking from a fire hose, it's a learning process".
