Defense Bill Could Be Year's Last Vehicle for Federal Workforce Policy Changes

With continued funding in place for federal agencies until early in 2024, one of the last major items in line for attention for this year is the annual defense authorization bill, which often serves as the vehicle for federal workplace policy changes, both at DoD and government-wide. TSP Summarizes Changes in Place and ahead Starting in January

The TSP has posted a summary of current and upcoming policy changes under the Secure 2.0 law enacted late in 2022 affecting itself and other similar retirement savings programs, including a change effective in January regarding required minimum distributions for retirees age 73 and above.

"Beginning in 2024, Roth balances will no longer be subject to RMDs prior to a participant's death. Your RMD calculation will include only your traditional balance, and only distributions from your traditional balance will count toward satisfying the RMD amount. If you have a Roth balance in your TSP account, this means your 2024 RMD amount may be less than it would have been," it says. Still Much to Do to Speed Up Processing of Retirement Applications, Says IG

OPM "has not made significant progress" in addressing the issues identified in a 2019 GAO report underlying delays in processing federal employee retirement applications, an OPM inspector general report has said.

The report comes just ahead of the annual surge in retirement applications around the turn of the year which causes a spike in the backlog at OPM, which commonly takes months for the agency to work down. The length of the processing time—during which new retirees receive only partial, estimated payments, with the difference made up when the adjudication is finalized—has been an issue for many years. TSP: Strong November Returns to Be Thankful For

All TSP stock-based funds produced strong gains in November, led by the small company stock S fund, up 11.19 percent, with the large company stock C fund up 9.12 percent and the international stock I fund up 8.54 percent.

Those funds are up 13.44, 20.76 and 12.33 percent, respectively, year to date. The bond F fund gained 4.51 percent in November and the government securities G fund 0.41 percent, for year to date gains of 1.79 and 3.82 percent.

The November returns for the Lifecycle L funds were: Income, 2.81; 2025, 3.67; 2030, 5.88; 2035, 6.44; 2040, 6.97; 2045, 7.44; 2050, 7.88; 2055, 2060, 2065, 9.14. They are up from 6.99 to 16.75 percent year to date.
