# FOOD FOR OTHERS

In December we collected 336 pounds of food and \$100 in donations for "Food for Others". Needed items include: **Food Items** (no more than 3 years expired, unopened, labeled, not homemade):

- Fresh fruits (oranges, apples, bananas, tomatoes, avocados, grapes, berries)
- Fresh vegetables (cucumbers, celery, peppers, lettuce, eggplant)
- Cooking Oil
- Dry goods cereal, pasta, rice, (16oz packages), dried beans
- Canned vegetables tomatoes (crushed, peeled, diced, etc.), beans, corn, etc.)
- Canned meat (chicken, turkey, or seafood), 2oz 15oz
- Canned fruit (packed in fruit juice instead of syrup) 11oz 20oz
- Spaghetti sauce, 14oz 1 lb (ideally in cans or plastic instead of glass)
- Fruit juice (100% juice) 32oz 64oz
- **Perishable Food** (Meat and Dairy unexpired, sealed, in original packaging):

**Non-Food Items (**New or Clean Reusable Grocery Bags 8 1/2 x 14 x 15 and can openers)

This month the chapter collected 336 pounds of dry and canned goods and \$100 in donations for Food for Others.

# LEGISLATIVE REPORT

(As of December 14, 2023)

**NATIONAL LEGISLATION-** For the first time in ages, Congress isn't facing a Christmastime shutdown threat. But the 2024 fight is going to be even worse than usual.

House Speaker Mike Johnson may have saved Christmas on Capital Hill, but Congress will be paying for it in the new year.

For the first time in roughly a decade, Washington faces no government shutdown in December. After Congress narrowly averted a government shutdown at the end of September by passing a stopgap continuing resolution extending the budget deadline to November 17, President Biden signed a second stopgap continuing resolution authored by Speaker Johnson on November 16 that is "laddered," consisting of two separate expiration dates for two expiration dates for two separate sets of appropriation bills, extending funding into 2024.

The first expiration date in the new continuing resolution, January 19, applies to the programs covered by the Agriculture, Energy-Water, Military Construction-VA, and Transportation-HUD bills. The second expiration date, February 2, applies to the programs covered by the Commerce-Justice-Science, Defense, Financial Services-General Government, Homeland Security, Interior-Environment, Labor-HHS-Education, Legislative Branch and State-Foreign Operations bills. Besides extending appropriations, the measure also includes several policy extensions through January 19 for certain health care programs and a farm bill extension through FY 2024.

The House and Senate are far from off the hook. Johnson has promised he won't put another "clean" funding bill on the floor, increasing the chances of a shutdown after the next spending deadlines on Jan. 19 and Feb.2. The House GOP is so bitterly divided that some lawmakers worry they'll engage in the same last-minute self-sabotage that plagued them this fall.

Congress already punted on spending twice this year. Many lawmakers see no reason it'll be any different in January. Johnson has ruled out another so-called clean stopgap spending bill, or continuing resolution that doesn't include any blanket cuts to government funding. That means Congress has only a few weeks of session to reconcile divergent spending levels on 12 different bills- the House GOP wants lower spending than most senators- and then steer identical legislation through both chambers.

And without a cross-Capitol agreement on top lines- the overall amount of spending- the House and Senate can't even negotiate the less controversial areas, like money for veterans and military construction. **(POLITICO)** 

Republicans and Democrats are still negotiating a massive foreign aid and security bill, reauthorizing the annual defense authorization bill and reauthorizing the national security surveillance measure.

Bipartisan negotiators were at loggerheads over a sprawling plan to send security assistance to Ukraine, Israel and the Indo-Pacific while also shoring up law enforcement at the southern border. Republicans were largely supportive of sending aid to America's allies, but looked to extract steep concessions from the White House and Democrats on border security.

Republicans also planned to vote on formalizing an impeachment inquiry into Biden over still-unproven claims that he improperly benefited from his family members' business ventures overseas. **(ABC News)** 

**VIRGINIA LEGISLATION**- The 2024 Regular Session of the Virginia General Assembly convenes at 12 noon on Wednesday, January 10, 2024 and is scheduled to finish (or adjourn sine die) on Saturday, March 9, 2024.

On November 20, lawmakers dropped the first bills that will be up for consideration. Much more is yet to come as Democrats and Republicans jockey for ways to realize their key priorities. on everything from hot-button issues like abortion access to the more bread-and butter legislation. Democrats will have control of both the House and Senate, but the slimness of their majorities means they aren't guaranteed to get everything they want.
