<u>Legislation Report</u> – Federal Budget: The Federal Government is still operating



through a set of Continuing Resolutions (CR) which have early 2024 expiration dates: January 19, 2024 pertains to the programs in the Agriculture, Energy-Water, Military Construction-VA, and Transportation-HUD bills; February 2, 2024 pertains to the programs

in the Commerce-Justice-Science, Defense, Financial Services-General Government, Homeland Security, Interior-Environment, Labor-HHS-Education, Legislative Branch and State-Foreign Operations bills. The new Speaker of the House has indicated that he won't put another "clean" funding bill or CR on the floor, which increases the chance of a full or partial government shutdown shortly after the House returns from the Holiday recess. Stay tuned.

Virginia Legislation- The 2024 Regular Session of the Virginia General Assembly



convenes January 10, 2024 and is scheduled to finish (or adjourn *sine die*) on March 9, 2024. During this session, our Governor will be submitting his 2-year Budget Request. Hopefully, there will be enough common ground in that request for meaningful progress on Virginia's

Budget.

VFN 2024 State Legislative Plan -- The Virginia Federation of NARFE (VFN) has



published its 2024 State Legislative Plan on the VFN website (https://www.vanarfe.org). Two items in the plan pertain to State taxation of CSRS Annuities. First, the VFN is asking that

the State exempt a portion of CSRS Annuities from State Taxation: The current Virginia Tax Policy disadvantages CSRS annuitants by taxing all of their CSRS annuity while the State does not tax Social Security payments, and we believe that a portion of the CSRS Annuity equates to Social Security. And, second, the VFN is asking that the income restriction be lifted on the Age 65+ Deduction, recognizing the current calculation of "income" unfairly disadvantages CSRS annuitants who must include all of their annuity as income in the computation, while Social Security recipients exclude (again) Social Security from their income. We are hoping to see some form of legislation proposed in the General Assembly for one of both of these issues.

<u>Get to Know Your Board</u> – We are resuming our series highlighting our Annandale Chapter Board Members. This month we feature **Phil Gilliland**, our Chapter Alzheimer's Chair:

I was born in Kansas and my parents farmed in Northwest Kansas before and during the Dust Bowl days and the Great Depression. Due to those two events, we moved to Texas in 1936 in a Model T Ford Touring car. My dad found work as a route man for a bread company and worked for them until he died in 1939. We moved back to Northwest Kansas where Dad's and Mom's parents both lived. We lived there until 1943 when we moved to Central Kansas for Mom's job with the U.S. Army. Mom never re-married and lived in Kansas until her death in 1998.

I have a sister and two brothers; older brother and sister, younger brother. They are all still alive and living in Colorado, Oregon, and California, respectively. My older brother was a nuclear engineer, working for General Electric; after her kids went to college, my sister worked for the State of Oregon; my younger brother was an M.D., in family practice. I have been married just over 63 years. We have a son, who lives in Clifton and has three children. He works as a Civil Engineer in his own company.

I have a B.S. in Math Education and an M.S. in Statistics, both from Kansas State University. I worked for the U.S. Government in three separate agencies as a Mathematical Statistician for a total of 30 years. After retirement, I sought standing from the Christian Church Capital Area Commission for Ministry to be a Lay Minister, later Commissioned Minister. In 2012, I began my studies at Wesley Theological Seminary, and received an M.A. in May, 2014. I was ordained into the ministry of the Christian Church (Disciples of Christ) on February 3, 2019. I have been a member of the First Christian Church, Falls Church, since November, 1966.

<u>Community Corner</u> – As the Washington Post recently reported, there is a much greater need for volunteers than there are volunteers. A few hours of volunteering per month can make a difference for the volunteer as well as the recipient. Below are two, among many, opportunities to volunteer.

<u>Volunteers Needed to Teach Basic Computer Skills</u> – Computer C.O.R.E needs volunteers to teach basic computer skills to adults via Zoom or serve as a "Zoom Administrator." They provide the necessary tools and training. This is an all-virtual volunteer role. The time commitment is one hour per week, 6 to 7 p.m. or 7:15 to 8 p.m. for ten-week terms – January-March, April-June, and September-November. They will accommodate vacation schedules using substitute teachers (another volunteer role). Other roles are available. For more information, go to www.computer.org/volunteer.

<u>Volunteers Needed for Income Tax Assistance Program</u> – The Volunteer Income Tax Assistance Program provides free tax preparation to qualified people in Northern Virginia. The Fairfax County Department of Family Services needs volunteers to act as greeters, interpreters (including ASL), screeners, tax preparers, online tax coaches, social media outreach and IT support. Free training (classroom and on-line) is available for screeners and tax preparers. Opportunities are available throughout Fairfax County, with flexible schedules, including evenings and weekends.
