#### **LEGISLATION**

#### **Federal**

The Senate returns to business on 1/8 and the House on 1/9. They'll have just 10 days to avert a partial government shutdown. The first deadline is January 19. Funding for the rest of the government expires on February 2. Negotiations continue between Senate majority leader Chuck Schumer and Speaker of the House Mike Johnson. According to Forbes Magazine online, the event forecasting site Kalshi puts the chance of a January shutdown at around 35%.

The Social Security Fairness Act of 2023, The Social Security Fairness Act, <u>H.R.82/S.597</u> would fully repeal the WEP and GPO. H.R.82 has 301 co-sponsors. S.597 has 49 cosponsors including Senator Tim Kaine.

Frances and I met with Delegate Sam Rasoul in December and presented him a \$500 check for his campaign fund for his continuing support of NARFE legislative issues. The check is from the VFN Pac Fund.

#### JANUARY 2024 MEETING MINUTES

NARFE Roanoke Valley Chapter 111, Area VII, met on Friday, January 5, 2024 at Jersey Lily's restaurant. Frances Boatman, President conducted the meeting. The meeting was called to order at 11:47 a.m. with 29 people in attendance including three guests and our guest speaker. A quorum was present to conduct chapter business.

January birthdays were recognized.

Dr. Leon Vinci, CDL District 6, passed out an article about repealing the WEP/GPO bill published in the Richmond and Roanoke newspapers. Leon is Advertising Chair for the VFN Convention. The chapter buys an ad each year. Leon suggested we have a second, full page ad with Frances.

Wanda Ware spoke on New Year's Resolutions and led us in the Pledge of Allegiance.

The Secretary's minutes for the December 2023 meeting were approved as published by acclamation.

Ellie Long, Secretary, announced we will collect food for LOA's Soup for Seniors program at the February meeting. Distinguished Service Citations were presented to Alpha Sue King and Phyllis Scruggs.

Mark Fisher gave the December 2023 treasurer's report. In his role as Service Officer, he discussed his problems with the new Open Season Health care plans. He has copies of Be Prepared for Life's Events and offered them to new members.

Carolyn Tucker, 1<sup>st</sup> VP, gave the membership report. Currently there are 154 chapter members. Welcome to new members Sue Bowyer, Jane Compton, Elisabeth DuBerry, and Samuel Hubbard.

Karen Simmons,  $2^{nd}$  VP, thanked Wanda for assisting with the Holiday luncheon games

Bill Ketron gave the Legislation report.

Frances gave the President's report.

Guest Martha Hooker, Chair of the Roanoke County Board of Supervisors spoke briefly on the importance of advocacy and staying involved in the legislative process.

Guest Doris McAdams, VFN Public Relations Chair, urged attendance at the VFN Conference and to follow her <u>NARFE Virginia Federation | Facebook</u> page.

Our guest speaker was Dwayne Yancey, Executive Editor of Cardinal News, a nonprofit, nonpartisan news organization serving Southwest and Southside Virginia. They are also active on multiple social media platforms. He spoke on the Changing Nature of Media Landscapes. Nationwide there are fewer journalists to cover local and state news. (No newspapers in Virginia have a dedicated person(s) to cover the General Assembly.) Newsrooms are a third of the size they were 20 years ago. Why? Consumers prefer getting news online. Newspaper's income is 85% from advertising, 15% from subscriptions. Over 20 years ad revenue is 1/5 of what it once was. Advertising revenue has gone away. Local advertising now goes to social media which better targets people interested in their products. With less revenue, expenses, primarily staffing, are reduced. This has happened nationwide. Small newspapers in Virginia have ceased publishing, including online. The newspaper industry has failed to adapt to technological change. Interest in news hasn't gone away, the delivery system has changed. The local daily newspapers are most impacted. Big papers benefit as they can sell and deliver subscriptions worldwide.

To fill the gap, there has been a rise of non-profit online news sites. Currently there are 425 such sites and this is where industry growth is taking place. These sites have no pay wall and are funded by multiple revenue streams. Mr. Yancey sees nonprofits becoming more prevalent over time.

Cardinal News is all virtual. Its goal is to build a business model with five revenue streams; newspapers have two. It is funded through donations, grants, philanthropy, sponsorships, and events. Their coverage is specific to Southwest and Southside Virginia politics, economy, culture, education, technology, and health care. They have five free newsletters available to readers on either a daily or weekly basis.

During the Q&A session, it was mentioned research has shown subscribers want a newsletter delivered to them daily. Pay walls limit the online growth of newspapers. Newspapers once locally owned or by publishing companies are now owned by media corporations or hedge funds. This provides fewer choices for stories.

The 50/50 (Alzheimer's Fund) drawing was won by Wanda Ware. The gift basket drawing was won by Phyllis Scruggs.

The meeting was adjourned at 1:54 PM.
