PROGRAM

At our February meeting, the program was "Everyone Speaks!" and all our attendees spent a little time on their topic of choice. For me, it was enjoyable to go back to growing up on Lake Erie, graduating from the USCG Academy, a Bermuda yacht race, years on and off ships, duties with maritime organizations, and such until retirement from my paying jobs. With my move to Lake Anna, it all shifted to the local waters, teaching the boating safety course, and becoming a member of the CG Auxiliary, LACA water quality monitoring, and a LAAC member for Louisa County, all with the sunrise over the lake waking me each morning. And now to April... Even with our smaller number of attendees, I have arranged for an outstanding local organization and expert to attend our meeting and discuss matters of great importance to Louisa County and to each of us individually. The speaker will be Sergeant Chuck Love of the LC Sherriff's Office, who spoke to us a couple years ago. He will cover many of the current LCSO programs: animal control, apps and alerts, law enforcement academy and adventure program, chaplain corps, LCSO Foundation, project lifesaver, and the many youth programs and benefits. Of note is their SHIELD Program, a community-focused policing method to counter crime, threats, and even terrorism by engaging community members and partners. Finally, we will cover

the local Most Wanted List, but I've confirmed that not a single chapter member is on the list. Please consider attending the meeting and bring your questions with you.

Regarding future programs, the June meeting will provide a follow-up report on this year's medical assistance trip to Uganda from Bob Maher and his team in Palmyra. This fall, we will have a medical insurance expert to provide guidance on changes to the system and particular information for Federal retirees. We are always appreciative of any ideas or suggestions you may have, and in the meantime, stay warm!

NATIONAL LEGISLATION REPORT

On February 29th Congress passed a 4th Continuing Resolution (CR) to once again work on the 2024 appropriations bills. They also announced that they reached an agreement for 2024. The CR was again staged in 2 phases, but the areas in each stage had changed; they are:

Since we are past March 8th, the status of H.R. 4366, the "Consolidated Appropriations Act, 2024," covers Agriculture, Commerce-Justice-Science, Energy-water, Interior-Environment, Veterans Affairs-Military Construction, and Transportation-HUD was signed by the President and provides full-year funding through September 30, 2024.

The remaining appropriations are still being worked since there are issues with funding for the Department of Homeland Security. Release of text for the complete sixbill package is now expected Monday March 18th at the earliest. This puts Congress on a compressed timeline to clear the legislation before Friday March 22nd, when deadline #2 comes up.

The issues with Homeland Security bill include two major areas of contention; Republicans' desire for more funding for Immigration and Customs Enforcement detention bed capacity, and Democrats' push for more money for Transportation Security Administration pay raises, as TSA workers were historically paid less than those at other agencies.

The following are updates on items that we have been keeping track of:

Social Security Fairness Act of 2023 H.R. 82 and S. 597 -Co-sponsors have increased to 310 in the house (204) Democrats, 106 Republicans) and 53 in the senate (41 democrats, 9 republicans and 3 independents).

The other bills related to Social Security are H.R.4583/S.2280-Social Security 2100 Act.

For FY 2025 which starts 1 October 2024, the President, in his budget, has proposed a 2% pay raise for current employees. It will be many months before we know the

results of this proposal.

Consider going to the advocacy page of the NARFE.org website where there are prepared letters on some of the topics discussed above or that are important to federal employees/retirees. You can write your own letter/e-mail and they will ensure that it is sent to your representative and senators plus notify you that the e-mail was sent. NARFE also gives you the ability to send comments to your representative and senator using Twitter ("X") if that is your preference. These topics include Saving the Civil Service Act, Long Term Care Premiums, Equal COLA,
