## MEMBERSHIP NEWS 1241 DULLES Membership Report

As of March 1, 2024

At the beginning of March we have 285 Chapter Members and 506 National Only members in our chapter area. This reflects a slow but steady loss of members. Every month we experience a net loss of about 3 members. National only membership also is experiencing attrition. Our chapter appears to be doing better than many in the state, but our long-term prospects are poor.

We need to recruit more new members, reinstate members who recently were dropped for non-renewal or our future is bleak. Everyone needs to look at their friends and associates to find recruits and reach out to others who used to be members and attend luncheons. Data from the National membership database for last month show that we have one New Chapter Member, Elizabeth Westgate who lives in Broadlands, VA.

Several current Members have been dropped for Non-Renewal. Gary L Klinedinst of Hillsboro, VA; Eugene Sullivan of Reston, VA; Darrell Breed of Sterling, VA; Gary D Martin, of Chantilly, VA; and Shirley Boning of Ashburn, VA.

The delay in processing by National may result in some of these being reinstated, but if you know them contact them and ask if it is an oversight.

## **LEGISLATIVE NEWS**

At this point it looks like the federal government has avoided another shutdown. The House Oversight Committee, which produces much of the legislation affecting federal employees and retirees, has produced little substantive legislation this session, preferring instead to pursue highly partisan investigations. Gerry Connolly and others have sponsored a number of bills supported by NARFE, but unfortunately they remain stuck in committee.

To overcome some of this gridlock, please consider donating to NARFE-PAC to support some of the legislators, like Gerry Connolly and Tim Kaine, who support NARFE goals.

Our local representatives, including Jennifer Wexton and Gerry Connolly, have brought notable infrastructure monies to Loudoun and Fairfax Counties, including substantial improvements to Dulles Airport.

Meanwhile in Virginia the House of Delegates and the State Senate are expected to go into special session to reconcile their respective budgets. Senator Jennifer Boysko, now a member of the Finance Committee, will be among the budget negotiators.

The Alexandria Arena is of many parts and has been the elephant in the room this session. Last I heard, there were many unresolved issues between the House, Senate, and the Governor. On this issue and many others, it is still unclear whether the governor will amend or veto significant bills coming to his desk from the General Assembly.
