Legislative Corner By Ed Weiler

NARFE Calls Upon All Members to Oppose Bills to Establish New Fiscal Commission (*H.R. 5779* and *S. 3262*)

It's back to the future on Capitol Hill. Who could forget those dark days back in December 2010, when the *National Commission on Fiscal Responsibility and Reform* launched its official report, "The Moment of Truth,"

with its proposed cuts in benefits for Federal workers and retirees (e.g., "voucherization" of the FEHBP)? While most of these proposed cuts never happened, the Commission's deliberations led to passage of the *Budget Control Act* in 2011, which set the stage for budget caps and years of heated wrangling on Capitol Hill over appropriations.

With the passage of time, the budget fights subsided to a low boil, albeit with periodic flare-ups. Yet, as noted in this column back in October 2023, Congress has not been able to resolve the Federal Government's deteriorating fiscal position. Instead, what has evolved (according to a *Wall Street Journal* article of 9/14/23) is a, "---tacit, politically popular consensus [that] keeps tax revenue as a share of the economy either flat or declining, while spending's share rises, [the result being] a permanent budget imbalance that both parties bemoan but neither seems eager to change."

It is precisely this inability of Congress to come to grips with the Federal Government's deteriorating fiscal position that has led once again to a call by some for a fiscal commission, as provided in *H.R.* 5779/S.3262. But before going further, a reality check is in order. Do we in fact have a dire fiscal problem? If one can believe the estimates coming from a Feb. 2024 Congressional Budget Office (CBO) report, we certainly do. As summarized in a recent e-mailed newsletter from the Committee for a Responsible Federal Budget (CRFB, 2/20/24): "Budget deficits are projected to grow from \$1.7 trillion in FY23 to \$2.6 trillion by 2034, according to CBO's latest projections. Nominal spending will rise from \$6.4 trillion this year to \$10.1 trillion by FY34, and 84% of this growth can be explained by increased spending on health, social security, and net interest."

Given the enormity of this looming fiscal challenge, forestalling the establishment of a fiscal commission might prove to be a heavy lift on the Hill. However, as NARFE rightly points out in a recent Advocacy Alert (see: www.narfe.org/advocacy), recourse to a fiscal commission is tantamount to an outsourcing of Congressional responsibility (and by extension, accountability). Nevertheless, the aforementioned stalemate between the tax-cutters and the program-spenders argues for an *ad* hoc workaround outside of Congress, hence the appealing logic of an independent commission.

So where does this leave us? Even if our efforts to prevent the establishment of a fiscal commission should fail, forceful advocacy in this regard will put our Congress(wo)men and Senators on notice that the benefits of Federal workers and retirees should not be used as a slush fund for any scheme to right the fiscal ship.

As a footnote, it's worth mentioning that one of the nine original co-sponsors of *S. 3262* is Virginia Sen. Mark Warner. Moreover, his co-sponsorship appears to be consistent with the fact that he has yet to sign on as a co-sponsor of *S. 597*, which is the Senate's companion of the House's bill for full repeal of the WEP-GPO (*i.e.*, *H.R. 82*). Presumably, fiscal worries are at issue in both instances. I point this out, not to malign Sen. Warner—in fact he has been a supporter of Federal workers and retirees over the years I've been writing this column. At the same time, as a member of the Senate Finance Committee, however, Sen. Warner must juggle a vast array of competing demands for Federal resources. Thus, in any bill that might spring from a fiscal commission, should one actually be established, our job is to help him strike the **right** balance.

March is NARFE -PAC Month

NARFE-PAC (Political Action Committee) is the best way for you to support Fed-friendly candidates running for Congress. Last year over 13,000 NARFE members contributed over \$750,000 to NARFE-PAC. This included 394 Virginia NARFE chapter members who contributed over \$29,000. Our own Chapter 7 had 24 members who contributed over \$2,800. These funds provided support to several Virginia lawmakers including Senator Tim Kaine, Rep. Gerry Connolly and Rep/ Jennifer Wexton. *(continued on p. 3)*
