MARCH PROGRAM MEETING

Staff members from the U.S. House of Representatives Honorable Gerald Connolly's office provided a presentation on their efforts for constituents. Mr. Chatmon (Community Engagement Representative) and Ms. Malik (Constituent Services/Field Representative) said many constituents have Social Security Administration issues. They have a priority number with SSA to call and get answers for district residents but they sometimes wait on hold 2 hours before they get an agent to help resolve constituent problems. They fielded a list of complaints from chapter members on the budget process, continuing resolutions, the postal service and Department of Defense support.

FOOD FOR OTHERS

Don't forget to bring your food donation to be taken to "Food for Others" to help those not so fortunate in Fairfax County. At the last two Chapter meetings we collected 130 pounds in February and 145 pounds in March. Lets keep increasing the amount collected.

Needed Food Items (no more than 3 years expired, unopened, labeled, not homemade):

- Fresh fruits (oranges, apples, bananas, tomatoes, avocados, grapes, berries)
- Fresh vegetables (cucumbers, celery, peppers, lettuce, eggplant)
- Cooking Oil (ideally in cans or plastic instead of glass)
- Dry goods cereal, pasta, rice, (16 oz packages), dried beans
- Canned vegetables, meat (2oz 15oz), and fruit (packed in juice 11 oz 20 oz)
- Spaghetti sauce, 14 oz 1 lb (ideally in cans or plastic instead of glass)
- Fruit juice (100% juice) 32 oz 64 oz

LEGISLATIVE REPORT

NATIONAL LEGISLATION - The Senate, on Friday, March 8, approved a funding package to set spending levels for some agencies for the rest of fiscal year 2024, sending the measure to the president just hours before a partial government shutdown was set to begin.

The \$460 billion "minibus" – which contains funding for the departments of Agriculture, Energy, Housing and Urban Development. Transportation, Veterans Affairs, Interior, Commerce and Justice, as well as the Environmental Protection Agency and some other agencies – will now become law after the House of Representatives passed it earlier that week. The measures will force many agencies across government to absorb modest cuts relative to their current funding levels, though overall non-defense discretionary spending will remain flat.

The Senate had to manage its typical high-wire act ahead of the vote, with Republicans demanding action on a series of doomed amendments.

Appropriators next faced a March 22 deadline, turning their attention to a second package featuring six of the 12 annual spending bills Congress must pass each year. House Republicans touted that in the first package they achieved cuts across agencies including EPA, FBI and Bureau of Alcohol, Tobacco, Firearms and Explosives, though after accounting for one-off projects in fiscal year 2023 and supplemental funding through previously passed laws, the reductions are not a significant as initially advertised.

Republicans also noted that, despite President Biden authorizing a 5.2% pay bump for federal employee salaries that went into effect Jan.1, the approved "minibus" did not include increased spending for federal employee salaries for the current fiscal year. That will require agencies to absorb those personnel costs elsewhere in the budget, they said.

Democrats boasted that they staved off the larger cuts Republicans had sought and secured funding for key priorities, including hiring air traffic controllers at the Federal Aviation Administration, maintaining pay raises for federal firefighters and adding mental heath care professionals at the Veterans Administration.

House Appropriations Committee Ranking Member Rosa DeLauro, D-Conn., said she was hopeful appropriators would meet the March 22 deadline for the second minibus, potentially including thornier parts of the government such as the

Homeland Security Department.

Senate Majority Leader Chuck Schumer, D-N.Y., was similarly optimistic, though he cautioned partisan differences could still derail progress. (**Government Executive**)

<u>VIRGINIA LEGISLATION</u> - The Democratic-controlled General Assembly wrapped up its 60-day session on March 9 with a snub to Gov. Glenn Youngkin's plans for a \$2 billion sports arena, one day after the Republican signed legislation to ensure same-sex couples cannot be denied marriage licenses, but vetoed eight of the first 84 bills sent to his desk.

Youngkin announced the vetoes, plus amendments to 12 other bills, hours before a midnight deadline and two days after leading Democrats agreed to a state budget compromise without provisions for Gov. Youngkin's top priority, a publicly financed arena for the Washington Wizards and Capitals in Alexandria.

Lawmakers agreed to a two-year spending plan that includes more money for schools, teachers, state and mental health, but not a tax overhaul that had been proposed by Gov. Youngkin, which would have raised the sales tax across the board while simultaneously cutting personal income taxes by 12 percent. They also approved a separate "caboose" budget to cover the remainer of the fiscal year, which ends June 30.

Gov. Youngkin vetoed bills related to firearms, book banning, marijuana, voting rolls, surrogacy, railroad safety and cybersecurity, stating he did so "to prevent the enactment of laws that would redundantly mirror existing statutes, potentially reverse our advancements in safeguarding elections data, and impose excessive regulatory constraints on our Commonwealth."

The governor thanked legislators for their efforts in a statement that also made clear he plans to make changes to what he called "backward budgets that need a lot of work."

The General Assembly will have a chance to override the vetoes and amendments when it reconvenes for its one-day "veto session" on April 17. (Washington Post)

70TH ANNUAL VIRGINIA FEDERATION OF NARFE CONFERENCE



FEDHub is an online community designed for all. Like social media sites it has a selection of communities, each focused on a topic or interest area. For example, some are specific to where you work or did work like the "U. S. Postal Service Community." The "Open Forum" has discussions on topics such as advocacy, Federal Employee Health Benefit (FEHB) plan choices, and many more.



To get started with FEDHub, go to the NARFE website at www.narfe.org and from the "For Members" menu select "FEDHub: NARFE Member Community." Log in using the same credentials you use to log into NARFE's Member Portal. (If you haven't logged in before, click the "Contact Us" link near the top of the screen.) Once logged in, start at the top left by selecting the link to the Quick Start Guide at the top left. Next fill in your profile. You can add a picture or leave it for later.

Now, join the conversation! In the middle of the top menu is the "Communities" drop-down menu. You automatically belong to the "Open Forum", but if you select "Suggested Communities" you can see other choices.
