### **LEGISLATION**

#### Federal

The Social Security Fairness Act of 2023, The Social Security Fairness Act, <u>H.R.82/S.597</u> would fully repeal the WEP and GPO. H.R.82 has 311 co-sponsors. S.597 has 53 co-sponsors including Senator Tim Kaine. There has been no action in either chamber though co-sponsors from both continue to sign on to their respective bills.

## Biden administration finalizes rule to prevent return of Schedule F

The rule does three things in an attempt to prevent a return of Schedule F, the ultimately unfulfilled attempt to reclassify tens of thousands of federal employees into at-will status, thereby making them easier to dismiss and more akin to political appointees. First, the regulation guarantees employment protections unless a worker voluntarily waives them. It also ensures that any future administration cannot apply broad descriptions of positions, like those of a "confidential" "policymaking" nature, to career civil servants for the purpose of converting them. Finally, the rule sets up hoops an administration would have to jump through anytime it wants to move positions out of the protected competitive service. And in the event that an employee is reclassified against those safeguards, it guarantees an appeal process. In addition, the final rule explains that members of the Senior Executive Service have separate adverse action protections. The rule by the Office of Personnel Management has been highly anticipated by good government groups, federal unions and employees themselves. The draft rule, published in September last year, received more than 4,000 comments and has been in the works for the last 18 months. It is important to note that the process this rule went through not only makes it strong ... but also because it means the rule cannot simply be undone by an executive order. Administration officials, who spoke on the condition of anonymity ... said they are confident this law can stand up on its own, with or without supplemental legislation currently pending in Congress. But experts said having legislation to further safeguard any attempts to override the rule would bolster its viability.

Saving the Civil Service Act, H.R.1002/S. 399 would prevent the return of Schedule F, a statutory loophole created by the previous administration that would have bypassed the system of rules ensuring civil servants are hired and fired based on merit. The bill would also block any position in the federal competitive service, created after September 30, 2020, from being reclassified

outside of merit system principles without the express consent of Congress and install a cap on the number of conversions to the frozen excepted service schedule (Schedule C), with the cap not to exceed more than one percent of the total number of employees, whichever is greater. And to ensure transparency, the bill would require the consent of the employee and the Office of Personnel Management (OPM) before transfer to an excepted service can occur, requires OPM annual reporting. Congress and gives additional oversight. H.R.1002 referred to the House Committee on Oversight and Accountability; 33 co-sponsors. S. 399 referred to the Senate Committee on Homeland Security and Governmental Affairs; 17 co-sponsors.

#### **APRIL 2024 MEETING MINUTES**

NARFE Roanoke Valley Chapter 111, Area VII, met on Friday, April 5, 2024 at Jersey Lily's restaurant. Frances Boatman, President conducted the meeting. The meeting was called to order at 11:45 a.m. with 21 people in attendance including one new member and our guest speaker. A quorum was present to conduct chapter business.

April birthdays were recognized.

Wanda Ware discussed the history of April Fools' Day and quoted passages from Proverbs and Romans about fools and foolishness. She then led us in the Pledge of Allegiance.

The Secretary's minutes for the March 2024 meeting were approved as published, motion made by Dr. Leon Vinci, seconded by Elaine Drewry.

Ellie Long, Secretary, reported two member deaths and passed around cruise brochures mailed to our NARFE P.O. Box.

Mark Fisher gave the March 2024 treasurer's report. As Service Officer, he has reached out to the family of Mollie Hester. He has copies of the F-100 for those who need one,

Carolyn Tucker, 1<sup>st</sup> VP, gave the membership report. Currently there are 156 chapter members. **Welcome to new member Thelma Martin.** 

Karen Simmons, 2<sup>nd</sup> VP, asked the group if they would be interested in a December speaker who provides a program on a 1940's sentimental journey. A majority of hands were raised in favor. The Board will further discuss at today's meeting.

Bill Ketron gave the Legislation report.

Frances gave the President's report.

Megan Mizak, Branch Manager of the Gainsboro Library, was our guest speaker. The American public library movement started in 1852. The American Library Association was established in 1876. Public libraries opened in northern states, but Southern states were two decades behind. In addition, the 13<sup>th</sup> and 14<sup>th</sup> Amendments were negated in Southern states by Black Codes and Jim Crow laws limiting opportunities for Black citizens in all aspects of life, culminating in the 1896 Supreme Court decision Plessy vs. Ferguson, resulting in the constitutional "separate, but equal" facilities for whites and blacks. Library services extended to whites only. Black leaders organized in the early 1900s to improve opportunities for Black education and libraries. The first freestanding library for, and owned, by Blacks was the Western Colored Branch Library in Louisville, KY in 1905. The first freestanding public library for, and operated, by Blacks in Virginia opened in 1921 in Norfolk. In 1920, Roanoke opened a main branch white's only library downtown. Black leaders successfully advocated for a Black library. The Gainsboro Branch Library

opened on December 14, 1921 in the basement of the Odd Fellows Building located in the largely self-sustaining, segregated, residential and business district of Gainsboro. It had 2,300 books and a trained librarian. No Black schools had a library. In 1928, Virginia Young Lee became Head Librarian. She was a graduate of Hampton Institute School of Library Science. She established a Black studies collection and displayed Black history exhibits. The city objected to these displays. She started a reading club. In the late 1930s, the library had outgrown its space and Roanoke city issued a \$20,000 bond for construction of a new library. Lee worked with St. Andrews Catholic Church to deed property to the city for the new library. Lee designed and sketched out the new library building. The new library opened in 1941 with 7,000 titles and 9,000 borrowers. Lee was informed by the city to dispose of her Black history collection or lose her job. Instead, she hid it in the library basement; the collection remained intact. The library survived urban renewal; much of Gainsboro did not. Lee retired in 1971. The library is still active today and is a VA State Landmark and listed on the National Register of Historic Places. Dr. Leon Vinci, CDL District 6, met with the staffs of Senators Kaine and Warner and Congressman Cline respectively in their Washington D.C. offices to review NARFE legislative priorities.

The 50/50 (Alzheimer's Fund) drawing was won by Carolyn Tucker. There was no gift basket drawing.

The meeting was adjourned at 1:18 p.m.
